Any conditional terms and conditions mentioned by the tenderer in his covering letter or in the tender documents will not be acceptable. 13. The selected tenderer has to provide its own manpower to get the working area used by its employees sweeped and cleaned. He has to ensure lifting of scrap/packing material/paint container etc. and putting them at appropriate place decided by the Corporation. 14.
