TERMS & CONDITIONS FOR SUBMITTING POSTAL QUATATION FOR SUPPLY OF ACCESSORIES OF VEHICLES/CARS

1	Eligibility	Local Dealers/Manufactures located at Chandigarh/Panchkula/Mohali.
2	Place of Delivery	Destination (door delivery in Govt. Central Workshop, Chandigarh).
3	Goods and Services Tax (GST)	GST applicable as per latest Govt. of India/State Govt. notification effective from 01.07.2017. GCW GST No. 04AAAGS2337BIZU
4	Packing and Forwarding	Inclusive & Securely packed.
5	Specifications	As per list at Transport Deptt website i.e. www.hartrans.gov.in
6	Validity of Quotation	The validity of Quotation will be for 12 months from the date of finalization of Quotations. No variation in Basic Prices will be allowed.
7	Quantity	As per requirement of Govt. Central Workshop, Chandigarh during the validity period of Quotation on the same rates and terms & conditions.
8	Payment Term	100% payment within 30 days from the date of satisfactory receipt of material in the consignee premises.
9	Delivery Schedule	At the time of requirement with lead time of maximum 07 days.
10	Price Variation	Price fixed for one year after final decision.
11	Delay Penalty	Delayed consignment/delivery schedule will be subjected to 0.5% penalty per consignment per week of delay or part thereof, recoverable on the value of stores supplied after the scheduled date.
12	Warranty	Free replacement against manufacturing defects, if any.
13	Fall Clause	The firm will be subjected to fall clause, in case of supply at lower rate than offered to the Haryana Govt. or any other State Transport Undertakings in India from the date of offering the lower rates.
14	Any firm that has been blacklisted during the last 3 years by Central Govt./any State Govt./PSU/STUs on the basis of submitting of the forged documents/ non supply of material/non-complying the Quotation obligations etc. shall not be allowed to participated in future Quotations. All the participating firms will be required to submit an affidavit along with Quotation that the participating firms have not been blacklisted by any Central Govt./any State Govt./PSU/STUs during the last three years. In case, contents of affidavit are not found correct during the course of decision making the offer of the firm will not be considered. In case of being found not cored during supply of ordered stores, supply of balance order will be cancelled and such firms will be debarred for participation in future quotations upto 3 years.

20	Any conditional terms and conditions mentioned by the firm in their covering letter or in the Quotation documents will not be considered.	
21	Delay in payments to the suppliers beyond the stipulated credit period indicated in the supply	

		order, unless supported by cogent reasons and approved by Senior Mechanical Engineer, Govt. Central Workshop, Haryana, Chandigarh will attract penal interest on the defaulting amount @ 25/- per rupees one lakh per day of delay beyond the stipulated credit period. Non provision of adequate budget will be no ground for delay in payments to the supplier.
22	Jurisdiction	Any dispute or difference or claim etc., shall be subject to the exclusive jurisdiction of the courts situated at Chandigarh only. No other court shall have the jurisdiction to entertain or try matter concerning this supply Quotation.
23	Arbitrator	All disputes and differences arising out of or concerning whatsoever, shall be referred to the sole Arbitrator or an officer appointed by the Director General, State Transport, Haryana, Chandigarh, acting as such at the time of the reference. There will be no objection to such appointment, that the Arbitrator so appointed is a Govt., servant, that he has to deal with such matters in the course of duties as Govt., servant and might have expressed views on all or any of the matters in disputes or differences. The award of such Arbitrator shall be final and binding on the parties involved. The award of such Arbitrator shall be final and binding on the parties involved. The Arbitrator has the powers to extend the time for making the award on request from either or the parties.
