(ग) खण्ड (अ) में,—

(i) उप-खण्ड (i) में, “75” अंकों के स्थान पर, “50” अंक प्रतिस्थापित किये जाएंगे;

(ii) उप-खण्ड (ii) में, “25” अंकों के स्थान पर, “50” अंक प्रतिस्थापित किये जाएंगे;”।

No. G.S.R. 17/Const./Art. 309/2010. —In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules further to amend the Haryana Transport Department (Group B) Service Rules, 1992, namely :—

1. These rules may be called the Haryana Transport Department (Group B) Service Amendment Rules, 2010.

2. In the Haryana Transport Department (Group B) Service Rules, 1992, (hereinafter called the said rules), in rule 9, in sub-rule (1), in clause (g), for sub clause (i), the following sub clause shall be substituted, namely :—

“(i) by promotion from amongst the Statistical Assistant, Assistant, Junior Auditor or Accountant in Roadways; or” shall be substituted.

3. In the said rules, in Appendix-B, under column 4, against serial number 8, for the existing entry (ii), the following entry shall be substituted, namely :—

“(ii) twelve years experience on any of the post of Statistical Assistant or Assistant or Junior Auditor or Accountant in Roadways or combined experience as such.”.

No. G.S.R. 9/Const./A-1/309.— In exercise of the powers conferred by the proviso to article 309 of the constitution of India, the Governor of Haryana hereby makes the following rules further to amend the Haryana Transport Department (Group A) Service Rules, 1992, namely:—

1. (1) These rules may be called the Haryana Transport Department (Group A) Service Amendment Rules, 2020.

(2) Unless otherwise provided, these rules shall be deemed to have come into force with effect from the 27th March, 1992.

2. In the Haryana Transport Department (Group A) Service Rules, 1992 (hereinafter called the said rules), in rule 5, for the words "thirty-five", the words "forty-two" shall be substituted and shall be deemed to have substituted with effect from the 26th August 2014.

3. In the said rules, in rule 9 for clause (l), the following clauses shall be substituted, namely:—

"(l) in the case of General Manager, —

(i) by promotion from amongst Works Manager, Service Engineer, Stores Purchase Officer or Traffic Manager; or

(ii) by transfer or deputation of an Officer of Group A already in the service of the Government of Haryana or the Government of India;

(m) in the case of Secretary, Regional Transport Authority, —

(i) by promotion from amongst Works Manager, Service Engineer, Stores Purchase Officer or Traffic Manager; or

(ii) by transfer or deputation of an Officer of Group A already in the service of the Government of Haryana or the Government of India."

4. In the said rules, in rule 14 —

(i) in sub-rule (1), for the words, signs, figures and brackets "Haryana Civil Services (Punishment and Appeal) Rules, 1987", the words, signs, figures and brackets "Haryana Civil Services (Punishment and Appeal) Rules, 2016" shall be substituted and shall be deemed to have been substituted with effect from 19th July, 2016;

(ii) in sub-rule (2), for the words, signs, figures and brackets "clause (c) or clause (d) of sub-rule (1) of rule 9 of the Haryana Civil Services (Punishment and Appeal) Rules, 1987" the words, signs, figures and brackets "clause (c) or clause (d) of rule 9 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016" shall be substituted and shall be deemed to have been substituted with effect from 19th July 2016.

5. In the said rules, in Appendix A for the existing Note at the end, the following Note shall be substituted, namely:—

"Note.— If any post mentioned at serial number 3,4,8,13,14 and 15 is held by an Officer appointed by transfer or deputation, then he shall draw pay in the pay scales as admissible to him in his cadre or as prescribed above, whichever is higher."

6. In the said rules, in Appendix B, after Note 2, the following Note shall be added, namely:—

"Note 3.— "If any post mentioned at serial number 14 and 15 is held by an Officer appointed by transfer or deputation, the qualification and experience mentioned in column 4 above shall not be applicable."

7. In the said rules, in Appendix C, -

- (i) against serial numbers 1 to 15, under column 4, for the existing entries, the following entries shall be substituted and shall be deemed to have been substituted with effect from 19th July, 2016, namely, -

"1. Minor Penalties. -

As prescribed in the Haryana Civil Services (Punishment and Appeal) Rules, 2016.

2. Major Penalties. - As prescribed in the Haryana Civil Services (Punishment and Appeal) Rules, 2016."

- (ii) the following Note shall be added and shall be deemed to have been added with effect from the 27th March, 2012, namely :-

"Note. - If the posts mentioned at serial number 2,3,4,6,8,13,14 and 15 are filled up by the transfer or deputation, the same shall be governed by their respective Service Rules as applicable to them."
