4. The successful bidder must shred or recycle the waste material immediately in presence of DGST representative.
5. The bidder will certify that the lifted material shall not be misused.
6. Weighing charges of empty and loaded vehicle shall be borne by the successful bidder.
7. Delivery will be given only against full payment.
8. Earnest Money of unsuccessful bidders will be released after finalization of bidding and receipt of security deposit.
9. Conditional bids may be rejected.
10. All disputes shall be subject to Chandigarh jurisdiction.
