## TERMS AND CONDITION

### ANNEXURE-1

- 1- All Quotations will be deemed to be F.O.R. destination unless otherwise specified in the quotation and should include packing, forwarding and installation charges.
- 2- Unless the goods offered are of recognized popular standard makes and full specifications have been stated.
- 3- The minimum period of delivery from date of placing the order should be specified.
- 4- All quotations will be deemed valid for 06 months from and excluding the date of opening of quotations.
- 5- (i) The inspection of the goods be carried out by the consignee at destination and rejected goods will have to be removed by you within 10 days of dispatch of advice from Senior Mechanical Engineer, Haryana, Chandigarh failing which the goods will lie at your risk.  
(ii) The rejected goods must be replaced by you within 15 days of the FOC by Senior Mechanical Engineer, Haryana, Chandigarh of a registered notice intimating that the goods have been rejecting.  
(iii) if you claim that the goods supplied by you are strictly according to specification stated in the Quotation
- 6- Your quotation may be accepted in part or whole.
- 7- The Goods will be supplied purely on credit basis and the payment will be made within 30 days from the receipt of the bills.
- 8- In case your rates are good for a certain period, postings of the acceptance on the last day will be acceptable to you.
- 9- In case of any dispute the decision of the Senior Mechanical Engineer, Haryana, Chandigarh shall be final and binding on you.
- 10- The contractor shall dispatch material "freight paid" in all cases where their offer is F.O.R. Destination
- 11- All above conditions will be enforced, unless written orders of Senior Mechanical Engineer, Haryana, Chandigarh are obtained for relaxing any specific condition in any specific instance
- 12- The quotations not strictly in accordance with the above conditions are liable to the rejected without consideration.
