PREFACE

The 73rd Constitutional Amendment Act, 1992, promulgated on 24th April, 1993, inserted Part IX in the Constitution. Article 243G of the Constitution mandates States to endow Panchayats with such powers and authority to enable them to function as institutions of self-government for planning and implementation of schemes for social justice and economic development, including on 29 subjects listed under the Eleventh Schedule.


Incentivizing the Panchayats in form of awards is an integral part of creating a healthy and competitive ecosystem for holistic implementation of developmental plans. Ministry of Panchayati Raj (MoPR) has been incentivizing the best performing Panchayati Raj Institutions (PRIs) through awards as an encouragement to enhance their performance in local self-governance.

Over the period, various initiatives/improvements have been taken under these Awards by virtue of making entire process of filing nominations by Panchayats online, introduction of new award categories/themes to focus on specific areas/sectors and socially important issues etc. Improvement and refinement in the award system is a continuous policy intervention. Previously, mostly the emphasis was laid on processesbased performance. Keeping in view the shifting priorities for attainment of new developmental goals and aligning the Awards/themes vis-vis- Sustainable Development Goals (SDGs), National Panchayat Awards have been rationalized while establishing a multi-level pyramid structure of awards (National/State/UT/District/Block levels) and also altering the qualitative aspect of measuring performances by bringing in outcome based parameters. Through this, the objective of holistically addressing the roles played by the Panchayats in attainment of the SDGs is to be realized.

India is a signatory to United Nations 2030 Agenda for achieving inclusive, people centric and holistic Sustainable Development through 17 identified goals. The Government of India is operating with strategic visioning, prioritization and implementation methods to achieve Sustainable Development Goals with the motto of "Leaving No One Behind" through "Whole of Government and Whole of Society Approach". Hon'ble Union Minister of Panchayati Raj on 7th December, 2021 released the report on "Localization of Sustainable Development Goals through Panchayati Raj Institutions" prepared by an Expert Committee constituted in this Ministry. The Committee in its report has identified 9 themes aggregating 17 SDGs for action at local (Gram Panchayat) level as a way forward for attainment of SDGs by the year 2030. These 9 themes are (i) Poverty free and enhanced livelihoods village, (ii) Healthy village, (iii) Child friendly village, (iv) Water sufficient village, (v) Clean and Green village, (vi) Self-sufficient infrastructure in village, (vii) Socially secured village, (viii) Village with good governance and (ix) Women-friendly Panchayat (earlier called as Engendered development in village).

Panchayats wherever indicated may be referred as Panchayats or similar level local bodies/councils existing in areas (such as Non-Part IX States) with no Panchayats.





1. Introduction

1.1 Incentivization of Panchayats scheme is one of the central components of Centrally Sponsored scheme of revamped Rashtriya Gram Swaraj Abhiyan (RGSA). Under this scheme, 'National Panchayat Awards' are given to the best performing Panchayats, including financial incentives for award winning Panchayats, in recognition of their performances under various priority sectors/themes. These awards are usually given annually on 24thApril, celebrated as National Panchayati Raj Day to commemorate 73rd Constitution Amendment Act, 1992 which came into force with effect from 24thApril, 1993.

1.2 National Panchayat Awards will be a multi-level pyramid competition of Panchayati Raj Institutions (PRIs) at Block, District, State/UT and National level under9 themes (identified by Expert Committee of Ministry of Panchayati Raj). The 9 Localization of Sustainable Development Goals(LSDG)themes are (i) Poverty free and enhanced livelihoods village, (ii) Healthy village, (iii) Child friendly village, (iv) Water sufficient village, (v) Clean and Green village, (vi) Self-sufficient infrastructure in village, (vii) Socially secured village, (viii) Village with good governance and (ix) Women friendly village. Panchayats will be incentivized for their performance in attainment of the SDGs under these themes.

1.3 All the Panchayats (District Panchayats, Block Panchayats and Gram Panchayats) will mandatorily participate under the thematic award competition. The Evaluation Committees at respective levels (Block, District, State/UT and National) will rank all the Panchayats under each theme and accordingly select top three Panchayats at every level.

1.4 The Block Panchayats (BPs) and District Panchayats (DPs) will be incentivized accordingly for the performance of their concerned GPs.

2. Objective of Awards

To nudge PRIs for a systematic planning, implementation, monitoring and accountability towards achieving LSDGs at the Panchayat level, the National Panchayat Awards have been restructured. Incentivization of Panchayats scheme, through National Panchayat Awards aims to:

- i. Assess the performance of PRIs in attainment of SDGs through 9 identified themes
- ii. Promote competitive spirit among PRIs
- iii. Catalyze the process of 'Localization of SDGs through PRIs' and sensitizing the PRIs about significance of attaining LSDG by 2030

3. Themes/Categories of National Panchayat Awards

3.1 National Panchayat Awards to Panchayats will be given for their performance under the various categories as given below:


















3.2 Special category of awards

Following special categories of awards will be given under National Panchayat Awards:

- i. Gram Urja Swaraj Vishesh Panchayat Puraskar: This award will be given to 3 GPs for their performance regarding adoption and usage of renewable sources of energy. This award could be sponsored by the concerned line Ministry/Department / industry.
- **ii.** Carbon Neutral Vishesh Panchayat Puraskar: This award will be given to 3 GPs who have done exemplary work towards achieving Net-Zero carbon emissions. Similar to Gram Urja Swaraj Puraskar, this award could also be sponsored by the concerned line Ministry/Department /industry.
- iii. Nanaji Deshmukh Sarvottam Panchayat Satat Vikas Puraskar: One GP which qualifies and gets shortlisted for National Panchayat Awards during the subsequent years also will be given this award instead of individual thematic award.
- **iv. Panchayat Kshamta Nirmaan Sarvottam Sansthan Puraskar :** This award will be given to 3 Institutions across the country who have provided institutional support to GPs in achieving LSDGs.
- v. Best Participant (State/District Panchayat): State/UT with highest percentage of participation from GPs will be recognized for their performance and for this,





certificate of appreciation will be given to the State/UT. Also, District Panchayats, where > =90% GPs participate for this competition, will be recognized for their performance and for this, certificate of appreciation will be given to them also.

3.3. States/UTs may additionally forward nominations of GP head/representatives or any other persons who has shown exemplary performance and dedication towards work at grassroots levels. These may be further nominated for Padma Awards by MoPR.

3.4. MoPR, if deems appropriate at any time, may institute and accordingly confer any other special award.

4. Structure of Deen Dayal Upadhyay Panchayat Satat Vikas Puraskar (DDUPSVP)

Revamped National Panchayat Awards establishes a multi-level pyramidical structure for Awards at Block, District, State/UT and National Level focussing on LSDG based themes. The GPs will be incentivized for their performances towards attainment of SDGs through 9 identified LSDG themes. BPs and DPs will be incentivized based on the performance of their concerned GPs and support extended by them in attaining LSDGs through expenditure incurred under BPDP and DPDP.

5 DDUPSVP: Block Level Awards (for GPs)

5.1 Constitution of Block Panchayat Performance Assessment Committee (BPPAC)

5.1.1 A BPPAC will be set up at Block level for each of the 9 themes which will assess, scrutinize and rank all the Gram Panchayats (GPs)/similar level local bodies in that Block. State/UT will oversee the constitution of BPPAC.

5.2 Selection criteria for GPs under Block Level Awards:

5.2.1 BPPAC for each of the 9 themes will ensure that all the concerned Gram Panchayats fill the online Questionnaires in respect of all the themes. For this, the support from line department functionaries at Gram Panchayat/Block level may be taken by the Committees/



GPs. These online questionnaires will be available at National Panchayat Awards Portal/ Dashboard.

5.2.2 The marks for each question of the corresponding Questionnaire will be autogenerated as per the pre-defined marking scheme by Ministry of Panchayati Raj.

5.2.3 All the GPs will be auto-ranked as per the marks obtained for Questionnaires under each theme.

5.2.4 <u>Field verification</u>: BPPAC for each theme will cross verify the information/data/ answer filled against each of the question of the corresponding questionnaire through field visit of the top 3 ranking GPs. The validation of information against each question for each thematic questionnaire will be done through supporting documents as per list indicated against each questionnaire.

5.2.5 BPPAC for each theme will prepare the verification report in the prescribed format for top 3 ranking GPs under each theme. The report will be placed before the GP in a meeting for validation. The validated field visit report will be signed by the field visit team and counter signed by the Sarpanch/Panchayat Secretary. The prescribed format for field verifications is as follows:

5.2.6 **Tied Cases resolution:** Any cases of tied marks will be sorted out by the BPPAC at its level. For resolving tied cases, the respective Committees will adopt the following procedure:

i. if there is a tie between 2 GPs for first rank, both will be examined through field visit and accordingly, these will be ranked 1st and 2nd.














- iii. if there is a tie between 2 GPs for third rank, both will be examined through field visit and accordingly, GP for 3rd rank will be selected.
- iv. In case there is still a tie between 2 GPs for 3rd rank after field visit, both the Panchayat will be regarded as Block Level Awardees ranked 3rd. Both GPs will also qualify and be nominated for the District Level Awards.
- v. If there are 3 or more top ranking GPs with equal marks, then all of them will be examined through field visit and accordingly, GPs for rank 1st, 2nd and 3rd will be selected.

5.2.7 BPPAC for each theme will finalize and select the top 3 ranking GPs under each theme which will be the Block Level Awardees. These Block Level Awardee GPs will be nominated by the BPPACs in the following prescribed format for District Level Awards.

7.2 Selection criteria for GPs under State/UT Level Awards:

7.2.2 **Field verification:** SPPAC/UPPAC for each theme will cross verify the top 3 ranking GPs nominated by SPPACs/UPPACs under each theme through field visits. The validation of information against each question for each thematic questionnaire will be done through supporting documents as per list indicated against each questionnaire.

7.2.3 SPPAC/UPPAC for each theme will prepare the verification report in the prescribed format for top 3 ranking GPs under each theme. 7.2.4 Tied Cases resolution: Any cases of tied marks will be sorted out by the SPPAC/ UPPAC at its level. For resolving tied cases, the respective Committees will follow the following procedure:

- i. if there is a tie between 2 GPs for first rank, both will be examined through field visit and accordingly, these will be ranked 1st and 2nd.
- ii. if there is a tie between 2 GPs for second rank, both will be examined through field visit and accordingly, these will be ranked 2nd and 3rd.









- iii. if there is a tie between 2 GPs for third rank, both will be examined through field visit and accordingly, GP for 3rd rank will be selected.

8.2 Selection criteria for GPs under National Panchayat Awards:

8.2.1 Out of the GPs nominated by SPPACs/UPPACs under each theme, NPPAC for each of the 9 themes will assess, scrutinize and select the top 3 ranking GPs/similar level local bodies based on questionnaires, supporting documents and video films of the respective nominated GPs.

8.2.2 Tied Cases resolution: For resolving tied cases, the respective Committees will follow the following procedure:

- i. if there is a tie between 2 GPs for first rank, both will be examined through field visit and accordingly, these will be ranked 1st and 2nd.
- ii. if there is a tie between 2 GPs for second rank, both will be examined through field visit and accordingly, these will be ranked 2nd and 3rd.

9 DDUPSVP : Selection of National Level Awardees (GPs)

9.1 A National Screening Committee (NSC) constituted in MoPR will overall finalize the National Panchayat Awardees.

9.1.2 Structure of the NSC:

- i. Chairperson: Additional Secretary, MoPR
- ii. Members:
 - All Divisional Heads, Deputy Secretary/Director (dealing with National Panchayat Awards) and Director, Integrated Finance Division.
 - 2 experts nominated by each Nodal Ministry/Department
 - Representative from NITI Aayog of the officer of Joint Secretary level
- iii. Member Convener: Under Secretary/Deputy Secretary (dealing with National Panchayat Awards)

9.2 DDUPSVP: Selection of National Panchayat Awardee GPs:

9.2.1 Thematic awards (GPs): NSC will select the National Panchayat top 3 ranking GPs under each theme based on the recommendations of the NPPACs for each of the 9 themes.

These GPs will be declared as National Panchayat Awardees and will be conferred with awards and financial incentives.

10 DDUPSVP: Selection of Awardee BPs

10.1 District Level Awards:

DPPAC for each of the 9 themes will select the top 3 ranking BPs as District Level Awardee based on following criteria:

- (i) 80% on the basis of average score of all its concerned GPs under that particular theme (automatically/self generated as per awards portal).
- (ii) 20% of own performance of Block Panchayat as per following criteria:
 - a. Concerned Block Panchayat Development Plan must be uploaded for the year 2023-24 and reflect works taken up under the concerned LSDG themes adopted by majority of the GPs.
 - b. At least 50% of the resources of Block Panchayat (for example, own sources of revenue, Central Finance Commission Grant, State Finance Commission Grant, and such other sources) must flow to the concerned themes in which majority of Panchayats have taken Sankalp and remaining 50% of funds on other LSDG themes. Further, 20% of the own funds of the Block Panchayat must be planned and spent on green projects i.e. water conservation, renewable energy projects, carbon neutral projects etc.

10.2 State/UT Level Awards

SPPAC/UPPAC for each of the 9 themes will select the top 3 ranking State/UT Level Awardee BPs out of the District Level Awardee BPs based on the criteria as stated above in para 10.1.

10.3 National Level Awards

NSC will select the top 3 ranking National level Awardee BPs out of the State/UT Level Awardee BPs based on the criteria as stated above in para 10.1.

11 DDUPSVP: Selection of Awardee DPs

11.1 State/UT Level Awards

SPPAC/UPPAC for each of the 9 themes will select the top 3 ranking DPs as State/UT Level Awardee based on following criteria:

- (i) 80% on the basis of average score of all its concerned GPs under that particular theme (automatically/self generated as per awards portal).
- (ii) 20% of own performance of District Panchayat as per following criteria:
 - a. Concerned District Panchayat Development Plan must be uploaded for the year 2023-24 and reflect works taken up under the concerned LSDG themes adopted by majority of the GPs.









b. At least 50% of the resources of District Panchayat (for example, own sources of revenue, Central Finance Commission Grant, State Finance Commission Grant, and such other sources) must flow to the concerned themes in which majority of Panchayats have taken Sankalp and remaining 50% of funds on other LSDG themes. Further, 20% of the own funds of the District Panchayat must be planned and spent on green projects i.e. water conservation, renewable energy projects, carbon neutral projects etc.

11.2 National Level Awards

NSC will select the top 3 ranking National level Awardee DPs out of the State/UT Level Awardee DPs based on the criteria as stated in para 11.1 above.

12. Nanaji Deshmukh Sarvottam Panchayat Satat Vikas Puraskar (for GPs, BPs and DPs)

12.1 Best 3 GPs: Out of the total GPs selected for National Panchayat Awards under each of the 9 themes, NSC will select the top 3 best GPs with highest aggregate/average score under all 9 themes combined (automatically/self generated as per awards portal).

12.2 Best 3 BPs: Out of the total BPs selected for National Panchayat Awards under each of the 9 themes, NSC will select the top 3 best BPs based on the criteria as stated in para 10.1 above.

12.3 Best 3 DPs: Out of the total DPs selected for National Panchayat Awards under each of the 9 themes, NSC will select the top 3 best DPs based on the criteria as stated in para 11.1 above.

13 Selection of National Level Awardees (Special Category Awards)

13.1 The nominations for special categories of awards namely, **Gram Urja Swaraj Vishesh Panchayat Puraskar and Carbon Neutral Vishesh Panchayat Puraskar** will be submitted to MoPR within the prescribed timeline by States/UTs which will be subsequently forwarded to concerned line Ministry by MoPR accordingly for selection of top 3 awardee GPs and awarding them accordingly. Evaluation criteria will be prepared by the concerned line Ministries and accordingly GPs will be shortlisted by them for awards.

13.2 Nanaji Deshmukh Sarvottam Panchayat Satat Vikas Puraskar: One GP which qualifies and gets shortlisted for National Panchayat Awards during the subsequent years also will be given this Award instead of individual thematic award. This, however, will include certificates/plaques and financial incentives. This award may be introduced w.e.f. Award Year 2025 i.e. Appraisal Year (2023-24).

13.3 Panchayat Kshamta Nirmaan Sarvottam Sansthan Puraskar: This award will be given to 3 Institutions across the country which have provided institutional support to GPs in achieving LSDGs. This institution may be recognized through a certificate/plaque for their efforts. No financial incentive will be given for this category of award. One















nomination per State/UT may be submitted to MoPR within the prescribed timeline for this award.

14. Awards approval Authority

Final approval authority for all the National Level Awards to be given by Ministry of Panchayati Raj will be Hon'ble Minister of Panchayati Raj.

15. Minimum Qualifying Marks:

- i. The minimum qualifying marks for individual theme and aggregate performance on all themes for the Gram Panchayats will be 50%.
- ii. For award at block/district level thematic or aggregate performance, the qualifying minimum eligible marks will be 70%.

The aforesaid criteria is for participation in National Level Awards.

However, States may relax the criteria for selection of best performing GPs/BPs/DPs and felicitating them in a manner deemed fit in case no GP/BP/DP fulfils prescribed criteria for National Level Awards.

16. Period of evaluation: The performance of PRIs for a financial year (termed as Appraisal Year) would be evaluated during the subsequent financial year.

17. The nominations with incomplete information or submitted after the stipulated timeline will be outrightly rejected at all levels.

18. Grievance/Dispute

No dispute/grievances/requests of any kind regarding awards will be entertained by MoPR subsequent to declaration of National Panchayat Awards.

19. Recognition and Certification of awardees

19.1 For National Level Awardees: Awardee GPs, BPs and DPs selected for National Panchayat Awards will be recognized with certificates/plaques and financial incentive/ award money, subject to annual changes, budget availability, sponsorships or as decided by MoPR periodically. The tentative award money with respect to number of awards will be as per table below which will be subject to budget availability:

19.2 For State/District/Block level Awardees: For encouragement to the Panchayats, States/UTs may felicitate the top-ranking Panchayats at Block, District and State/UT levels with Plaques/certificates and/or financial incentives. The expenditure on this account will be borne by State/District/Block level Administrations from their own pool of resources. These awards could also be sponsored by industry / Trust/Foundation. The design of Plaques/Certificates of National Panchayat Awards may be adopted/modified by States/UTs/Districts/Blocks for felicitating awardees at respective levels, however, the logo of the concerned theme must be incorporated in it. These Plaques/Certificates may also be prepared in local languages as well. These Plaques/certificates may also include the names of the achiever frontline workers at appropriate levels.


19.3 Utilization of Award money:

The award money will be utilized by the awardee Panchayats for public purposes especially for livelihood support, asset creation, civic amenities creation & maintenance and bridging the gaps in the funds received from Union/State Government for various projects by the Panchayat. Some of the activities on which the award money can be utilized are as follows:

- Developmental activities related to particular award theme
- Information, Education & Communication Campaigns
- Community infrastructure development
- Gender friendly transport facility
- Installation of CCTV cameras
- Organizing Health Camps
- Augmenting learning outcomes i.e. digital libraries, public library, digital class rooms etc.
- Sanitization
- Celebration of various theme related days (such as Women's day, Children's day, Environment day etc.)
- Special theme-based trainings
- Recreational facilities for children
- Disabled friendly infrastructure
- Grain Bank
- Community Kitchens
- Employment generation

This list is indicative and not exhaustive.

The State/UT will, however, ensure utilization of award money by the awardee/incentivized Panchayats only for public developmental activities in the Panchayat.









20. Flow of funds

Incentive amount/award money for the awardee/winning Panchayats would be transferred electronically & directly into their PFMS Mapped authenticated bank accounts (by State/ UT) during or subsequent to the Award Ceremony/National Panchayati Raj Day celebrated on 24th April every year.

















21. **Utilization Certificate (UC)**

The State Government/UT Administration concerned will furnish a UC (in GFR 12-C format) to MoPR as per General Financial Rules (GFR), 2017, the UC submitted by the State Government/UT Administration must be counter-signed by the Administrative Secretary of the Division regulating the Scheme/Finance Secretary.

22. **Designing of Plaques/Certificates/Trophies for the awardee** panchayats:

MoPR may engage/avail services of any organization for designing the Plaques/certificates for National Level Awardees. The Plaques/certificates will, inter-alia, bear logos of concerned nodal Ministry/Department, MoPR and concerned theme.

23. **Felicitation of awardees:**

- i. Block Level Awards: As a motivation for performance, the GPs selected for Block Level Awards will be felicitated with a certificate and/or cash/kind in a function organized during the month of December (following immediately after the awardees selection process at this level). The function will be organized at Block Headquarter in presence of Member of Parliament, Members of Legislative Assembly (MLA), senior public functionaries, senior Government functionaries, frontline workers, supporting organizations etc. Overall responsibility of organizing the event will rest with the Block Level Administration.
- ii. District Level Awards: Similar to the Block level function, GPs and BPs selected for District Level Awards will be felicitated with a certificate and/or cash/kind in a function organized during the month of January (following immediately after the awardees selection process at this level). The function will be organized at District Headquarter in presence of Minister-in-charge, MPs, MLAs, all BP Heads/councillor, DP councillor, Panchayat elected representatives, senior public functionaries, District Collector, senior Government functionaries, frontline workers, supporting organizations etc. Overall responsibility of organizing the event will rest with the District Level Administration.
- State/UT level Awards: The State/UT level awardee GPs, BPs and DPs will iii. be felicitated in a function organized during the month of February (following immediately after the awardees selection process at this level) at State/UT level, preferably in presence of Governor/Chief Minister along with Minister-in-charge, MPs, MLAs, Panchayat elected representatives, senior Government functionaries,



frontline workers, supporting organization etc. Overall responsibility of organizing the event will rest with the State/UT Level Administration.

iv. National level Awards: The National level awardee Panchayats will be felicitated on the occasion of National Panchayati Raj Day (celebrated annually on 24th April) or on an occasion decided by Ministry/GoI on account of unforeseen circumstances such as elections etc. The event is usually graced by Hon'ble Prime Minister, Central/State Ministers, Awardee Panchayats and other dignitaries. Invitees would be appropriately decided by MoPR.

23.1 At the BP/DP level award consideration, recognition/feliciation will be given to the respective MPs/MLAs contributing towards the activities under SDGs out of their local development funds or convergence of funds out of the MP/MLA local funds.

24. Administrative Cost for States/UTs:

24.1 MoPR will support States/UTs for the administrative expenditure towards award related activities ranging from Rs.5-7 lakhs for smaller States and upto Rs.20 lakhs for bigger States. The expenditure on this account may be borne by the States/UTs from the approved Annual Action Plan under RGSA. In case the Plan has already been approved, the States/UTs may take post facto approval for the same.

24.2 From the funds released towards Administrative Cost, State Institute of Rural Development & Panchayati Raj will hire 2 persons for the monitoring of filling the online questionnaires (on short term basis only and for an approximate maximum period of 4 months i.e. 1st September to 31st December, 2022).

25. IEC strategy: MoPR will develop an effective Information, Education & Communication (IEC) strategy for publicity of National Panchayat Awards. A structured IEC campaign will be worked out by Media Division, MoPR. Sponsoring Ministries/ Departments will also supplement the efforts towards effective dissemination of information and publicity of National Panchayat Awards concerning their themes.

28. For monitoring the process of Awards, a Portal for these awards prepared by NIC, including a User manual for reference, will be available for the respective Committees.

29. Owing to extraordinary situations (pandemic situations, elections or such), MoPR may make modifications in the timelines/processes, if deemed necessary at its sole discretion.

30. MoPR may make modifications in the guidelines, if deemed necessary, periodically.
