Three Ministries/Department namely, Rural Development, Water Resources and Health participated in the virtual meeting. In line with the direction by the Chairman, Ministries/Department of Women & Child Development, Drinking Water & Sanitation and Social Justice and Empowerment alongwith NITI Aayog who did not participate in the meeting were subsequently requested for comments on the revamped awards structure and questionnaires. The comments were received only from D/o Drinking Water & Sanitation (D/o DWS) through email on 14.07.2022.

D/o DWS broadly agreed with the award structure while seeking information on quantum of award money to be sponsored for 'Clean and Green Panchayat' thematic award, flow of the award money to awardees from Nodal Departments, and the Department who would be responsible for preparing checklist for filed visit and criteria for ranking. D/O DWS also submitted comments on 'Clean and Green Panchayat' award theme Questionnaire.
