## **GEO-DEMOGRAPHIC FEATURES**

- Himachal Pradesh, lies in the North Western Himalayas.
- The altitude in the Pradesh, a wholly mountainous region in the lap of Himalayas, ranges from 350 metres to 6975 metres above mean sea level.

## **Scheduled Area of Himachal Pradesh**

 The scheduled area of the State lies in greater Himalayas with tough topography and some inaccessible pockets, as these areas observe heavy snowfall and remains cut off for months.

 This Tribal population constitutes only a fraction of the total population with vast uninhabited area, which is bestowed with many cash crops like apple, stone fruits, chilgoza etc.







## **Scheduled Area of Himachal Pradesh**


 There are 10 different Tribes in Himachal Pradesh. Gaddi, Gujjar, Lahuala, Swangla, etc are major tribes in schedule Areas of the State. The total population of Tribals in the state is 5.71 %.

## **Tribal Area of Himachal Pradesh Cont....**

- Two districts namely Kinnaur and Lahaul & Spiti and Two development blocks namely Pangi and Bharmaur of Chamba district comprise the Scheduled area of the State.
- There are 2 Zila Parishads namely Kinnaur and Lahaul & Spiti and a part of District Chamba in the scheduled area of HP.
   Seven Panchayat Samitis namely Kalpa, Nichar, Pooh, Lahaul, Spiti, Bharmaur and Pangi falls under Scheduled Area. There are 168 Gram Panchayats in the Scheduled – V area.

# what has been done

 With a view to bring the Himachal Pradesh Panchayati Raj Act, 1994 in conformity with the provisions of the PESA Act, a new ChapterVI-A, namely special provisions relating to the Gram Panchayats, Panchayat Samitis and Zila Parishads located in the Scheduled Areas was added. The provisions of this Chapter have been made applicable to the Panchayats in the Scheduled areas of the State and shall prevail over anything inconsistent therewith else where in the Act.





## **Status of PESA**

- In accordance with the PESA Act, special provisions relating to Gram Panchayats, Panchayat Samitis and Zila Parishads have been incorporated in the H.P. Panchayati Raj Act, 1994 vide sections 97-A to 97-I and the same are being followed in letter & spirit.
- For facilitating the provisions of PESA Act, HP PANCHAYATI RAJ [ Extension To The Scheduled <u>Areas]RULES</u> have also been framed and notified on 26<sup>th</sup> March 2011.





## **Status of PESA Cont...**

- The State Government has provided 100% reservation in the offices of Chairpersons of Panchayats at all the three levels for the persons belonging to the scheduled Tribes in Scheduled areas of the State and 50% of the total offices are further reserved for women.
- In the entire tribal area ,the Gram Sabhas are competent to safeguard the traditions and customs of the people, their cultural identity, community recourses without detriment to any law for the time being in force, the customary mode of dispute resolution.





## **COMPLIANCE OF PROVISIONS OF PANCHAYAT** (EXTENSION TO THE SCHEDULED AREAS) ACT, 1996 in Himachal Pradesh

Department of Forest			The Forest Department vide executive order dated 28 <sup>th</sup> February, 2003 has identified 37 species of Medicinal herbs and other non timber Forest Produce on which control has been given to the concerned Panchayats and the Pradhan of the concerned Panchayat has been empowered to issue passes for these items and to levy export fee which will form the fund of the Panchayat. In addition to this Pradhans of the Panchayats has been appointed as Forest Officer to carry out the purposes of rule 11 of the Himachal Pradesh Forest Produce Transit (Land Routes) rules, 1978 for the issuance pass for transport of Minor Forest Produce collected from the forest in the concerned Panchayat

**Capacity Building and Training for PRIs in scheduled Areas.** 

- The elections of PR institutions were held in the State in the month of January 2021 except Lahul Sub-division of District Lahaul & Spiti where elections were held in October 2021
- Capacity building and training of Ers and Officials is under way





## **Capacity Building continued.....**

- Training Module PESA <u>Material\Capacity</u> <u>building under PESA</u> has already been developed and CBT Programmes are being started.
- Keeping in view the Provisions of PESA Act and the Rules made thereunder reading material in simple language has been prepared and will be distributed to the ERs of PRIs in Scheduled Areas.





## Separate Budget for Scheduled Areas

- Against 5.71 % tribal population, 9 % of the state plan/development funds have been earmarked for scheduled areas.
- For F.Y. 2020-21 Rs. 711 cr have been disbursed.
- For current F.Y. i.e. 2021-22 funds to the tune of 847 cr have been budgeted under TASP.





# **E-Connectivity**

All the Panchayat Samitis in the entire Scheduled Areas have been provided video conference facility and it is the endeavor on the part of the State government to directly interact with the grass root functionaries including the Panchayat Office bearers as well as Panchayat Officials. This will help State govt. and the department to have a feedback on all important govt. policies and acquaint the grass root functionaries regarding the latest developments at the Govt. level.





## What is remained to be done(WAY FORWARD)

- Appointment of PESA consultant
- Appointment of PESA Coordinator at district level
- Training of related line department officers at state level as well as district level for the better implementation of PESA provisions
- Capacity building of ERs and Officials of PESA area with Ex Office bearers as resource persons





## Way Forward contd.....

- Sensitization of Gram Sabha members with the involvement of NGOs which are working for tribal rights
- Periodic review of PESA implementation at highest level
- Distribution of PESA reading material to Ers and Gram Sabha members
- Active involvement of departments like Revenue, Industries, Forest, Agriculture etc. in the proper implementation of PESA
