

Specific provisions of PESA related to planning



- State legislation shall be in consonance with the customary law, social and religious practices and traditional management practices of common resources [Sec 4(1)(a)]
- PESA provides for constitution of Gram Sabha for each village
- Every Gram Sabha shall approve the plans, programmes and projects for social and economic development before such plans, programmes and projects taken up for implementation by the Panchayat [Sec 4(e)]
- PESA empowers Gram Sabhas to safeguard and preserve traditions and customs; identifying beneficiaries for various schemes and issuing certificates of utilisation of funds
- planning and management of minor water bodies in the Scheduled Areas shall be entrusted to Panchayats at the appropriate level; [Sec 4(j)]
- recommendations of the Gram Sabha or the Panchayats at the appropriate level shall be made mandatory prior to grant of prospecting licence or mining lease for minor minerals in the Scheduled Areas; [Sec 4(k)]
- the prior recommendation of the Gram Sabha or the Panchayats at the appropriate level shall be made mandatory for grant of concession for the exploitation of minor minerals by auction; [Sec 4(I)]






Sector-Wise activities Distribution

Women & Child Development

• Availability of Aanganwadi Centre, Early Childhood Education in the Anganwadi,



Poverty Alleviation

• Presence of SHGs; SHGs federated into Village Organisations (VOs); SHGs with access to bank loans; households mobilized into Producer Groups (PGs)

Special Support to Panchayats in PESA Areas One Gram Sabha Mobiliser in each PESA GP to ensure maximum participation of members of PRIs (max of Rs. 2,500/month)

One PESA coordinator in each Block (max of Rs. 20,000/month)

One PESA coordinator in each district (max of Rs. 25,000 /month)

Orientation programmes for Gram Sabha (max of Rs.10,000 for each GP)

Contracting a NGO for regular hand holding (max of Rs.10,000/GP)




Sector-Wise activities Distribution








Sector-Wise activities Distribution
