

Dukli Panchayat Samity had 8 Kani (1.3 hector approx.) unused land behind the Office building. It was decided in the 2021 General Body meeting, to use the land (1.3 hector approx.) for Organic based Agri production and Fish production centres. Subsequently, they started the "Organic Agriculture and Pisciculture Project" with the support of CFC, SFC & their Own source fund to increase their Own Source Revenue.

The Panchayat Samiti placed its fund to the Agriculture Department for Organic Farming & Fishery Department for the creation of water bodies and fingerling production. Last year, Panchayat Samiti earned Rs.95000/- by selling different vegetables, and this year Panchayat Samiti has already earned an amount of Rs.1,30,024/-by selling different vegetables from its selling corner.
