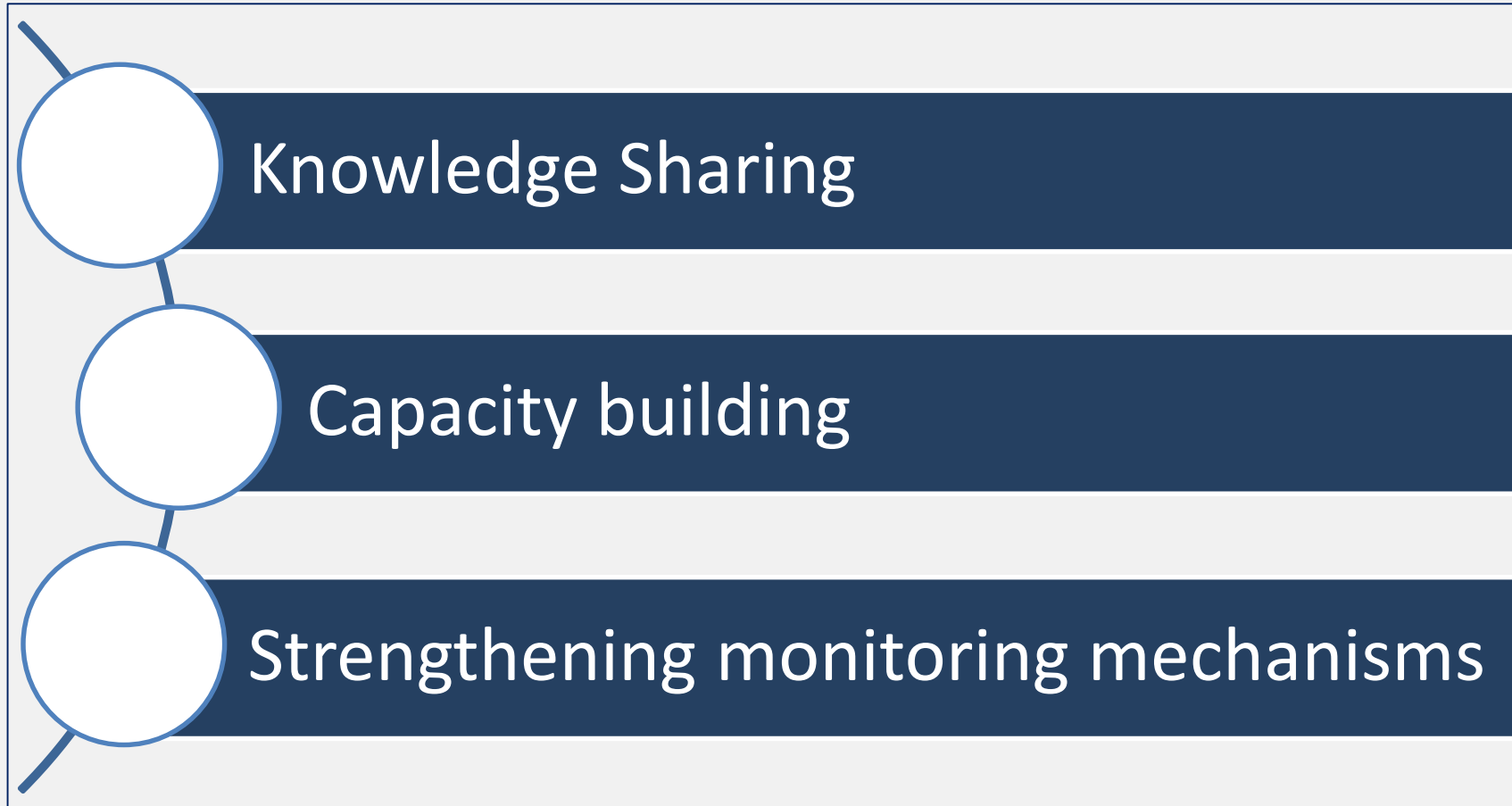

# SDG Localization: Upgrade Quality of GPDP Process at the Gram Panchayat Level by Linking the SDGs

## SDGCC Punjab



SDG-aligned Gram Panchayat Development Plans (GPDPs) are envisioned as a step forward for developing model SDG panchayats through SDG governance and implementation strengthening at the grassroots level.



The SDGCC assisted the Patiala district administration to conduct a needs assessment of five identified gram panchayats by following a participatory approach.



All the panchayat secretaries and representatives from Patiala district administration participated in the meeting.



The needs of the gram panchayats were assessed at an individual and collective level and the meeting ended with the finalization of priority activities along with budgetary requirements and processes for approval.



The SDGCC will also support the identified GPs to implement various activities, including necessary training in collaboration with the district administration.

## Strengthen training institutions to capacitate key officials to localize the SDGs through developing a training manual on developing SDG integrated GPDPs

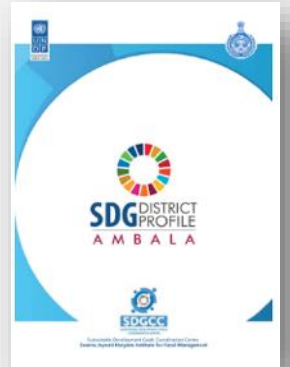
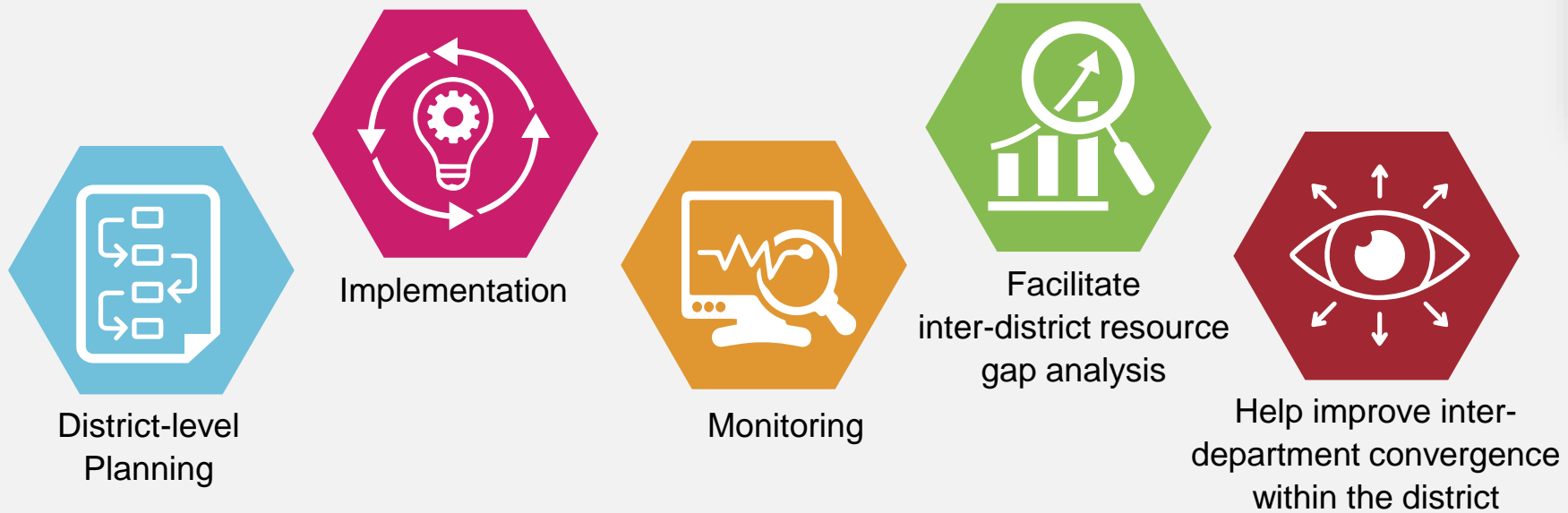

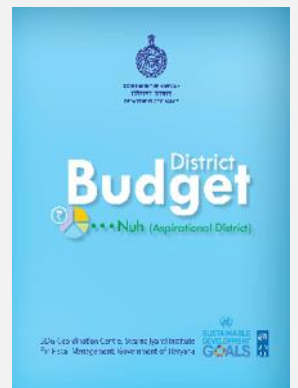
## District SDG Profile Booklets

The SIF & DIF, Haryana, has been finalized and aligned to National Indicator Framework.



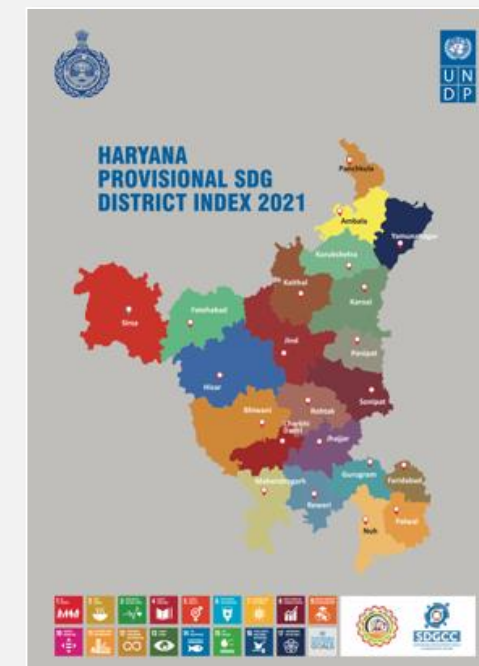
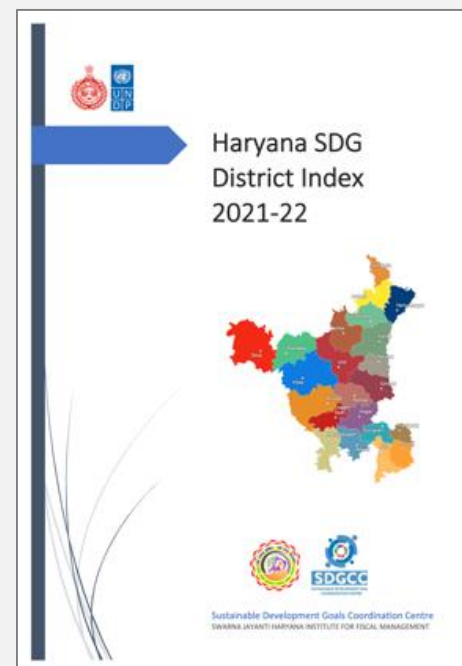
It was drafted through a consultative and participatory approach.

- Second and current edition is based on 15 Goals, 62 Targets and 115 Indicators





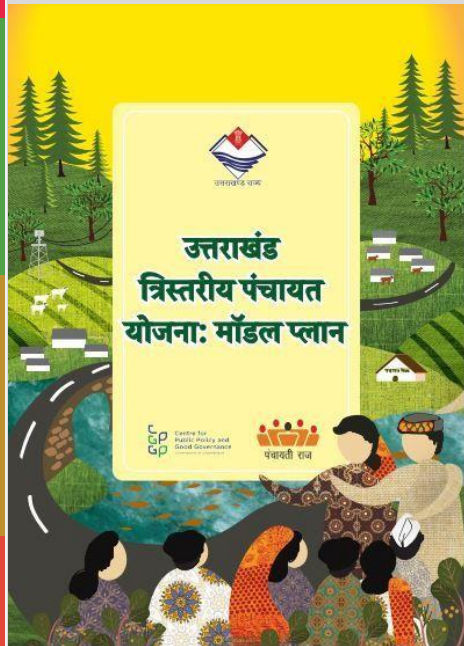
## CPPGG Uttarakhand

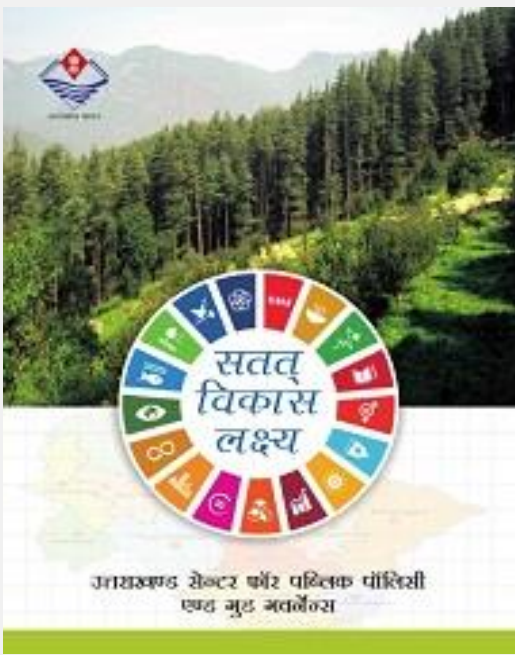

- **SDG Cell in all the districts** have been constituted and operational





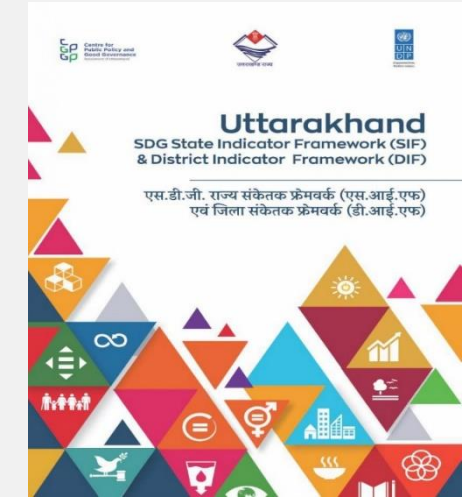

## Model GP Clusters

UNDP, in partnership with the Department of Rural Development aims to create Model GP Clusters to achieve Holistic and Sustainable Development

- Lead to Institutional strengthening of GPs and enablement of Quality GPDP.
- The GP Clusters to be provided technical guidance and handholding support to evolve into Model GP Clusters.
- UNDP is prototyping **a real-time based mobile based application** for monitoring impact, outcome and output indicators for tracking the progress of GPs.
- The resultant data will be housed in a centralized SDG Dashboard (already established by Planning Department) that will be dynamic in nature- enabling real-time data availability
- Development based on convergence of stakeholder activities and government schemes.

## Pilot Local Indicator Framework

- Local Indicator Framework preparation pilot in Karnataka districts- in progress

### Develop an 'SDG Model Village' where no one is left behind

SDGCC Nagaland is working with the Government of Nagaland to develop **an SDG Model Village** on a pilot basis.

- **Capacity building** of the elected representatives, members of the VC & VDB and field functionaries
- **Extensive publicity** on the importance of SDGs in the local dialect across the village for generating awareness and localizing the SDGs.
- Conduct **SDG-oriented need assessment** and situational analysis of existing infrastructure, facilities, etc.
- Develop **Local Indicator Framework (LIF)** based on the priority areas in alignment with the MoPR's Local LIF, collect baseline and set the time bound targets for short-term, medium-term, and long-term. Thereafter, regular collection of quality data to track the progress.
- Implement **new and innovative solutions** to perennial problems that will contribute towards the achievement of the goals and indicators at the grassroots level
- **Aligning village development plans to the SDGs** and targets for holistic and comprehensive local planning and execution of actions for achieving the SDGs



## SDGCC Punjab

### SRLM Knowledge Portal

The SDGCC supported the State Rural Livelihood Mission in creating a knowledge portal to address the emerging need of strengthening livelihoods, village organizations and self-help groups in Punjab during the COVID-19 pandemic.



A website for P-SRLM was designed and developed with a particular focus on developing relevant content to counter the effects of the pandemic, which included case studies, testimonials, and success stories of women in rural Punjab.

### I4SDG (Integrated Inclusive Innovation Incubator for SDGs)

- The SDGCC in partnership with the UNDP Accelerator Labs plans to work closely with concerned government departments, technical agencies, civil society organizations, industry partners and academic institutions to create an **SDG pilot model cluster**
- This is an incubation unit to pilot various SDG projects like GEET aimed at improving the quality of life for people from all strata of society.

### GIS-Enabled Entitlement Tracking (GEET)

UNDP and the Ministry of Tribal Affairs, GoI, developed a **GIS- Enabled Entitlement Tracking (GEET)** application to help create awareness among rural communities about social protection schemes, while enabling tracking and review of their outreach

## **Developing Panchayat Index/ PRA Tools/ Quality GPDPs**

- Support states in finalizing state-specific Local Indicator Framework (LIF) in alignment with SIF & DIF
- Field level testing of draft Panchayat Development Index (data availability, frequency, sources etc.)
- Facilitating preparation of quality GPDPs especially across Three Thematic Areas – Socially Secured Village, Poverty Free Village and Clean & Green Village
- Developing Participatory Rural Appraisal (PRA) Tools to support GPDP Planning Process



## Capacity Building

- **Empowering elected representatives** in collaboration with **SIRD, RD**
- Developing appropriate **Training package** (Modules and Learning Materials) for Master Trainers
- Sensitization of the community on various government schemes and policies through **IEC materials**
