# J&K: Existing SDG framework at State level

---

- A rigorous and logical step-by-step process followed for adopting SDGs – including goal setting, target prioritization, indicator selection, scheme analysis and developing a monitoring system.
- UT SDG indicator framework prepared in consultation with NITI Aayog- **206 indicators covering 81 targets were shortlisted for J&K SDG indicator framework**
- **High Level Committee constituted for SDGs under the Chairmanship of Chief Secretary, J&K**, with Administrative Secretaries of major Departments as its members
- **District Indicator Framework (DIF) on SDGs of J&K, UT** covering 15 Goals, 62 Targets and 166 Indicators, has been also prepared and finalized in consultation with the NITI Aayog/MOSPI. Districts have been asked to prepare their District plan
- Jammu and Kashmir Government is also in the process of creation of SDG Dashboard

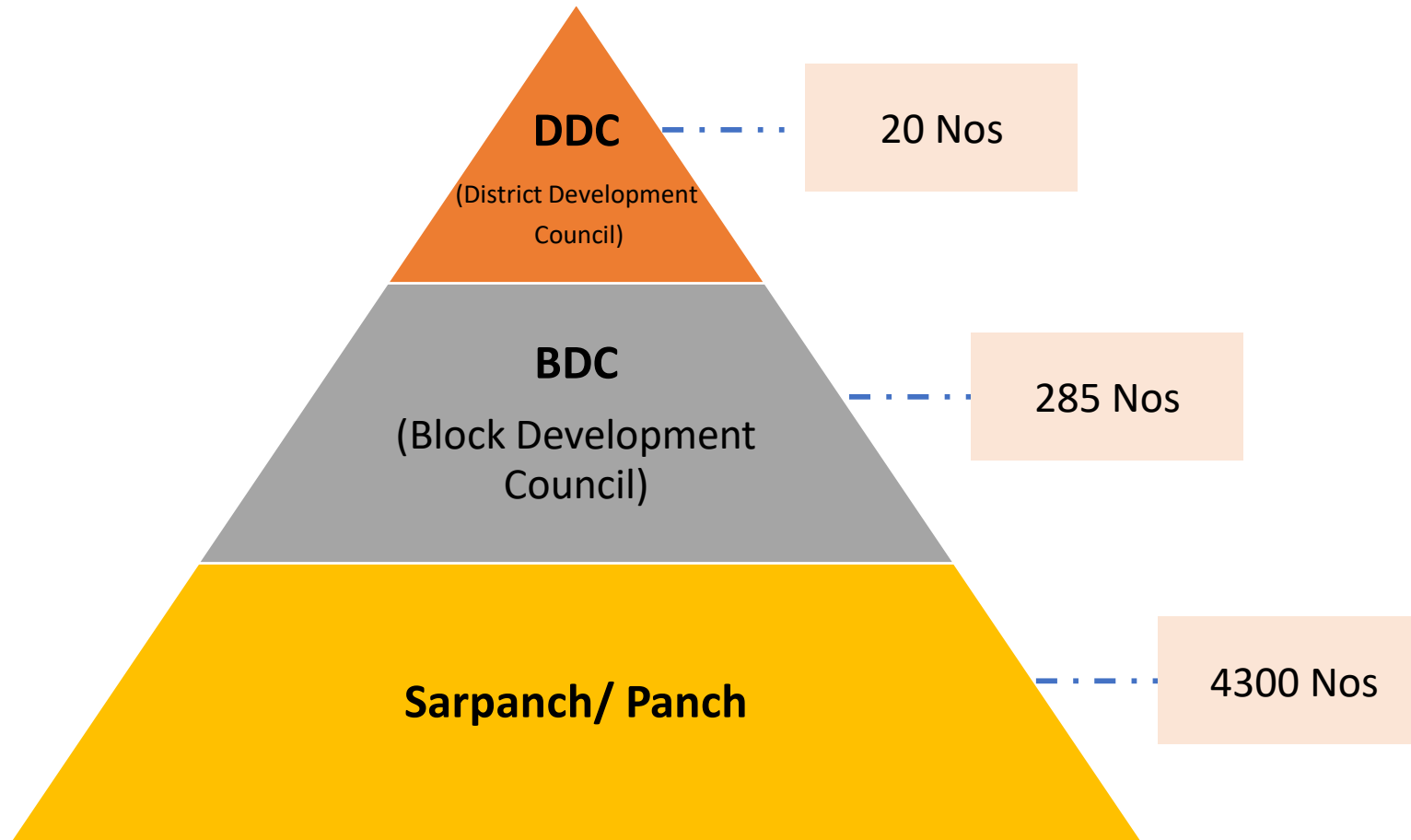

# J&K: Existing Institutional set up

---

## Panchayati Raj: 3 tier system



- All the 3-tiers of PRIs were in place in January, 2021
- Funds were also kept at the disposal of PRIs during 2020-21

# Roadmap for Localization of SDGs



## Committee formation

- ▶ Joint Advisory/ Communication to line departments; Rural & PR Dept – Nodal Department
- ▶ Framing of Task force/ Committees at UT/ District/ Block level



## Awareness regarding LSDGs

- ▶ Sensitization to PRIs on LSDGs by conducting Gram Sabhas across 4291 panchayats
- ▶ Involvement of line departments in awareness programme/ Gram Sabhas
- ▶ Roles and responsibilities for different levels



## Situation Analysis of GPs

- ▶ As-Is assessment of GPs with respect to PRI SDG indicators (Setting benchmark)
- ▶ Data source for GPs: Mission Antodaya, Gram Panchayats and consultation with Department
- ▶ Gap identification



## Prioritization of 9 themes

- ▶ Setting priorities and timelines
- ▶ Defining Local SDG goals and action plan thereon



## Capacity Building & Training on SDGs

- ▶ Training to 32,000 PRIs and SHGs (Self Help Groups) on 9 thematic themes at Block level
- ▶ Content development aligned with NIRD guidelines on Audio/Video – 9 thematic areas



## Resource Envelope

- ▶ Saturation/ Coverage of presence schemes
- ▶ Availability of various resources
- ▶ Mapping of resources with activities/ indicators and others – Involvement of stakeholders (SHGs/CBOs/Other)



## Plan as per prioritization

- ▶ GPs to set plan in view of target and different themes to meet critical gaps
- ▶ Setting timelines and earmarking resources in consultation with departments within available resources
- ▶ Integration with GPDPs



## Monitoring of activities

- ▶ GPs to monitor the plan on periodical basis
- ▶ Taking corrective actions from time to time



## Output and Impact

- ▶ Measuring output efforts per plan
- ▶ Undertaking impact assessment
