

#### Other steps to be taken

1. Facilitating oath taking by PRI members and community elders for achieving LSDGs and ensure meaningful participation for securing better rank in National Panchayat Awards.

2. Felicitation of all Pradhans/ Chairpersons of all participating GP/VCs in the National Panchayat Awards w.r.t all 9 LSDGs on the subsequent National Panchayati Raj day.

3. Collection of prior declaration from all BDOs declaring that all GP/VCs under the concerned block will participate in the National Panchayat Awards.

4. Activating a call center for regularly pursuing with the elected representatives and others across all levels of the hierarchy for ensuring mandatory participation in the NPA.

5. Gap analysis for due emphasis to focus areas at the time of PDP and allied activities.
