

## CURRENT YEAR STRATEGY FOR LSDG THROUGH TRAINING & CAPACITY BUILDING

- The TNA is the entry/ key assessment for drawing the training needs of the State. In this context, on need base, the second TNA is being prepared to be conducted
- State level Training of Trainers on Localizing of Sustainable Development Goals covering 9 thematic areas and ToT on convergent and evidence building planning for Development of quality GPDP/ DPDP and cascading of the training programme till Gram Panchayat level.
- (I) Seminar on “Development of International Bordering GPs (II) Rural development: Opportunities and challenges for Arunachal Pradesh are the new features of the training action.
- Deploying more functionaries for Training & Capacity Building (District Panchayat Development Officers, COs/ BDOs- Member Secretaries (Gram Panchayats), PFMS Officers, Panchayats Technical Assistants/JEs at different level).
- Institutional partnership with line departmental organizations like Ar. SRLM, SCERT, ATI, DIETS and Training cell of Skill development of State Government, RG Polytechnics : Modalities through the MOU.
- More policy/ advocacy programmes like: State level workshop on “Own source revenue and road map for Arunachal Pradesh.

## CURRENT YEAR STRATEGY FOR LSDG THROUGH TRAINING & CAPACITY

- Quality improvement of GPDP and incorporation of “**Sanklap**” of SDG are the key features of convergence planning. In this context the potentials CBOs/ NGOs shall be engaged in GP level
- Engagement of faculties of SIRD&PR are being planned for mentoring and handholding support to some of the Gram Panchayats to show case the model Gram Panchayats in the line of LSDGs (30 Nos). In the same line the DNOs/ PTA/JE(PR) shall adopt at least one Gram Panchayat covering certain SDGs/ *Sankalp* in their respective jurisdiction.
- Institutional strengthening: 23 number of DPRCs are proposed with two categories (12 numbers DPRCs for new construction and 11 numbers of DPRCs in the rented building).
- The people’s plan campaign : Advance Preparation & involvement of Interns/ Research Scholars/ Village Alumni/ School Alumni to contribute in the GPDP process as Gram Sabha Members.
- The concept of “*Go back your village and Share your knowledge*” for *the development of own Village* is slogan of the PPC in this year.
- Last Year 2 years constraint :COVID-19 restriction ,however , this year ,the momentum of training and capacity building network shall be expanded .
