Institutional arrangements for Localization of SDGs

- The Government of Uttarakhand is committed for achieving SDGs by or before 2030
- Centre for Public Policy & Good Governance(CPPGG) is nodal for SDG planning and monitoring at the State level.
- Six Working Groups for Six themes (Economy and Employment, Infrastructure Development, Social Infra, Climate Resilience and Natural Resource Management, Border Area Development and Tech based service delivery) headed by the senior administrative Secretaries, have been constituted for providing overall guidance
- Steering Committee, comprised of ACS-Planning, Addl. Secretary (P); Director-DES, and ACEO, CPPGG, for periodic review of SIF, DIF, MIF, & Monitoring processes

Institutional arrangements for Localization of SDGs

- MoU signed with UNDP and CPPGG for technical support
- CPPGG working in a hub and spoke model, issue-based partnership/support has been agreed with 8 institutions (IIT-Roorkee, IIM-Kashipur, Doon University, GB Pant Agri Univ, UPES, ATI Nainital, AIIMS Rishikesh and GBPNIHE Almora) to support several interventions
- MoU has been signed between CPPGG and Panchayat Raj Departments for supporting the integration of SDGs in GPDP, BPDP, and DPDP
- State Vision 2030 has been published – providing an overall roadmap
- State Indicator Framework – 369 indicators
- District Vision 2030 has been developed
- District Indicator Framework – 125 indicators
- 35 Monthly monitorable indicators finalized for regular monitoring

Major steps taken for Localization of SDGs

- SDG Dashboard operational – having data from 2015-16 to 2020-21
- SDG Task Force has been constituted at divisional and districts level
- SDG Cell in all the districts have been constituted
- Chief Development Officers have been designated SDG Nodal Officer
- SDGs have been aligned with the outcome budget
- During the last assembly session – on 28 August 2021 SDGs were discussed by the Hon'ble Members of Vidhan Sabha
- Model Panchayat Plan published for aligning SDGs with GP, BP, DP Development Plans
- ToT (two) have been conducted – a pool of trainer/facilitators have been prepared for handling

- ▶ Clear vision with strategic planning is required.
- ▶ Localising vision clearly shown in 9 themes.
- ▶ Necessary to identify the major growth drivers to enhance the local economy for enhance livelihood and poverty free Panchayat and engendered development at least
- ▶ To achieve the LSDGs targets, the multi-facet efforts are required.
 - ▶ **sensitization and awareness creation through IEC activities ,**
 - ▶ **capacity building,**
 - ▶ **Planning (GPDP,BPDP and DPDP)**
 - ▶ **Budgeting and Resource mapping**
 - ▶ **inter-sectoral co-ordination and convergence**
 - ▶ **monitoring, and evaluation**
 - ▶ **innovative models for implementation of SDGs**
- ▶ Data management system
- ▶ Sensitization workshops at ZP, BP, and GP levels
- ▶ Planning and execution workshops for developing model plan

Guidelines, Action Plan, Priorities

- ▶ Circular yet to issue for five-year visioning of Panchayat plan (Karnataka model).
- ▶ State shall prioritize the different themes as below.

1. Theme 8 - Village with good governance (goal no. 9, 16, 17) –C3N(Convergence, Co-ordination , Community Participation & Networking) Model to be promoted;

2.Theme 1- Poverty free & enhanced livelihood(SDG 1,2,3,4,5,6,7,8,10,11,12,15)– Huge out migration for livelihood therefore all the major departments like Agri, Horti, Animal Husbandry, Dairy, Fisheries, MSME, Tourism, RD would make the strategies.

3.Theme 2 & 3 Healthy village and child friendly village(SDG1,2,3,4,5,6,12)The state has large number of malnutrition issues in terms of stunting, wasting and anemia among the children and women along with ANC , PNC , Institutional Delivery issues

4.Theme 4 water sufficient village(SDG1,2,3,4,5,6,8,9,10,11,12,13,14,15) :The state has water scarcity in hill region;

5. Theme 5 Clean & Green Village (Goal No. 6, 7, 12, 13, 14,15) - Uttarakhand is disaster prone areas, afforestation, solar energy promotion, maintaining health hygiene practices.

6. Theme 9 - Engendered Development (Goal no. 1,2,3,4,5,6,7,8,9,10,16) – Reducing work force participation of women over the years. Largely, hill economy is depend on women.

7. Theme 7 - Socially secured village (goal no. 1,2 5,10, 16) – Due to migration, large number of old populations is left behind in villages. among children & Women.

8. Theme 6 – Self-sufficient infrastructure (goal no. 1,2,4,5,6,9,12) – The villages have comparatively better infrastructure, hence, it is kept in last priority.

To begin with, 20 most vulnerable GPs from each block will be identified and saturated under each theme aiming at ‘Sarva Utthan Serva Samridhhi’ campaign

Support Arrangements at different level

- ▶ Under RGSA, the state is planning to provide the handholding support for preparation of comprehensive GPDP, BPDP, & DPDP.
- ▶ It is proposed that one facilitator at each cluster (10-15 GP) for three months from August to September. Similarly, for BPDP (2-3 BPs) one facilitator and for ZPDP one each.
- ▶ ADOs will be nominated as charge officer for each block and they will support facilitate the cluster level facilitator for preparation and overall of supervision.
- ▶ Other HR under different programmes are to be identified for effective and efficient co-ordination and facilitation to PRIs
- ▶ The above facilitator will provide technical and other required support to six committees at GP level.
- ▶ Time bound compliances should be ensured through formulating / adopting right to services for community.
- ▶ Charter for the above will developed after in-depth consultation.

Role of NGOs, SHGs and Academic Institutions

- ▶ Thematic area-wise identification and empanelment of local NGOs/CBOs for the mobilization of rural masses, Support in IEC, imparting trainings, and also work as watch-dog.
- ▶ In Uttarakhand more than 95% women SHGs are formed.
- ▶ Though the objective of SHGs formation is for income generating yet the SHGs can support to facilitate the Aganwadis for identifying the malnourished children and women, status of immunization, anemia, Operation and maintenance of Water supply and other community assets.
- ▶ Through internship programs, the educational institutions shall be involved in conducting surveys, Studies and MnE.
- ▶ We have already done such pilot to see the preparation of GPDP,BPDP and DPDP

IEC Activities

- ▶ IEC Activities for effective planning, implementation and monitoring of the themes
- ▶ Still the IEC activities are being done in fragmented and silos manner
- ▶ Identification of agency for designing the IEC activities
- ▶ Earmarked the resources for IEC
- ▶ Development of IEC tools like posters, folk, social media, community radio, electronic media, pamphlet, wall writing etc
- ▶ Community Radios are effective tool in hilly region. Usage of CRs for 9 themes
- ▶ Positioning of IEC materials

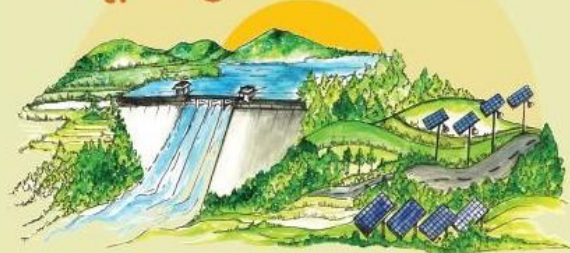
