

In Q.1,2,3 Performance should be measured on demand raised.

Can NREGA data be directly pushed from central NIC datasets? If needed, editing option to GP may be given. It will reduce data errors.

In Q.10, is it loans sanctioned or loans disbursed?

Q.11. Some GPs may not have enough number of separate SHGs for each of the 05 radio buttons. The question format does not account for it,.

Q.12 data relates to skill development and the GP will NOT have this at their level at all.

Q.14. Grain bank concept is obsolete in light of Universal PDS in Chhattisgarh and also because Food dept directly gives grain to Panchayats as part of the Drought Manual.

2	Healthy Panchayat	In Q.5 and Q.9, are the check boxes yes/no type. If so, then what about qualitative differentiation in performace? How will that be captured? In Q.10, telemedicine clause should be there only for such GPs where telephone signal / connectivity is available. If not, it will penalise such Panchayats needlessly. In Q.13., data table is not logical about marks range to be allotted. We need to have clarity on the marking table. In Q.14, Total own Fund column must come before "Sector", else it will be mis-leading. Also, logic should be built into the software to dis-allow wront entries. Such as, if individual line entries entered are more than total own income, then it should give a prompt at time of submission.
4	Water Sufficient Panchayat	In Q 8 hand pump cleaning should be deleted.
5	Clean and Green Panchayat	In Q.5, UJALA and in Q.6, UJJWALA data, will not be there with GP sachiv for last year because saturation was done 03-04 years ago in mission mode.
