**Minutes of the 1st Central Empowered Committee (CEC) of Rashtriya
Gram Swaraj Abhiyan (RGSA) held on 02nd March 2021**

The 1st Meeting of Central Empowered Committee (CEC) of Rashtriya Gram Swaraj Abhiyan (RGSA) for the year 2021-22 was held on 2nd March 2021 through Video Conference under the chairmanship of Secretary, Ministry of Panchayati Raj. The meeting was convened for consideration and approval of the Annual Action Plans (AAPs) of 6 States/UTs namely Andaman and Nicobar Islands, Bihar, Gujarat, Karnataka, Kerala and Meghalaya.

Welcoming the Secretary, members of the CEC and the representatives from States/UTs, Joint Secretary (CB) shared the agenda of the CEC meeting. Secretary, MoPR and Chairman of the CEC addressed the CEC members and the representatives of 6 states/UTs. The following observations were made by the Chairman & Secretary MoPR:

- Non-release of matching state share in time by the states results in undue delay for releasing the Central Share thereby impacting the CB and related activities. States need to be more proactive in fulfilling the financial norms for expending the funds timely.
- Large amount of unspent balance with States / UTs results in corresponding reduction in Central share releases.
- Under capacity building and training, States/UTs should give special emphasis on digital literacy of Elected Representatives, effective CB to transform the ward members or Panches into sectoral resource persons.
- States/UTs should prioritise various Capacity Building & Training activities for the SHGs for promoting alternate livelihood opportunities through distance mode/online/video mode training with support from NIRDPR/SIRDPRs/ and other Training organisations.
- Training and capacity building are carried out in accordance with the proposed calendar. Emphasising on the role of NIRDPR, Chairman advised that the training material and modules submitted by the States are required to be examined thoroughly by NIRDPR and same is required to be communicated to States.
- States/ UTs need to forge collaborations with educational institutions and institutions of excellence for providing handholding support to Gram Panchayats for preparation of quality GPDPs. It is also crucial that SIRDs may collaborate with research institutes for deeper penetration of CB activities at grass root level which will also give the students/academicians first hand practical experience.
- All the agencies are to be registered under the Public Financial Management System (PFMS)

Thereafter, CEC took up for consideration the Annual Action Plans submitted by 6 States/UTs.

AGENDA : Approval of the Annual Action Plans (AAPs) of 6 States/UTs namely Andaman and Nicobar Islands, Bihar, Gujarat, Karnataka, Kerala and Meghalaya.

The details of amount proposed by States and MoPR recommendation along with CEC observations are as under:

(A) Andaman & Nicobar Islands

- Fund proposed by UT - 2.255 cr.
- Fund recommended by CEC - 2.255 cr.
- The details of broad activities and amount approved there for are given in **Annexure I (a)**

CEC Observations

- ❖ As per the information provided by the State during the CEC meeting, State has utilized 6.086% of the funds available with them.
- ❖ Progress reported on MIS: State has uploaded the progress of 2020-21 in the MIS.
- ❖ % of CB&T activity proposed in AAP 2021-22: 76.78%
- ❖ An amount of Rs. 3.234 cr. remains as unspent balance with the UT. CEC has approved an amount of Rs. 2.255 cr for 2021-22 and requested UT to utilize the unspent balance at the earliest for any further, release under RGSA scheme.

(B) Bihar

- Fund proposed by State - 260.61 cr.
- Fund recommended by CEC - 268.90 cr.
- The details of broad activities and amount approved there for are given in **Annexure I (b)**

CEC Observation

- ❖ Capacity Building & Training (CB&T)- Approved as proposed. (Rs 99.327 cr)
- ❖ Carry over activities not proposed in the AAP submitted by the State, however, during the CEC meeting State has requested to approve the following carry over activities, hence the increase in fund recommended by CEC
- ❖ **Repair of PB**: An amount of Rs. 4.68 cr. approved by CEC for repair of 117 GPs during the year 2021-22 as carry over activity.
- ❖ **CSC co-location**: 1050 CSC co-location approved during the financial year 2020-21, during the CEC meeting State has informed that 800 CSC co-located and utilization of the same will be forwarded soon. Further, State requested to provide fund for the collocation of remaining 250 CSC with the GPs during the current financial amounting to Rs. 10 cr. CEC advised the State to share the list of the GPs co-located and also approved the proposal for co-locating remaining 250 GPs amounting to Rs. 10 cr. as committed liability.

- ❖ **Construction of PB:** CEC in principle approved the proposal of construction of 500 PB. However, keeping in view limited fund availability under the budgetary allocation for the scheme during the year 2021-22, the CEC decided that funds for 100 GP buildings may be released subject to observance of RGSA guideline and other conditions. The funds for remaining GPs will be considered for the release during the 3rd quarter of the year keeping in view the availability of fund position therein.
- ❖ State has utilized 46.62% of available fund during the F.Y.2020-21.
- ❖ Progress reported on MIS: State may ensure updating of progress in the MIS at the earliest
- ❖ % of CB&T activity proposed in AAP 2021-22: 38.112%

(C) Gujarat

- Fund proposed by State - 69.09 cr.
- Fund recommended by CEC - 55.07 cr.
- The details of broad activities and amount approved there for are given in **Annexure I (c)**

CEC Observation

- ❖ The components & amount proposed by State which was not approved by CEC are as under:
- ❖ **CB&T-** State proposed an amount of Rs.38.88 cr. and CEC recommended for only 32.48 cr. as the training for 40,000 ERs was a carryover activity for which funds were already available with the State. Of this CEC has accorded post-facto approval to 32112 training, already completed by the State.
- ❖ **PLC-** CEC approved Rs. 0.25 cr. for 5 PLC as proposed by the State
- ❖ Construction of SPRC/DPRC: - State proposed an amount of Rs. 1:00 cr & 4:00 cr respectively for SPRC & 2 new DPRC, which was not approved by CEC.
- ❖ **E-SPMU-** State proposed an amount of Rs. 0.084 cr. however, CEC approved for 0.06 cr. as per RGSA norms
- ❖ **E-DPMU-** State proposed an amount of Rs. 1.44 cr. however, CEC approved for 1.386 cr. as per RGSA norms.
- ❖ Project related to Economic Development and Support for Innovation:- State submitted the proposal under the component of project for economic development and innovation of Rs 1.65 cr. CEC asked the state to come with DPR and it may be considered separately.
- ❖ An amount of Rs. 19.94 cr. was available unspent balance with the State during the year 2020-21 and as per the information received from the State same has been utilized by the State.
- ❖ Progress reported on MIS: State may ensure updating of progress in the MIS at the earliest
- ❖ % of CB&T activity proposed in AAP 2021-22: 60.177%
- ❖ **Training Component:-** CEC considered the all training activities proposed by the State in which they will train their 75% of the ERs and Panchayat functionaries
- ❖ **Construction of Panchayat Bhawan:-** CEC agreed for construction of 30 Panchayat Bhawan as carry over activities worth 6 cr.

(D) Karnataka

- Fund proposed by State - 180.61 cr.
- Fund recommended by CEC - 195.11 cr.
- The details of broad activities and amount approved there for are given in **Annexure I (d)**

CEC Observation

- ❖ State has proposed an amount of Rs. 127.33 cr under Training & Capacity Building (CB&T), an amount of Rs. 100.32 cr approved by MoPR during CEC meeting as the training proposed at village level is not admissible as per scheme. However, it was advised that CEC shall consider the proposal after the State suitably modified the training proposed at village level to appropriate level. ***Karnataka has submitted the revised CB proposal after necessary corrections amounting to Rs. 127.33 cr. Accordingly, the proposal is approved.***
- ❖ E-DPMU- State proposed an amount of Rs. 1.54 cr. for 30 E-DPMU @ 43000/- however, CEC recommended 1.26 cr for 30 E-DPMU @ 35000/- as per RGSA norms.
- ❖ Additional fund approved by CEC:
- ❖ Repair of PB: State has proposed Rs. 10.00 cr for 250 new repair.
- ❖ However, during the CEC meeting state has requested to consider 346 repairs as carry over. Same was approved
- ❖ Total 596 PB repair approved to the tune of 23.84 cr.
- ❖ During the financial year State has utilized 19.404% of available fund during the F.Y. 2020-21.
- ❖ Progress reported on MIS: State may ensure updating of progress in the MIS at the earliest
- ❖ % of CB&T activity proposed in AAP 2021-22: 72.57%
- ❖ **Construction of New GP Buildings**: In principle approved for 100 GPs.
- ❖ **Repair of GPs**: An amount of Rs. 238400000 in principle approved for 596 Repair of PB (346 c.o + 250 new).
- ❖ State may ensure timely release of State matching Share.
- ❖ Training calendar may be shared

(E) Kerala

- Fund proposed by State - 61.96 cr.
- Fund recommended by CEC - 52.86 cr.
- The details of broad activities and amount approved there for are given in **Annexure I (e)**

CEC Observation

- ❖ CB & Training activities:- CEC has given approval of all its training activities proposed by the State amounting to Rs. 32.528 cr.
- ❖ Panchayat Bhawan Support:-
- ❖ Construction: State proposed for carry over construction of 6 Panchayat Bhawan.
- ❖ CEC approved 2 New Panchayat Bhawans

- ❖ Repair of Panchayat Bhawans :- CEC gave in-principle approval of Repairs of 50 Panchayat Bhawans subject to availability of funds.
- ❖ CSC Co-location:- CEC given nod to complete the CSC co-location of 12 CSC under the carry over activities.
- ❖ E-Enablement:- CEC approved procurement of computers for 100 GPs under the e_enablement component,
- ❖ Distance Learning Facility through IP based Technology: - State proposed to establish the IP based technologies within the State worth Rs 1.74 cr. for better Training activities and communication. CEC given the approval of the same.
- ❖ Project related to Economic Development and Innovation:- State proposed for project of worth 2.10 cr under the support for Economic Development and Innovation, ***CEC asked the state to come with DPR and it will considered separately***
- ❖ Progress reported on MIS: State may ensure updating of progress in the MIS at the earliest
- ❖ % of CB&T activity proposed in AAP 2021-22: 52.49%

(F) Meghalaya

- Fund proposed by State - 37.155 cr.
- Fund recommended by CEC - 34.863 cr.
- The details of broad activities and amount approved there for are given in **Annexure I (f)**

CEC Observation

- ❖ CB&T: CEC has given approval of all its training activities proposed by the State amounting to Rs. 11.85 cr.
- ❖ CEC did not approve the proposal for Construction of New SPRC & DPRC as proposed
- ❖ State has not released any state matching share and in 2019-20 the state government did not released any fund to the SNA. It was informed to the state that the release of funds for the year 2021-22 will be done only after the state release their state share and central share to SNA and send the utilization certificate showing the same.
- ❖ State was also informed that they have not done any uploading of GPDP plan on e-gram swaraj portal and are advised to do the same.
- ❖ Progress reported on MIS: State advised to ensure the uploading of progress in MIS.

* During CEC meeting, the Additional Chief Secretary (Panchayati Raj) stressed the need for providing adequate infrastructure in Gram Panchayat Building so as to function these GPs in smooth manner. He stated that keeping in view the larger size of GP in the State and the

functions performed by the GPs, the State intended to construct Panchayat Sarkar Bhawan in the GPs through convergence of funds and hence requested for providing financial assistance for 500 GP building @ Rs. 20 lakhs/ GP out of RGSA.

CEC Decision: In view of the position brought out by the State the CEC in principle approved the proposal. However, keeping in view limited fund availability under the budgetary allocation for the scheme during the year 2021-22, the CEC decided that funds for 100 GP buildings may be released subject to observance of RGSA guideline and other conditions. The funds for remaining GPs will be considered for the release during the 3rd quarter of the year keeping in view the availability of fund position therein.

** During the CEC meeting, State informed that an amount of Rs. 4.68 cr was approved for repair of 117 GPs during the F.Y. 2019-20. However, no expenditure has been made by State towards this activity. The State now wanted to undertake this activity during the year 2021-22. Hence, State requested for approval of an amount of Rs. 4.68 cr. as a carry over activity for the year 2021-22.

CEC Decision: In view of the facts of the case, the CEC approved the activity as committed liability subject to condition that the above activity may be completed during the year.

*** During the CEC meeting, State informed that out of 1050 CSC co-location approved during the financial year 2020-21, State has co-located 800 CSC and utilization of the same will be forwarded soon. Further, State requested to provide fund for the collocation of remaining 250 CSC with the GPs during the current financial amounting to Rs. 10 cr.

CEC Decision: CEC advised the State to share the list of the GPs co-located and also approved the proposal for co-locating remaining 250 GPs amounting to Rs. 10 cr. as committed liability.
