# Ministry of Panchayati Raj (Azadi Ka Amrit Mahotsav)

Proposed activities during **Week 4** [**02.04.2021 - 08.04.2021**] for Panchayati Raj institutions to conduct Awareness Campaign involving officials/ functionaries of the concerned / line Department to discuss and sensitize the villagers regarding the initiatives relating to awareness campaign on localisation of **SDG Goal 1 - No Poverty**, as listed among a set of 17 Sustainable Development Goals (SDGs) to end poverty, fight inequality and injustice, and tackle climate change by 2030:

**Objective**: Poverty is a multidimensional concept that encompasses the various deprivations that poor people experience in their daily lives. The first goal of the 2030 Sustainable Development Goals is to end poverty in all its forms, everywhere. Sustainable Development Goal 1 (SDG1) aims to eradicate extreme poverty by 2030. As the closest level of government to the people, Panchayati Raj Institutions are well-placed to raise awareness about the importance of the SDGs and their relevance to local communities. Local self-governments bridge the gap between Central Government and communities and should play a strong role in fostering the involvement of civil society organizations, the private sector (micro, small and medium enterprises), academia and other community-based organizations.

**Participation**: Involvement of elected public representatives including elected members of Panchayats, functionaries of public dealing departments, youth, school students, social and cultural organizations, NGOs, civil society and all the sections of the society for ensuring maximum public participation in this National festival of the grand celebrations of 75 years of Independence.

### **Proposed activities:**

- (i) Awareness-raising activities should aim to increase the engagement of citizens and local communities in order to promote their sense of ownership of the Agenda and their participation in the achievement of the SDGs at local level.
- (ii) Activities that can be undertaken to raise awareness among the population should make the SDGs engaging and harness the power of local culture/tradition. Such activities could cultural programmes, wall-painting, fairs, annual events, discussing success stories, good practices etc. The planning of activities should include a gender perspective to ensure that women and girls are not excluded.
- (iii) Panchayats may conduct IEC activities based on local situation / requirement / suitability.
- (iv) Panchayats may explore the possibilities of organizing Job Fairs/ Melas where improved crop varieties and innovative crop cultivation practices will be exhibited.
- (v) Panchayats may inform / sensitize the masses about various poverty alleviation schemes launched by the Government of India to address poverty in rural areas and to ensure rural development.
- (vi) Special awareness about Schemes such as Mahatma Gandhi National Rural Employment Guarantee Act 2005 (MGNREGA), National Rural Livelihood Mission (NRLM), Pradhan Mantri Awaas Yojana-Gramin (PMAY-G), Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Public Distribution System (PDS) etc.

**Significance of 13**<sup>th</sup> **April in Indian Freedom Movement**: The Jallianwala Bagh massacre, also known as the Amritsar massacre, took place on 13 April 1919. A grateful Nation pays tributes to the martyrs of the Jallianwala Bagh massacre of 1919. Their greatest sacrifice, courage and valour will continue to inspire Indians for years to come.

**Significance of 14<sup>th</sup> April** (**Ambedkar Jayanti**): Hon'ble Prime Minister's concluding remarks in the 75<sup>th</sup> Episode of 'Mann Ki Baat' broadcast on 28/3/2021 are reproduced as under: "Today in 'Mann Ki Baat' we talked about 'Amrit Mahotsav' and our duties towards the country. We also discussed other festivals and festivities. Meanwhile, another festival is arriving which reminds us of our constitutional rights and duties. That is 14 April – Birth anniversary of Dr. Baba Saheb Ambedkar ji. This time in the 'Amrit Mahotsav', this occasion has become even more special. I am sure that we will make this birth anniversary of Babasaheb a memorable one by taking a resolve of our duties and thus paying tribute to him."

**Objective**: Jan Sanvaad (जन संवाद) and Jan Jagran (जन जागरण) about various facets of Azadi Ka Amrut Mahotsav in all villages under the jurisdiction of Panchayati Raj Institutions across the country for ensuring Jan Bhagidaari (जन भागीदारी) in 75-week long Azadi Ka Amrit Mahotsav.
