



### **Suggestions**

**Regarding submission of supplementary plan:** One mandatory provision of getting approval from the state level before uploading supplementary plan may be included in e-Gramswaraj portal so that check and balance mechanism could be ensured.

**Resource Envelope:** Once an amount is allocated to a particular activity the budget should be proportionately reduced and the latest fund availability should be automatically shown for further allocation. Presently the whole budget amount is shown even after actual exhaustion of the budget.

**Availability of GP wise data:** The data in major schemes like PMJDY, PMJJBY etc., got reflected revenue mouja wise in their respective MIS rather than Gram Panchayat wise. The availability of GP-wise data should be ensured for holistic planning.

**Issues related to Line Departments:** Integration of line dept. specific plans from their respective MIS for a particular GP in the eGS portal.

**FFC Issues:** The portal should automatically fetch fund devolution status of the FFC and the fund should be shown under tied and untied grant. Moreover for tied grants permissible activity (i.e, Drinking water and sanitation), fund availability in the ratio 50:50 should be automatically shown and the fund should be proportionately reduced every time an allocation is made to an activity. Purpose is to show in real time the fund availability under drinking water and sanitation heads.
