Subject:- Regarding Utilisation of Unspent balance of Fourteenth Finance Commission Grants (XIV FC) to Gram Panchayats beyond 31st March, 2023

Sir /Madam,

I am directed to refer to OM No. 15(1)- FC XV/FCD/2020-25 dated 11th May, 2023 from Ministry of Finance (MoF), Govt of India on the above subject. (Copy Enclosed). In the reference OM, it has been confirmed that the rural local bodies in the State may utilise unspent balance of XIV FC grants as per guidelines on the subject. However, to avoid parking of funds, Ministry of Panchayati Raj (MoPR) has been advised not to recommend release of grants to those local bodies who have unspent balance of XIV FC exceeding 10 % of the instalment under consideration for release.

2. In order to facilitate making recommendation for release of subsequent instalment of Fifteenth Finance Commission (XV FC) Grants' instalment to the States in compliance to the above stipulation of MoF, States are required to submit along with their claim for subsequent instalment of XV FC Grants, a certificate, that the Rural Local Bodies (RLBs) in the State do not have unspent balance of XIV FC Grants exceeding 10 % of the instalment under consideration. This would be an additional requirement to the already existing eligibility conditions for release of XV FC Grants.

This issues with the approval of Secretary, Panchayati Raj.
