# A brief overview

- A. Saksham Anganwadi and Poshan 2.0 (or Mission Poshan 2.0) is an Umbrella Mission of MWCD
- B. It seeks to address the challenge of malnutrition in children upto age of 6 years, pregnant women, lactating mothers and adolescent girls (14-18 years)
- C. The Mission aligns 3 important programmes that aim at achieving nutritional outcomes, viz.
  - i. Anganwadi Services Scheme
  - ii. Scheme for Adolescent Girls and
  - iii. Poshan Abhiyaan
- D. The Poshan Tracker an ICT platform has been developed as an important governance tool for Poshan 2.0

# Poshan Tracker Coverage and Current Status

1. Total Beneficiaries without Adolescent Girls: 10,06,47,068
2. Total Beneficiaries including Adolescent Girls: 10,28,93,968
  - a. Pregnant Women: 70,48,018
  - b. Lactating Mothers: 47,68,578
  - c. Children 0 to 6 years: 8,88,30,472
  - d. Adolescent Girls: 22,46,900 (Aspirational Districts and North Eastern Region)
3. 94% Aadhaar Verified beneficiaries
4. 77.82% Adolescent Girls are Aadhaar verified
5. 13,61,107 Anganwadi Workers (AWW) using the Poshan Tracker application
6. 8,66,262 Anganwadi Helpers (AWH) registered

# Poshan Tracker Coverage and Current Status

7. Complete State Machinery onboarded
  - a. 132 State Officials
  - b. 999 District Officials
  - c. 7,714 Project/ Block Officials
  - d. 36,682 Supervisors
8. Achieved 87% measuring efficiency by capturing height and weight of 7,70,79,767 children (0 to 6 years) out of 8,88,30,472 registered children
9. Achieved 93% Home Visits completion status by 13,52,304 AWW covering 2,29,77,674 beneficiaries whereas the target visits was 2,45,99,705
10. THR distribution recorded as 44% for Pregnant Women, Lactation Mother, Adolescent Girls and Children 6 months to 3 years (Module under revision)
11. HCM distribution recorded as 63% for children 3 years to 6 years (Module under revision)
12. Capturing all Infrastructure details like, Owned/ Rented building, Drinking Water facility, Functional Toilet

### GOVERNMENT OF INDIA



- Announced by Hon'ble Prime Minister on **31.12.2016** and **implemented w.e.f. 1.1.2017**
- Revised PMMVY under Mission Shakti for empowerment of women implemented w.e.f. **1.4.2022**
- Implemented in Direct Benefit Transfer (DBT) mode
- Benefit of **₹5,000** in 2 installments for 1<sup>st</sup> child and the remaining amount to be received under Janani Suraksha Yojana so that a woman gets on an average **₹6,000**
- **₹6,000 for second child only if the child is a girl.**
- **Up to 4<sup>th</sup> June 2023 more than 3.33 Cr beneficiaries have been enrolled and out of which 3.11 Cr beneficiaries have been given the benefit with a total disbursement of 13,646 Cr Rs.**

# Stakeholders and Their Responsibilities



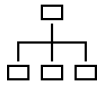
## **Citizen**

Citizen can register themselves using the mobile app /PMMVY portal/Umang App /



## **Field Functionary**

Field Functionary (AWW/ASHA) will be able to register a beneficiary at village level



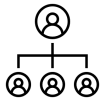
## **Supervisor**

Supervisor/ANM at the block level will verify the beneficiaries registered by the field functionaries.



## **Sanctioning Officer**

The Sanctioning Officer (CDPO/Medical Officer) will approve the registration and different claims forms submitted by the Supervisor



## **District Nodal Officer**

The District Level User will create the Sanctioning Officer and Supervisor User Accounts



## **State Nodal Officer**

The State Level User will create the District Level User account.



## **Central Nodal Officer**

They will have the rights to add, delete or modify any user account.
