States' Initiatives on LSDG and Development of LIFs (2/15)

West Bengal



Participatory and theme-based planning processes adopted :

- 'Para Baithak' for data validation and participatory planning for GPDP
- Introduced Digitization of primary data system captured in Peoples' Plan Campaign for GPDP from FY 2022-23 for preparing Gram Panchayat-wise Local HDI Report (LHDI)
- Real data of stages of participatory planning will be captured through Mobile-Application
- Dedicated Banglar Para Baithak Portal is used for preparation of Baithak Calendar, theme-wise Data capturing etc.
- 9 LSDG themes mapped with corresponding Standing Committees/Sub-Committees of Panchayats
- Shifting from Sector based Indicator to Theme based Indicator (*Information collected at GP Level and from neighborhood level meeting*). Based on this, report for GP, BP and DP will be compiled
- Theme based indicators have also been mapped with existing Sector and Sthayee Samiti (Standing Committees)

West Bengal

- **9 broad steps involved/to be involved in the Participatory Planning Process through Para Baithak :**

1. Preparation of Baithak Calendar (Neighborhood Level Meeting Schedule)
2. Invitation of citizens to attend Hamlet Meeting
3. Capture Theme-wise GP Level Indicator
4. Hamlet Level Meeting (Para Baithak) on scheduled date
5. Verification of data at Gram Panchayat level
6. Monitoring of Theme-Wise Issues raised by Villagers at Hamlet Meeting
7. Analysis of Theme-wise report, identifying the gap and ranking of Gram Panchayat
8. Proposed activity entry
9. Report on Theme based Local Indicator and Draft Plan



- **Outcome of the Para Baithak-based Participatory Plan Process:**

1. Identification of local development index and setting the target of GPDP in tune with LSDGs
2. Development of GP-wise HDI reports
3. Preparation of more need based GPDP in compliance to LSDGs with focus on human and social development
4. Reduction in cost of time to capture and compile the data
5. Strengthening of the good governance system of PRI
6. Strengthening the process of transparency and accountability of planning process through Gram Sansad Sabha (Ward Sabha) and Gram Sabha
7. Analyzing baseline situation for preparation of GPDP based on digitalization of data

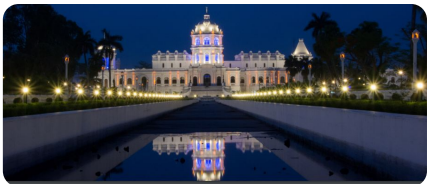
States' Initiatives on LSDG and Development of LIFs (4/5)

Karnataka



- Computed Localised Sustainable Development Index at Gram Panchayat level in tune with the activities of the state ; pilot taken up in 31 GPs one from each district
- LSDGs were incorporated into State's online portal 'Panchatantra' for monitoring the process of preparation of plans and the same has been developed and incorporated in Panchatantra 2.0.

Tripura



- As a pilot exercise, 5 GPs from different Block taken for Gap analysis
- 'Gram Panchayat level Micro Team for Data Collection' developed
- After the analysis 52 Additional indicators suggested with total LIFs to be taken into account is 415
- State is putting in place local action plans involving the local communities involving training for local government officials and staff

States' Initiatives on LSDG and Development of LIFs (5/5)

J&K



- Framework of 206 indicators covering 81 targets prepared (includes 23 UT specific/localized indicators)
- Following this, District Indicator Framework (DIF) covering 15 Goals, 62 Targets and 166 Indicators developed in consultation with the NITI Aayog/MoSPI
- Panchayat level indicator framework being developed
- Two workshops on SDGs organized in Srinagar
- Draft document SDG Progress Report 2022, has been shared with all the stakeholders/ Administrative Departments for vetting of Data and bridging gaps
- Preparation of Panchayat Indicator Framework in process

Uttar Pradesh



- Selected themes of priority : Child Friendly Panchayat and Women Friendly Panchayat
- Directions from PR Department given for 100% participation of women elected representatives and at least 50 percent beneficiaries under POSHAN Abhiyan in Mahila Sabhas & Bal Sabhas.
- Mandatory participation of Anganwadi worker (ICDS), representatives from Education and other concerned line departments.
- Discussion on Mahila & Bal Sabha related panchayat 'Sankalp' in the Gram Sabha meetings.
- Also, 100% participation of Self –Help Groups and invite Panchayat Samiti members as special invitees have been directed.
