3	Criteria for selection of VCs/GPs for Data collection	 It covers the entire 11 districts and 26 Blocks. 1 VC from each Block had been selected by Deputy Commissioner. Thus total no. of VCs selected by DC is 26. 21 Villages adopted by various colleges in Mizoram had been covered. 6 villages under Village Level Development Plan (VLPD) under Planning Department were also covered. 9 backward villages under DoNeR Ministry were also selected for data collection. Therefore, total number of Villages selected for Data Collection is 62.

Challenges faced during data validation process at GP level

As aforementioned, data validation process is done at State Level by Planning Department and not at the GP Level.

Suggestions in respect of Local Indicators & its data Points (in respect of revision, modification & addition (if any)

The process of data collection in respect of Local Indicator Framework in Mizoram is still underway on pilot basis with the initiative of Planning Department.

After completion of data collection process, Planning Department in consultation with line Departments will validate data.

As stated, data collection is on pilot basis and relevant data will be added and irrelevant will be deleted.



Feedback on PDI Portal

- 1. State PDI Nodal Officer: will be decided by the State whether Local Administration Department (dealing with eGramSwaraj) or Planning Department (SGDs Nodal Department).
- 2. User Registration/Authentication:
 - 1. State and GP level credentials are same with eGS Login credentials.
 - 2. Facilitators shall be registered and their Login will be created from PDI Portal by the State User.

3. Indicator Management:

- 1. 2 categories of Indicator-
 - 1. Common Mandatory.
 - 2. Specific/Optional can be selected or de-selected by State.

4. State Specific Localization and Configuration:

- 1. It may also be required to register State Head Office of certain Department.
- 5. Block Level Configuration:
 - 1. As there are no Block Panchayats, this may not be required for the State.
 - 2. Portal hierarchy may be State Village Council. No tier in between.
- 6. Facilitator Management: (Is it mandatory? This can have financial implications)
- 7. In the case of Mizoram, Facilitators will be registered by State PDI Nodal Officer from State Login.



Feedback on PDI Portal (contd.)

- **8. Functions and SoP for State PDI Nodal Officer:** Formal consultation workshop will be organized at State Level wherein State and line Department officials and State NIC will participate.
- 9. **Data Verification** need to be done at State Level (Portal need to be configured to suit our existing system).
- 10. Functions and SoP for Block Panchayat Nodal Officers: N.A for Mizoram.



Institutional Mechanism for Validation

As on date, there is no mechanism as such. However, SDGs Cell under Planning Department will validate the data that are being collected on pilot basis.

State will try to follow the mechanism as suggested in the PDI guideline with customization to suit existing system. In this regard, technical support from the Ministry will be required.
