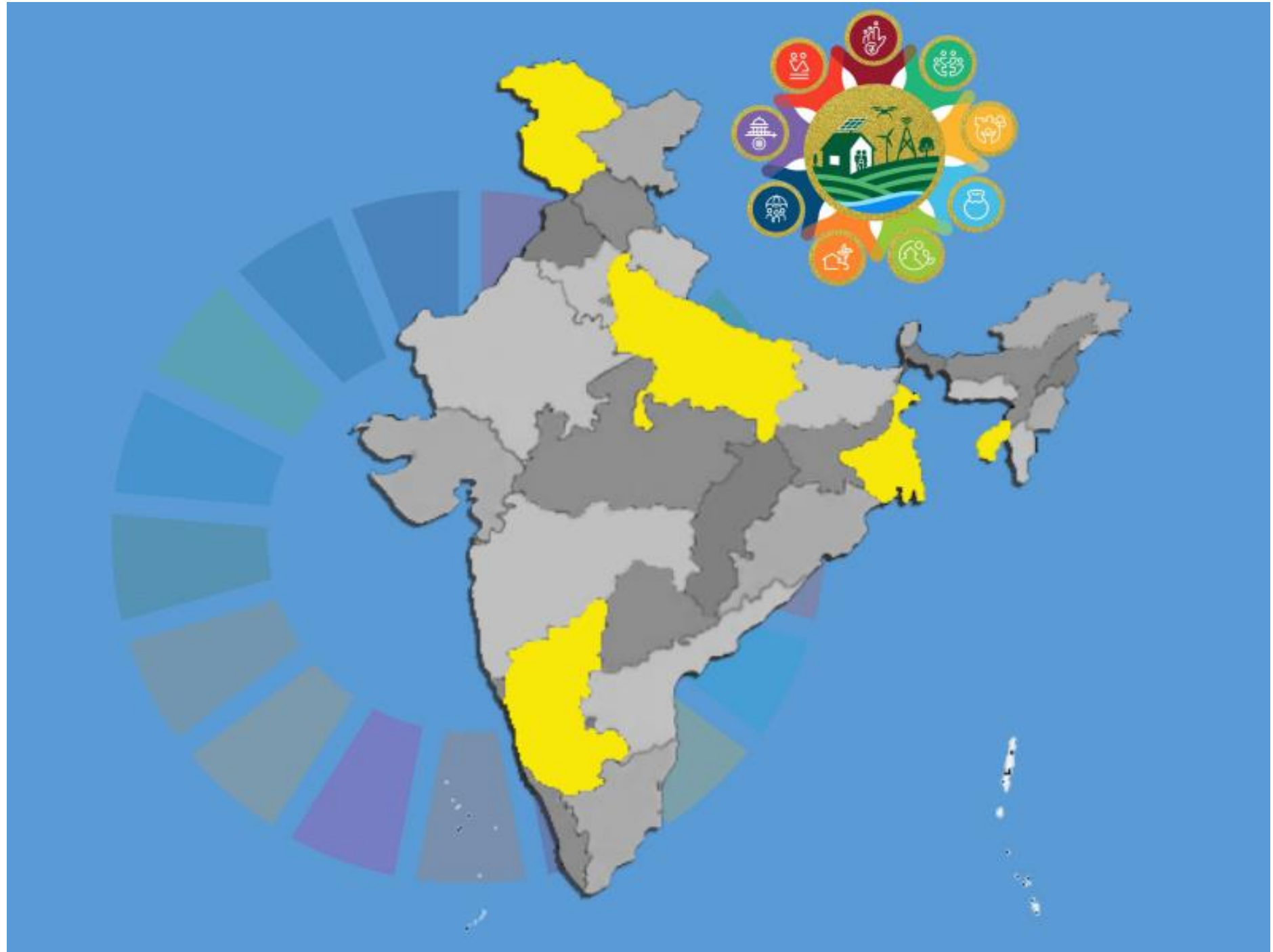

Key steps involved in data collection at GP level

Three-Day Orientation of the Functionaries of the Selected Gram Panchayats on the PDIs. The first day was a detailed in-house discussion on the LIFs, Numerators, and Denominators.

The second was full of field level activity where the data points were discussed in presence of field officials, elected representatives, and panchayat functionaries.

The third day was the day for data compilation and putting forward necessary suggestions.

The final output was discussed with the officials of the Directorate of Panchayats, Government of Tripura and a compiled list has been prepared accordingly.

Challenges faced during data validation process at GP level

1. All the Panchayats are not having representative/official of Line Department posted
2. In a significant number of instances, data was found to be available at the Subdivision or District level, but SDM office or DM office functionaries were not present during the exercise as a result of which validation was not possible from their end.
3. In a few instances the respective department is having the data at the level of District and Subdivision but not at the level of GP. For instance, information from NHFS, banks, Aadhaar, etc.
4. Inadequate recordkeeping at the Gram Panchayat level with special reference to other Line Department .
5. The presence of identical data at various levels and in different formats.

Feedback on PDI Portal

1. Data Verification Office:
 - Block Level Office
 - Requirement: Edit Option
2. Field Level Office:
 - Field Level Office
 - Requirement: Edit Option
3. Data Source Registers:
 - Data Source Register/ Records
 - Requirement: Edit Option
4. Data Auto-Porting from various portals
 - Requirement: Provision to add fresh data for all the Indicators
5. Requirement of District/ Block/ Panchayat– wise reports.
6. Option of report should be there to track the performance of Panchayat



Institutional Mechanism for Validation

1. Constitution of a Block Level Committee consisting of all the relevant Line Departments headed by the Block Development Officer of that concerned block. When required, the District Level Officials will also be included in the committee.
2. District wise workshops will be conducted to train the Block Level Committee on their roles and responsibilities. The ADM & Collectors will be assigned to coordinate the whole process.
3. After the collection of the data, the same will be placed before the committee for validation.



Plan of Action for Rolling out PDI in the State/UT

1st

- A State Level Steering Committee will be formed under the Chairmanship of the CS, Tripura. Including all other Principal Secretaries/ Secretaries/ DGP– Selection of Departmental Nodal Officer.
- Subsequently, One Day State Level Workshop will be conducted with the key officials of relevant Line Departments, Panchayat, Districts, and other stakeholders for finalization of data points.

2nd

- After the finalization of the data points at the State Level, One Day State Level Workshop will be conducted with the DLMTs for rolling out of PDI.
- The District Wise Workshops will be conducted for the training of all the facilitators. (1 facilitator per GP)

3rd

- A time span of two months will be given to all the stakeholders for uploading the authenticated data of PDI.
- The progress of data collection will be monitored at the State level on a fortnightly basis.

Request to the Ministry

1. To depute experts for State level workshops.
2. The whole exercise will be conducted a fresh not taking into consideration of other survey etc, hence, the information of MA survey may not be auto-populated.
3. Honorarium of the Surveyor may be ensured from the end of Ministry for timely completion of the PDI.
