Institutional Mechanism for Validation

1. Capacity building & Training – SIRD with a handholding support from MoPR

2. **State Team-** to supervise data collection, validation/re-validation and finalization of data received from blocks

3. **Block Level Team** -shall correspond, coordinate and receive data from the GPs/ Field officers of other line departments. The Block Level officers will check for data accuracy, quality, validate ad verify.

4. **GP/Village functionaries-** will facilitate/monitor the data collection process, validate and verify before the final approval during the gram sabha
