Challenges in data validation process at GP level

- Line Department Functionaries may not take the ownership for data quality. Intervention of Higher level offices is required.
- Misinterpretation of Indicators at Ground Level.
- Unavailability of Updated Data at GP Level.
- Reluctance in sharing sensitive information at public domain.
- Data Redundancy could be an issue, as there can be more than one source of Data available at GP.



Suggestions in respect of Local Indicators & its data Points (in respect of revision, modification & addition (if any)

- Panchayat Secretary should be responsible to enter the data which is only related to the GP; Other Line Department Frontline workers should take the ownership to enter Data related to their department.
- Sharing of Data from State Specific Portals through API Integration with PDI Portal.
- Many indicators would not have data available at the GP level. For Example- Indicators related to Anaemia, Diabetes.
- Data related to criminal offences would not be available in the public domain and arranging information for indicators like People using tobacco, alcohol etc. would be impractical.
- There should be a provision to add State Specific indicators which are not included in the already provided list.



Feedback on PDI Portal



The data entry should be done by officials of line departments using their MIS system/registers; these provisions should be made in the PDI portal.

Data for some indicators which are using standardize data for example-population-2011 should be fetch automatically in the portal. Re-entering data manually can be avoided to preserve data integrity.

There is no Edit/Delete option for field offices/ data source registers after they are saved once.

Instead of mapping one indicator with the data sources each and every time, multiple indicators having common data sources can be mapped with multiple indicators.

Marking pattern should be at each indicator.



Suggestions in respect of Local Indicators & its data Points (in respect of revision, modification & addition (if any)



- The formulation of many indicators is not clear.
 For example-Total estimated number of eligible women households-Theme-9.
- The sequencing of numerators and denominators need to be corrected and arranged in a proper order. For Example-Theme-9/49.
- There are many repeated indicators within same theme
 Example-No of works implemented by GP-Theme-6
 No of under-5 children, theme-3 & theme-9


