Challenges faced during data validation process at GP level

- 1. No facilitator at Gram Panchayat Level
- 2. Lack of manpower at all levels.
- 3. One GP secy. appointed to multiple GPs
- 4. Unorganised Data Source



Suggestions in respect of Local Indicators & its data Points (in respect of revision, modification & addition (if any)

- 1. Data verification offices name need to be rename (not editable)
- 2. Field offices name to be editable
- 3. Facilitator appointed to fill indicator need to save one by one, therefore auto-save option should be enabled.
- 4. For Data entry Facilitator should be well familiar with the process.
- 5. Fix monetary compensation may be declared for facilitators (who aren't employees).



Feedback on PDI Portal

- 1. A comprehensive Mobile Application should be launched.
- 2. "Read- Aloud" option in local language may be enabled for data points.

Institutional Mechanism for Validation

- Line Departmental Committees may be constituted at Block, District and State level for data validation.
- 2. Remarks from Elected representatives (GP, Block & District) may be used for data collection.



Plan of Action for Rolling out PDI in the State/UT

- 1. State, district and block Level Workshop may be organized for launching of PDI
- 2. Dedicated manpower should be identified in each line department for data collection and validation.
