Subject: Approval of Revised Budget Summary of Annual Action Plan 2025-26 of the State of Jharkhand under Revamped RGSA-Regarding.

Madam,

I am directed to refer to your SEC meeting dated 06.11.2025 received from the State Government of Jharkhand, requesting for approval of the Additional Annual Action plan which include the training on GPDP, BDP & ZDP of panchayat functionaries, specialised training related to PAI, EWR and E-Governance, Management Development Programme (MDP), computer and accessories and innovative activity under Additional Annual Action Plan FY 2025-26 during the current financial year under the revamped RGSA scheme.

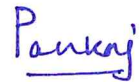
2. Accordingly, the component-wise revised allocation is as under:

- a) **Capacity Building & Training (CB&T):** The amount under the new sub-component '*training for panchayat development*' for 41,344 participants amounting to Rs. 7.98 crore, and the amount under the sub-component '*specialised training*' for 45,167 participants amounting to Rs. 15.38 crore thereby enhancing the overall CB&T component to Rs. 42.48 crore.
- b) **Other Activities-Capacity Building & Training:** The State has requested approval for new sub component Leadership/Management Development Programme (MDP) for 300 participants amounting to Rs.1.50 crore thereby enhancing the overall other activities under CB &T component to Rs. 12.97 crore.
- c) **E-Enablement:** A new sub-component '*Computer and Accessories*' has been proposed, with provision for 2,066 computers amounting to Rs. 16.12 crore.

3. The Revised Budget Summary of the Annual Action Plan 2025-26 of Jharkhand is enclosed at *Annexure-I* for reference and further necessary action.

4. The State Government may take necessary steps for the implementation of the activities in line with the revised approval.
