Subject: Approval of Supplementary (Revised) Training Plan under Annual Action Plan 2025–26 of UT of Ladakh under Revamped RGSA – reg.

Sir,

I am directed to refer to the proposal submitted by the Union Territory of Ladakh **vide letter dated 07.01.2026** regarding revision of the Training Plan under the Annual Action Plan (AAP) 2025–26 and to convey the approval of the Competent Authority for the **Supplementary (Revised) Training Plan** under the Revamped Rashtriya Gram Swaraj Abhiyan (RGSA).

2. The revision has been proposed in view of the non-conduct of Panchayat elections during the current year. Accordingly, the UT of Ladakh has rationalized the approved training activities by removing all trainings involving Elected Representatives (ERs) and by proposing need-based capacity-building trainings for officials, functionaries, SHG members and frontline stakeholders within the approved Panchayat Development framework. It is further noted that only the **number of participants has been enhanced to 10,013**, without any change in the approved financial outlay.

3. The total financial outlay of the approved Supplementary (Revised) Training Plan under the **training component is ₹1,88,46,500/-** (Rupees One Crore Eighty-Eight Lakh Forty-Six Thousand Five Hundred only), which is the same as the amount earlier approved under the training component of the AAP 2025–26 and remains within the **overall approved outlay of ₹9.82 crore** for the UT of Ladakh under the Revamped RGSA for FY 2025–26.

4. The Revised Budget Summary of the Annual Action Plan 2025-26 of the UT of Ladakh is enclosed at **Annexure-I** for reference and further necessary action.
