With its roots in the rich history and culture of our Nation, the Panchayati Raj System fortifies the basis of Indian democracy, which has further been strengthened by the 73rd Constitutional Amendment Act and subsequently adoption of Panchayats Extension to Schedules Areas (PESA) Act 1996 that accorded constitutional status to the Panchayati Raj system in the Country. With the passage of nearly three decades of both the Acts, the Panchayati Raj system has evolved and transformed the decentralised, participatory, inclusive rural local self-governance in the country through the combined efforts of the Union Government and State Governments. However, the devolution to Panchayats, their governance capabilities, resource mobilisation, funding etc. across the States/ UTs have not been even. The level of improvements in local governance, therefore, varies from State to State.

With the aim to provide statistical insights into the progresses and achievements of the status of Panchayati Raj system in various States/UTs, the Ministry has compiled its second edition of 'Basic Statistics of Panchayati Raj Institutions' involving rural local self-government taking into account various parameters and facets of statistics including the financial and physical progresses of schemes and other activities. This publication offers a comprehensive overview of the status of PRIs in India incorporating data on key Panchayat indicators at the level of States/UTs.

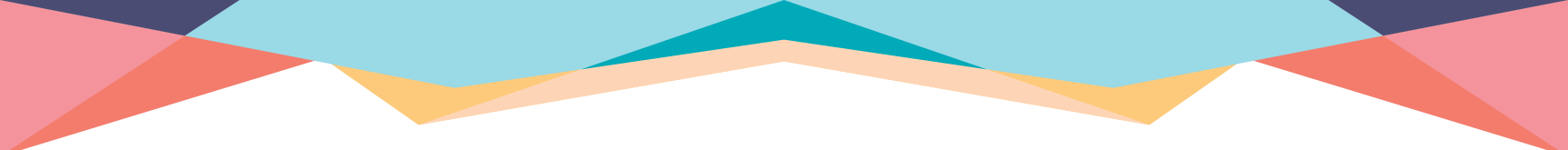

CHAPTER - 1

INTRODUCTION

1. Mandate of the Ministry of Panchayati Raj

- 1.1** The mandate of the Ministry of Panchayati Raj (MoPR), which was set up in May, 2004, is to ensure the compliance of the provisions of Part IX of the Constitution, provisions regarding the District Planning Committees as per Article 243ZD, and PESA. The Ministry's vision is to attain decentralized and participatory local self-government through Panchayats, or Panchayati Raj Institutions (PRIs). The Ministry's mission is empowerment, enablement and accountability of PRIs to ensure inclusive development with social justice, and efficient delivery of services.
- 1.2** The Ministry works to fulfil its mandate in various ways. Essentially, it plays a strong advocacy role. MoPR fosters knowledge creation and sharing so that the issues to be addressed are clearly articulated, meaningful strategies formulated, and there is sharing within Government as well as with non-Government agencies and experts. It also provides technical assistance and facilities cross-learning across States. In the light of recent changes in policy and to take advantage of the emerging opportunities, the Ministry has repositioned itself with basic changes in its mandate.

2. Constitutional Provisions Regarding Panchayati Raj

- 2.1** Part IX of the Constitution of India provides for setting up of three tiers of Panchayats (only two tiers in case of States or Union Territories having population less than 2 million): (i) Gram Panchayat at village level (ii) District Panchayats at District level and (iii) Intermediate Panchayats at sub-district level in between Gram Panchayats and District Panchayats. It also provides for Gram Sabha (general assembly of registered voters who reside in the area of Gram Panchayat) as a forum for direct participation of villagers in local governance.
- 2.2** The Constitution of India has fixed five-year terms for these Panchayats and has made provision for the reservation of seats for Women and marginalized sections (Scheduled Castes and Scheduled Tribes) of Indian society. While reservation of Schedule Castes (SCs) & Schedule Tribes (STs) is in proportion to their share in population, that for women is at least 33.33%. However, many States have increased the reservation of seats and chairperson posts for women in Panchayats to 50%.
- 2.3** The Constitution of India also stipulates direct elections of all members of Panchayats. For conducting these elections, all States are mandated to constitute a State Election Commission. Also it is compulsory for States to constitute a State Finance Commission (SFC) every fifth year for recommending principles for division of financial resources between State and local governments (both urban and rural). SFCs are to make recommendations to the Governor regarding the distribution

between the State and Panchayats of the net proceeds of taxes, duties, toll and fees etc., the determination of taxes, duties tolls and fees which may be assigned to, or appropriated by, the Panchayats, and grants-in-aid to the Panchayats from the Consolidated Fund to the State, as well as measures needed to improve the financial position of Panchayats.

3. Areas Not Covered under Part IX

- 3.1** While Part IX of the Constitution applies to a vast majority of the country, as per Article 243M of the Constitution, some areas are exempted from Part IX. These include the States of Meghalaya, Mizoram and Nagaland, areas covered under the Sixth Schedule, the hill areas of Manipur and the district level Panchayats in the hill areas of Darjeeling. Various kinds of grassroots local governance structures exist in these areas.

4. Notified Fifth Schedule Areas (FSA)

- 4.1** Article 243M (1) of the Constitution exempts Scheduled Areas and tribal areas referred to in Clause (1) and (2) of article 244 from application of the provisions of Part IX of the Constitution. However, article 243M (4) (b) empowers the Parliament to legislate and extend the provisions of Part IX to Scheduled Areas and tribal areas referred to in clause (1), subject to such exceptions and modifications as may be specified in such law and no such law shall be deemed to be an amendment of the Constitution for the purpose of article 368. Article 244 of the Constitution makes special provisions for the administration of certain areas called “Scheduled Areas” in States other than Assam, Meghalaya, Tripura and Mizoram.
- 4.2** The Fifth Schedule of the Constitution deals with the administration and control of Scheduled Areas as well as of Scheduled Tribes residing in the areas other than States of Assam, Meghalaya, Tripura and Mizoram. “The Provisions of the Panchayat (Extension to the Scheduled Areas) Act, 1996” (PESA), extends Part IX of the Constitution with certain modifications and exceptions, to the Fifth Schedule Areas notified under Article 244(1) of the Constitution. At present, Fifth Schedule Areas exist in 10 States viz. Andhra Pradesh, Chhattisgarh, Gujarat, Himachal Pradesh, Jharkhand, Madhya Pradesh, Maharashtra, Odisha, Rajasthan and Telangana.

5. The Role of States

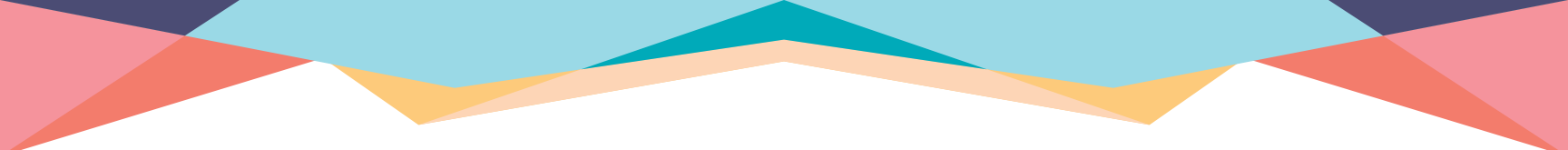
- 5.1** As local government is a State subject, State legislatures have a critical role in determining various aspects of Panchayati Raj in their States. States are keys as far as devolution of powers to Panchayats is concerned. The Constitution envisaged that Panchayats will function as institutions of local government and prepare plans and implement schemes for economic development and social justice, but leaves

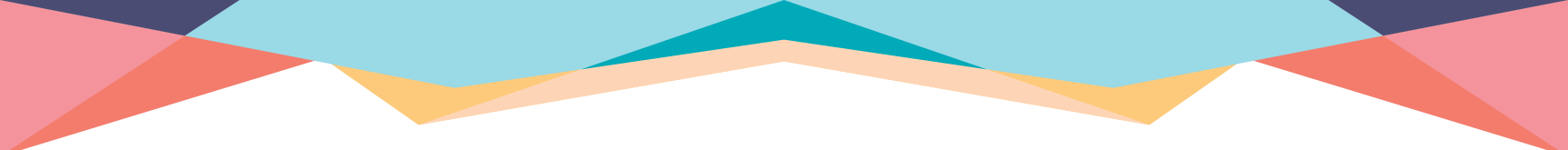
the precise devolution of powers and authority to Panchayats to the States. The State legislatures are to consider the 29 matters illustratively set out in the Eleventh Schedule for devolution to the Panchayats for the planning and implementation of schemes for economic development and social justice. Powers to impose taxes by and provisions of funds to the Panchayats are determined by State. Moreover, States play a critical role in building Panchayat capacities and in creating an appropriate framework for accountability and transparency as well.

6. Eleventh Schedule (Article 243G)

6.1 The functions entrusted to a Panchayat under the Eleventh Schedule to Article 243G of the Constitution are as under:

1. Agriculture, including agricultural extension.
2. Land improvement, implementation of land reforms, land consolidation and soil conservation.
3. Minor irrigation, water management and watershed development.
4. Animal husbandry, dairying and poultry.
5. Fisheries.
6. Social forestry and farm forestry.
7. Minor forest produce.
8. Small scale industries, including food processing industries.
9. Khadi, village and cottage industries.
10. Rural housing.
11. Drinking water.
12. Fuel and fodder.
13. Roads, culverts, bridges, ferries, waterways and other means of communication.
14. Rural electrification, including distribution of electricity.
15. Non-conventional energy sources.
16. Poverty alleviation programme.
17. Education, including primary and secondary schools.
18. Technical training and vocational education.
19. Adult and non-formal education.

20. Libraries.
 21. Cultural activities.
 22. Markets and fairs.
 23. Health and sanitation, including hospitals, primary health centers and dispensaries.
 24. Family welfare.
 25. Women and child development.
 26. Social welfare, including welfare of the handicapped and mentally regarded.
 27. Welfare of the weaker sections, and in particular, of the Scheduled Castes and the Scheduled Tribes.
 28. Public distribution system.
 29. Maintenance of community assets.

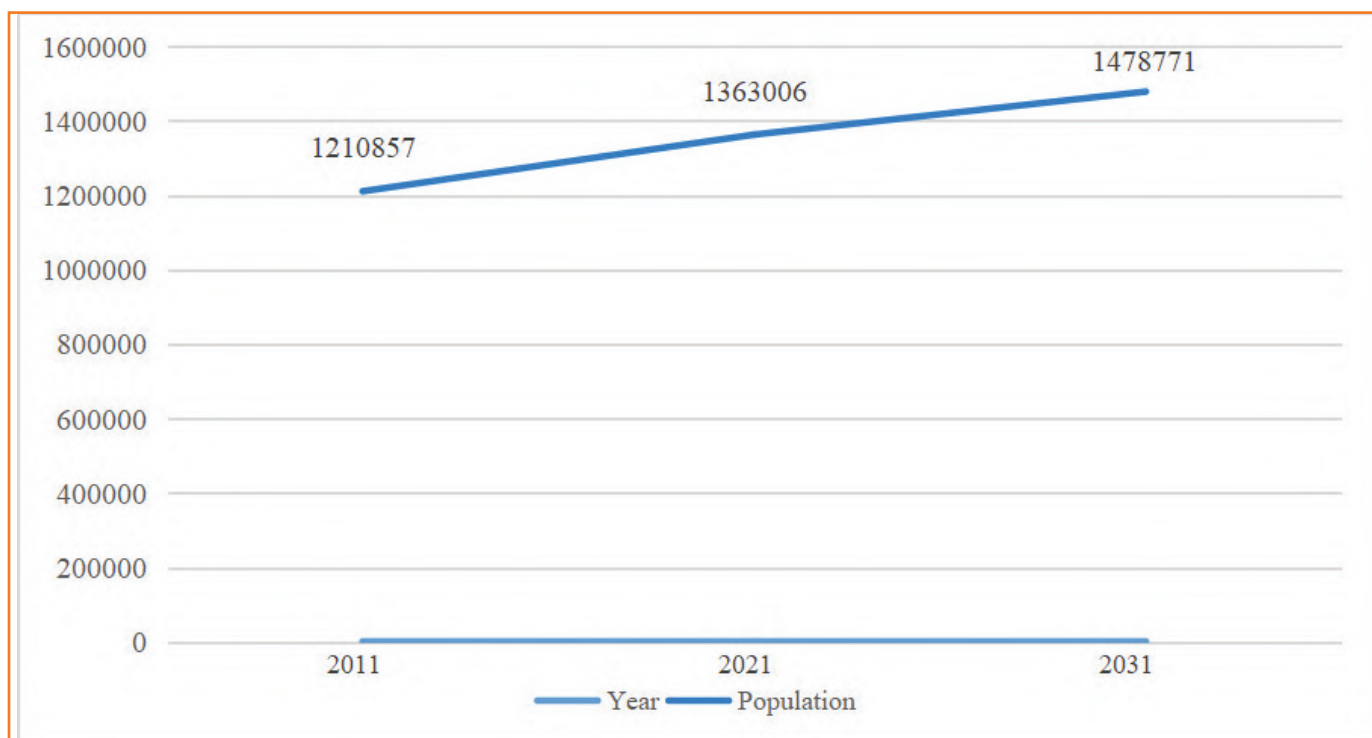

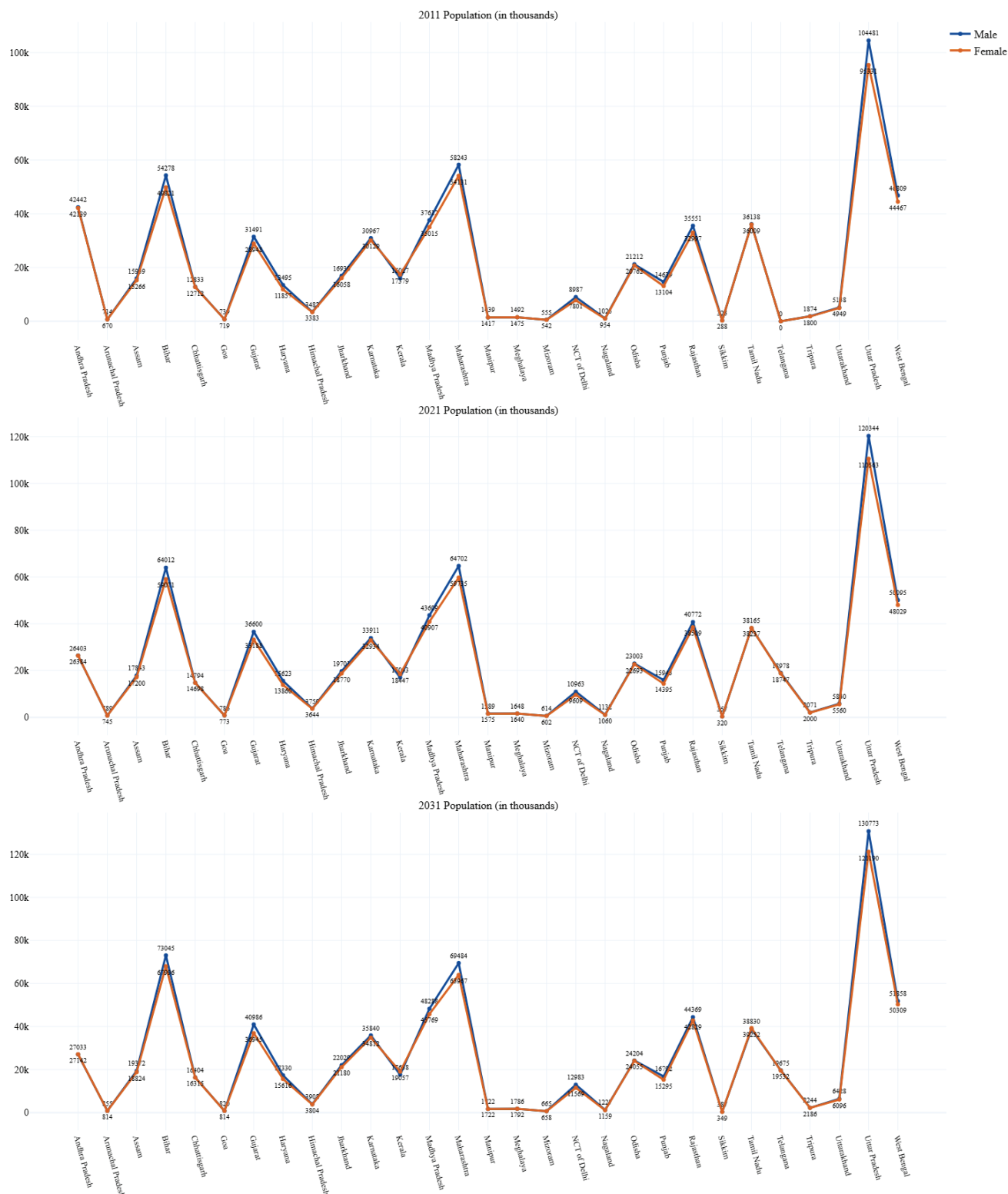

Figure 2.3: Projected National Population by Gender (2011–2031)

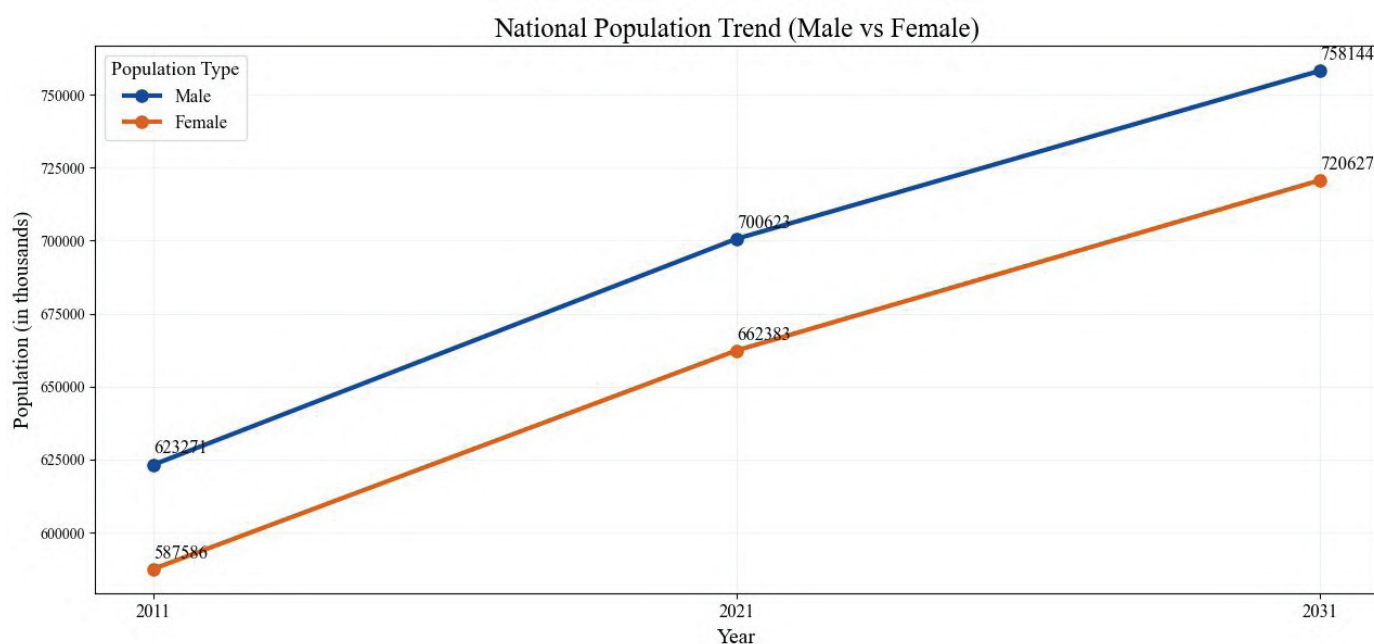
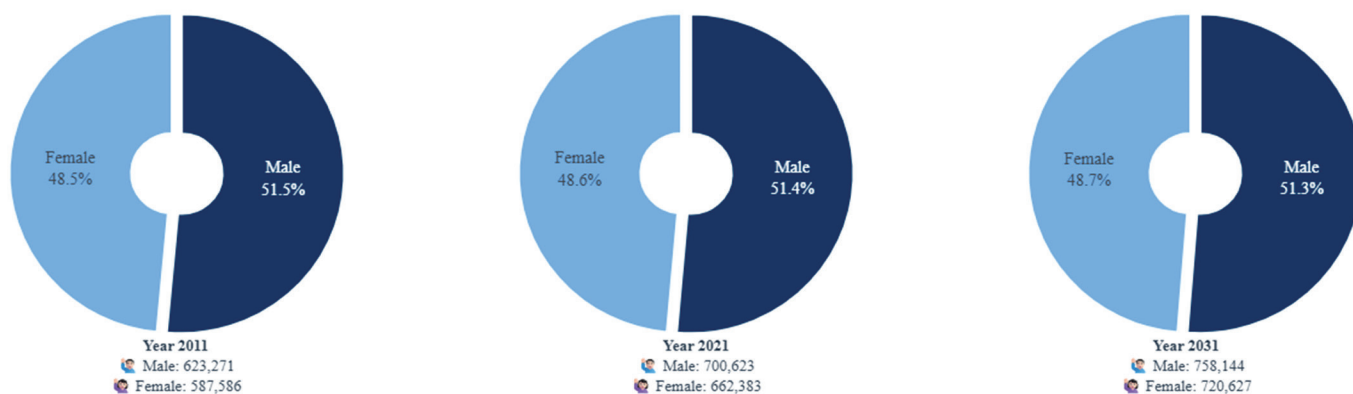


Figure 2.4: Decadal Growth of Total Population in India by Sex

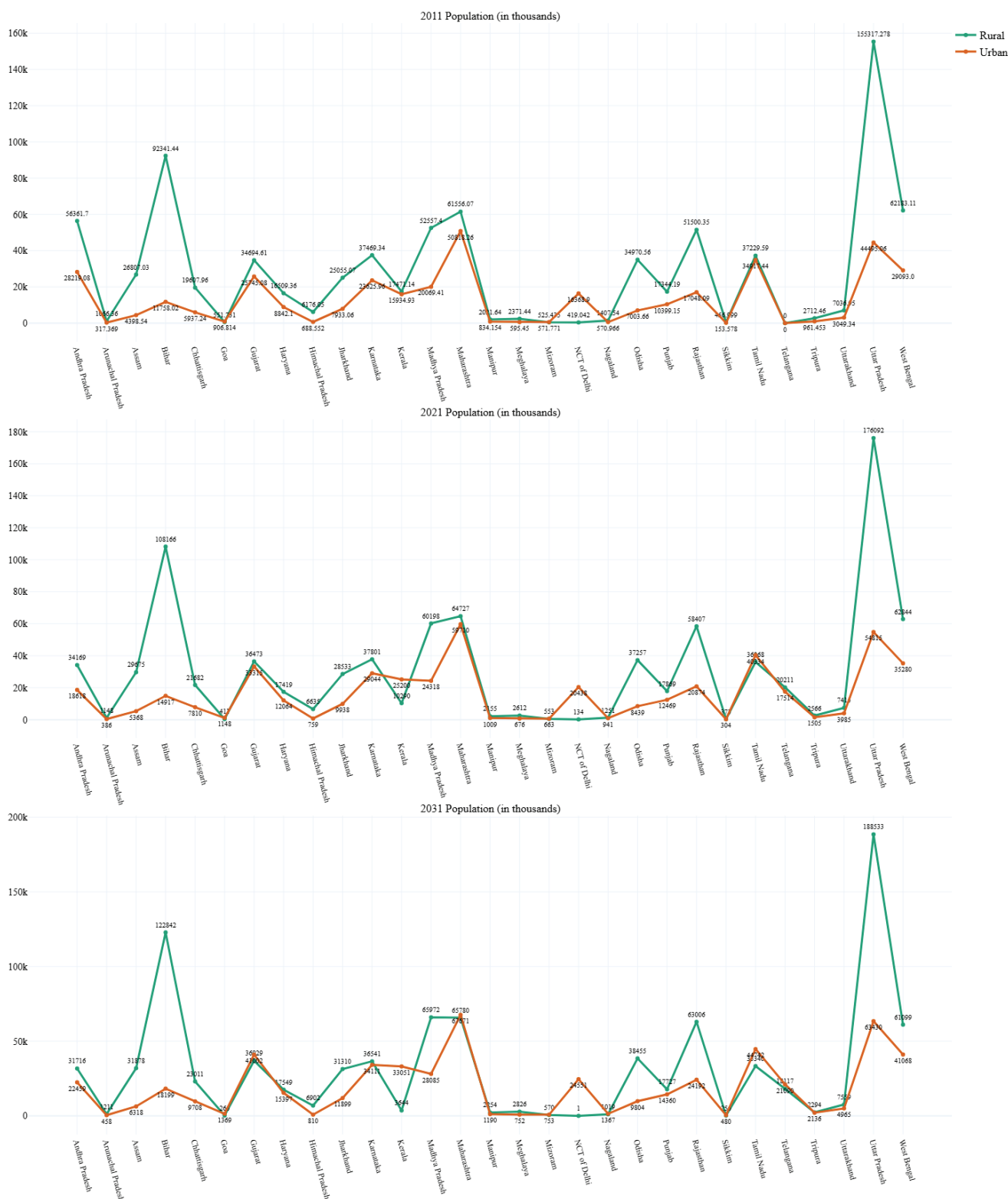

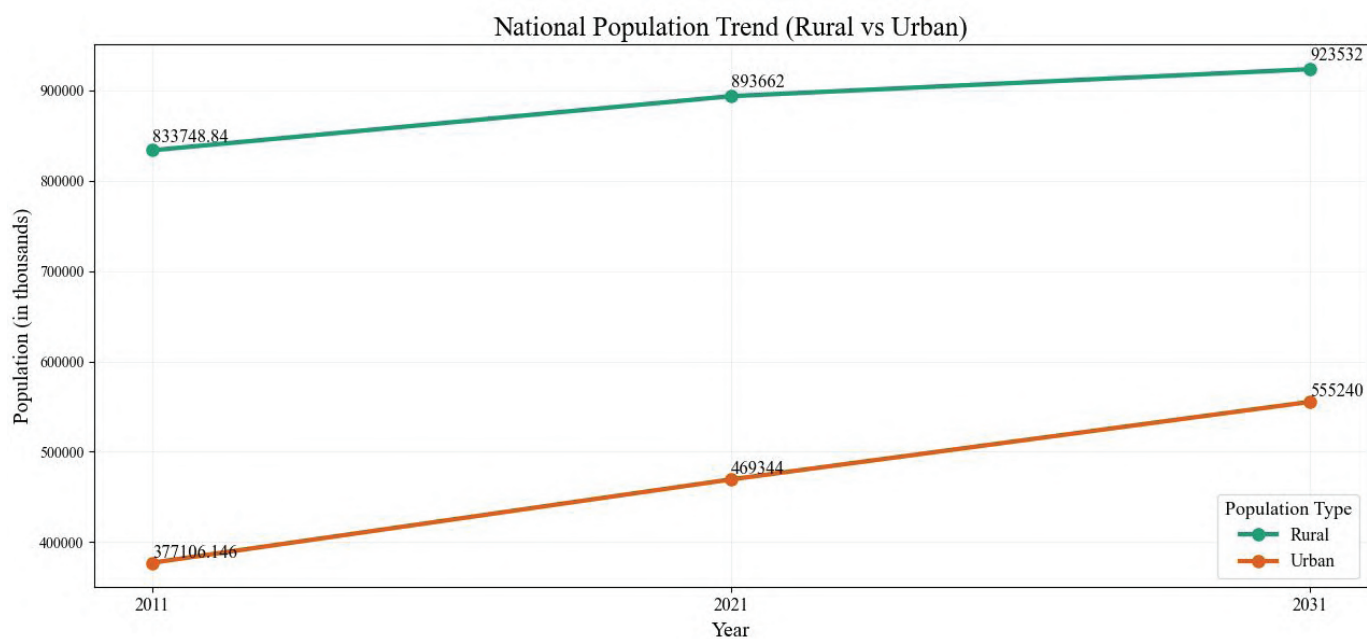
Figure 2.5: Population in India (Rural-Urban): India, States & UTs (in Lakhs)

Rural & Urban Population Across States (2011–2031)

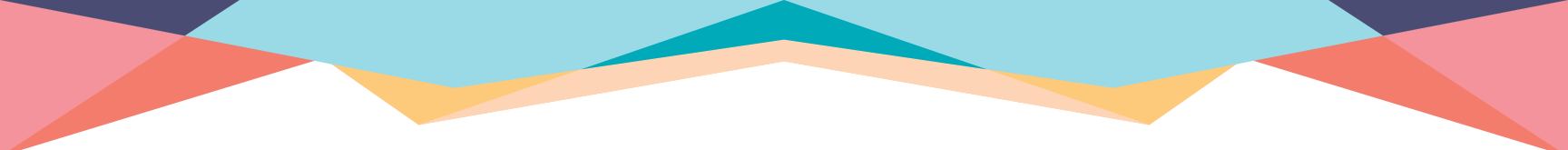

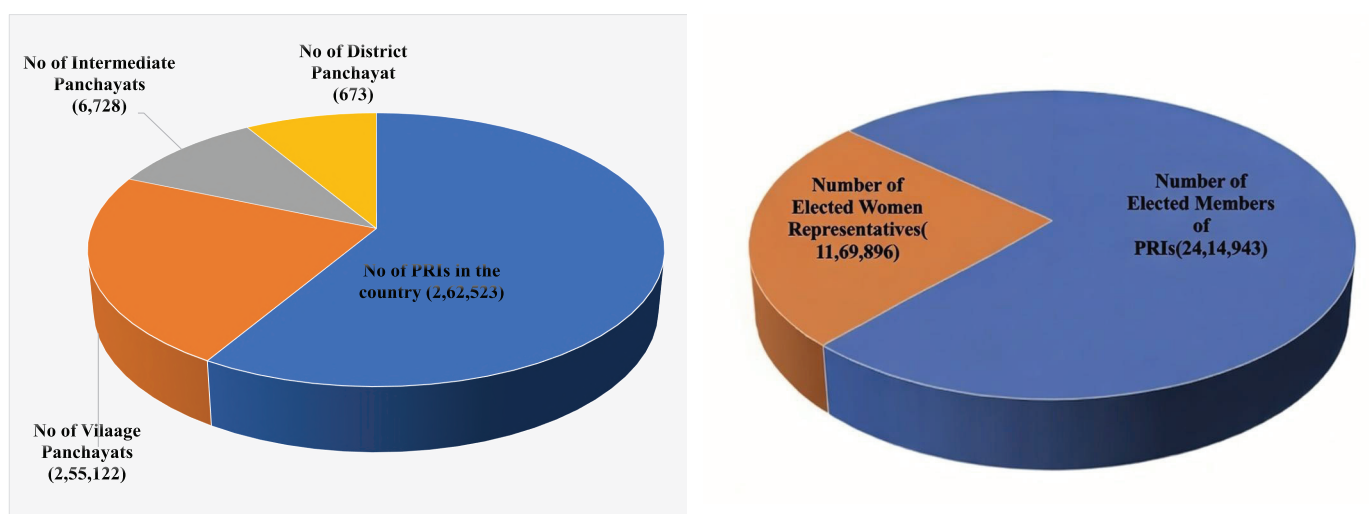

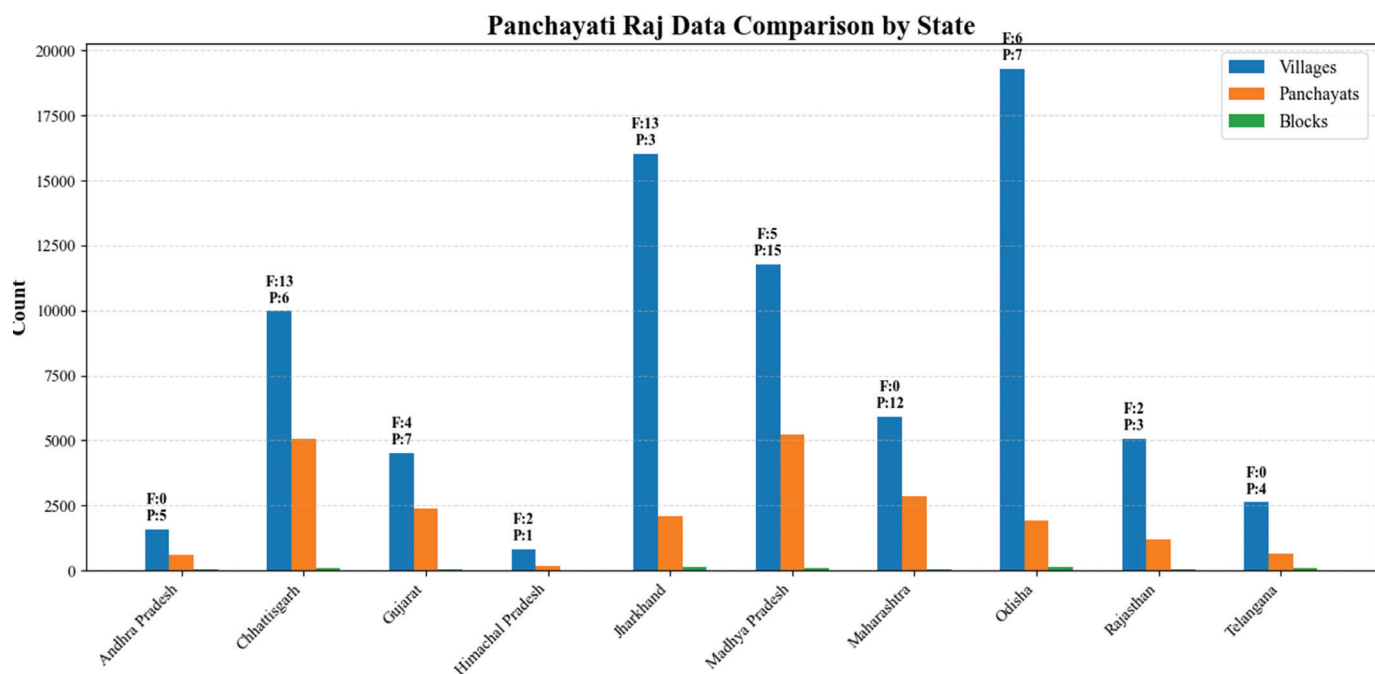

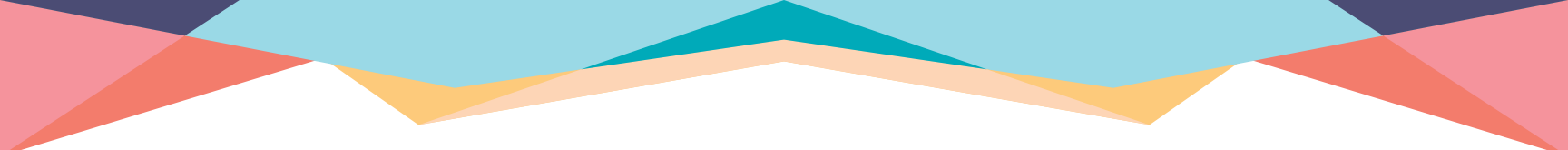

CAPACITY BUILDING

Capacity Building and Training of PRIs and Implementation of Rashtriya Gram Swaraj Abhiyan (RGSA)

Capacity Building and Training (CB&T) of Panchayati Raj Institutions (PRIs) has been one of the major activities of Ministry of Panchayati Raj (MoPR). The Ministry has been providing programmatic, technical, and institutional support for strengthening of PRIs including advocacy support for inter-ministerial and multi-sectoral coordination. A Centrally Sponsored Scheme of **Rashtriya Gram Swaraj Abhiyan (RGSA)** is being implemented with effect from 2018-19 with the primary aim capacity building and training of the elected representatives and functionaries of the PRIs.

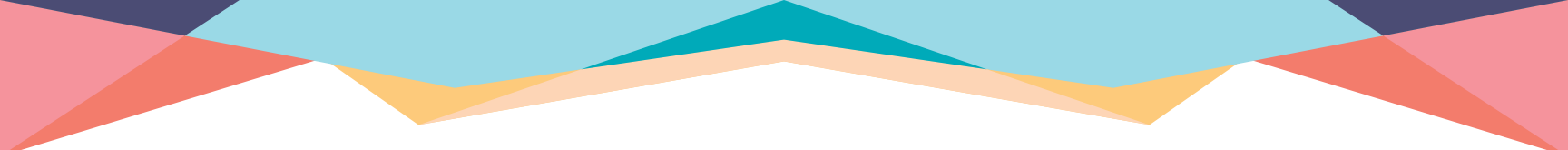

Survey of Villages and Mapping with Improvised Technology in Village Areas (SVAMITVA) is a Central Sector Scheme under implementation since 2020, aims to provide the 'Record of Rights' to village household owners possessing houses in inhabited rural areas after drone survey of the villages. The scheme has multifarious objectives of creation of accurate land records, reducing property-related disputes, facilitating monetization of properties, and enabling bank loans, comprehensive village-level planning etc.

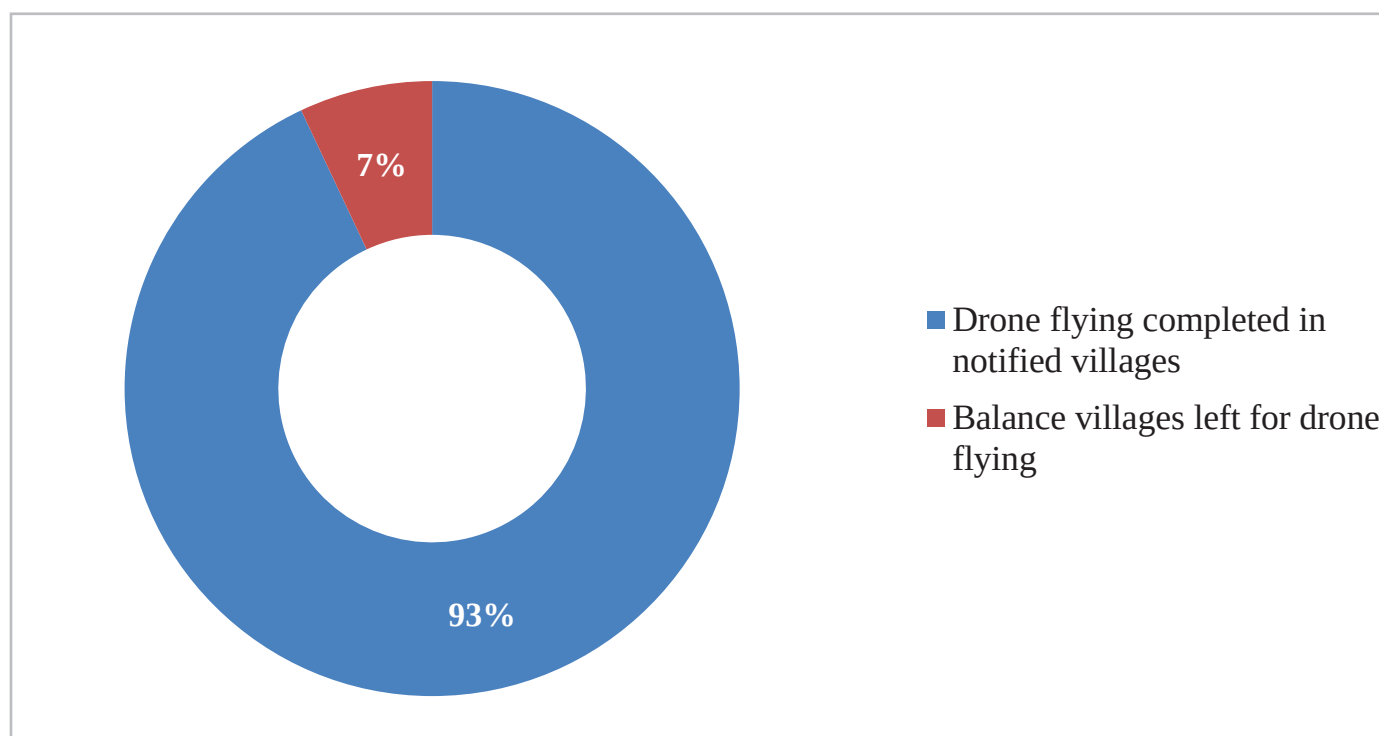

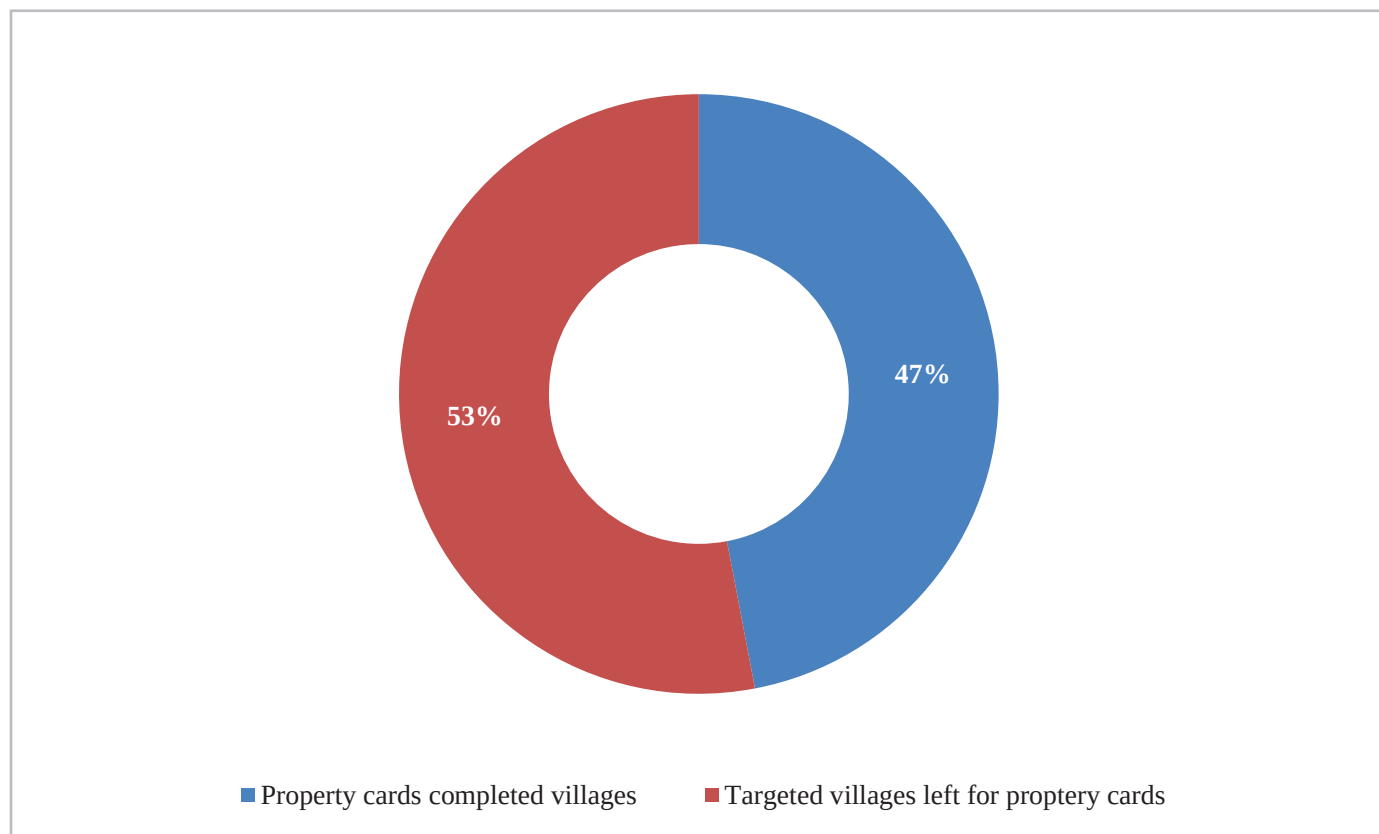

Figure 5.1: Progress of Drone Flying in Notified Villages under SVAMITVA Scheme

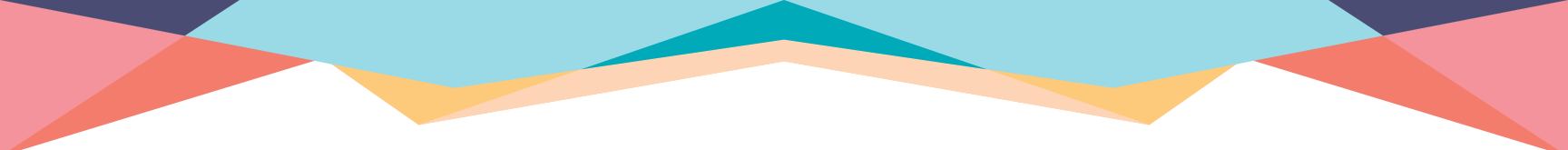

CHAPTER - 6

E-GOVERNANCE/ICT INITIATIVES

E-GOVERNANCE/ICT INITIATIVES

With the objective of transforming the governance landscape by ensuring participation of citizens in policy making and providing easy access to information to the citizens, National e- Governance Plan (NeGP) was introduced in 2006. The vision of the NeGP was to “Make all Government services accessible to the common man in his locality, through common service delivery outlets and ensure efficiency, transparency and reliability of such services at affordable costs to realize the basic needs of the common man.” e-Panchayat is one such Mission Mode Project (MMP) under the Digital India programme of Govt. of India, currently being implemented with a vision to empower and transform rural India. The e- Governance project aims to transform the Panchayati Raj Institutions (PRIs) into symbols of modernity, transparency and efficiency making it one of a kind nationwide IT initiative introduced by the Ministry of Panchayati Raj (MoPR) that endeavours to ensure people’s participation in programme decision making, implementation and delivery. The project aims to automate the functioning of the Panchayats.

1.	e-Gram Swaraj 	e-GramSwaraj (eGS) work-based accounting software, launched in April 2020, that provides a single platform for all planning and accounting needs including various other aspects of Panchayat functioning like monitoring, asset management receipt & expenditure etc. It aims to bring in better transparency in the decentralised planning at Gram Panchayat (GPD), Block Panchayat (BPD) and Zilla Panchayat (ZPD) level, progress reporting and work-based accounting. This application provides the interface to PFMS (eGSPI) for the Panchayats to make online payments viz. expenditure incurred under Central Finance Commission. eGSPI is one of its kind of interface for GPs to make real time payments to vendors/service providers. During April 2023, eGS was integrated with Government e-MarketPlace (GeM) in order to bring transparency in Panchayat procurement. This integration will enable the Panchayats to procure their goods and services through GeM leveraging the e-GramSwaraj platform. eGS was integrated with BHASHINI during August 2024 to provide services in 22 scheduled languages of India through Bhashini's AI-powered translation, making local-language accessibility a reality for users across India. This initiative promotes inclusive participation among Panchayat officials and citizens, improving service delivery and effective operations of Panchayats.
2.	Audit Online 	Audit Online, for transparent auditing of Central Finance Commission funds utilisation and strengthening the financial management of Panchayats, was launched in April 2020. AuditOnline is a configurable platform enabling Government entities to facilitate their internal and external audits and to comply with the Comptroller and Audit General of India's (CAG) defined standards and guidelines. It aids effective auditing by ensuring tracking & monitoring of end-to-end auditing process.
3.	Local Government Directory 	Local Government Directory (LGD) application is the repository of standard location code (LGD code) of all administrative units of the States/UTs. It also provides an online mechanism to update as and when there is any change in the boundary of the administrative units due to creation, delimitation or merger of the units. Objective of LGD is to standardize the location codes across e-Governance applications, ensure interoperability of the data between various platforms, create a common pool of data and thus establish transparency in the system.
4.	Citizen Charter 	Citizen Charter Campaign "Meri Panchayat Mera Adhikar, Jan Sevaayein Humare Dwaar" was carried out from 01st July- 30th September 2021 with an aim to make Local Governments more responsive, by defining the role of Panchayats in the delivery of key services to rural people, giving them the mandate as enshrined under article 243G of the Constitution of India.

5.	 Panchayat NIRNAY	The Ministry of Panchayati Raj has launched a mobile application called “GS NIRNAY,” which stands for National Initiative for Rural India to Navigate, InnovAte and Resolve PanchaYat decisions. The app was launched during the National Conference on Incentivisation of Panchayats cum Award Ceremony on 17th April 2023. The app aims to empower rural communities by providing easy access to critical information discussed during a Gram Sabha, verifying facts, and increasing transparency and efficiency in the functioning of Panchayats. 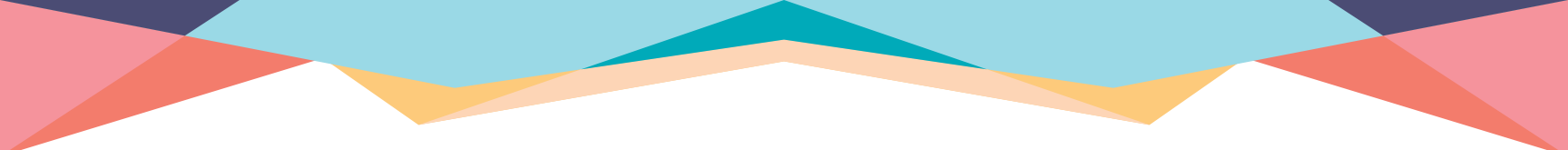

CHAPTER - 7

INCENTIVIZATION OF PANCHAYATS

INCENTIVIZATION OF PANCHAYATS

The Ministry of Panchayati Raj (MoPR) confers the National Panchayat Awards annually to the best performing Panchayats, which motivates them to improve their local development efforts. The awards are usually given on National Panchayati Raj Day on 24th April. These have been revamped and aligned with the Localisation of Sustainable Development Goals (LSDGs) themes since 2023. The awards are categorized into nine themes: (i) Poverty free and enhanced livelihoods Panchayat, (ii) Healthy Panchayat, (iii) Child friendly Panchayat, (iv) Water sufficient Panchayat, (v) Clean and Green Panchayat, (vi) Self-sufficient infrastructure in Panchayat, (vii) Socially Secured Panchayat, (viii) Panchayat with Good Governance, and (ix) Women-friendly Panchayat. The awards also include special categories for Gram Panchayats for their performance on climate action, mobilisation of Own Sources of Revenue. Also, Awards for capacity building of the Panchayats are given to the Institutions. The award money under various categories and tiers of Panchayats ranges from Rs.50 lakh to Rs.5 crore.

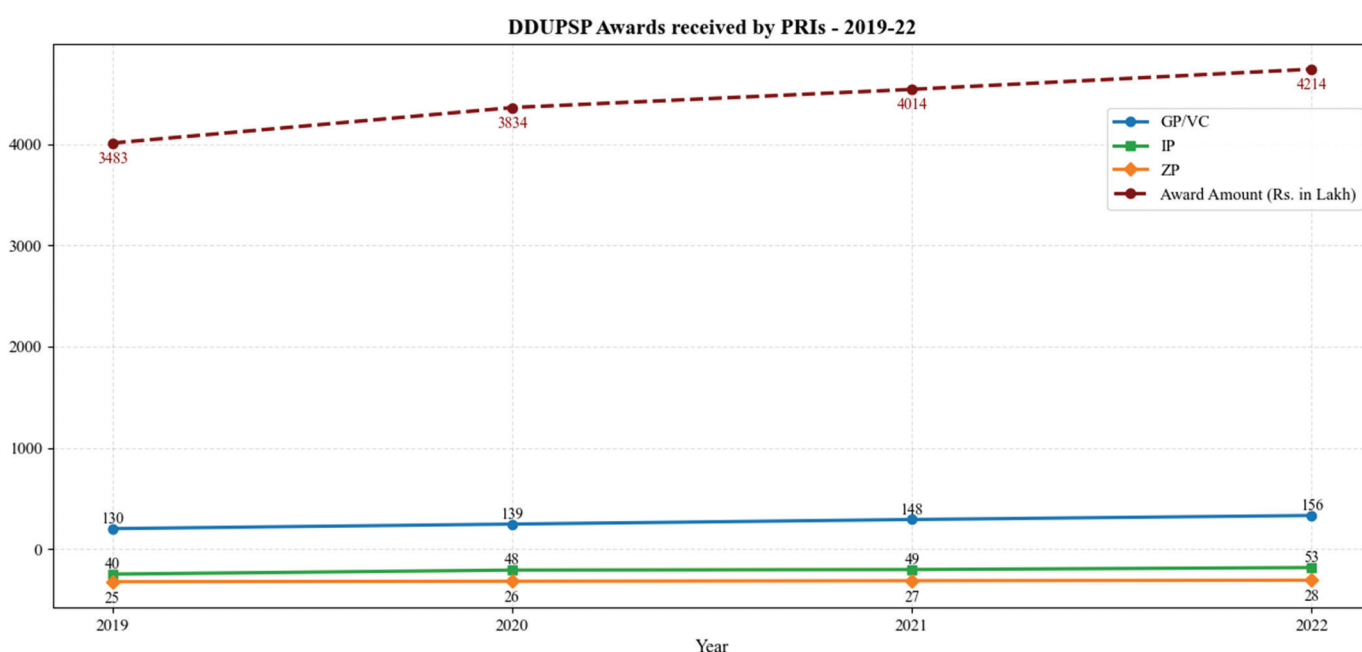

Fig 7.1: DDUPSP Awards received by PRI's from 2019-2022



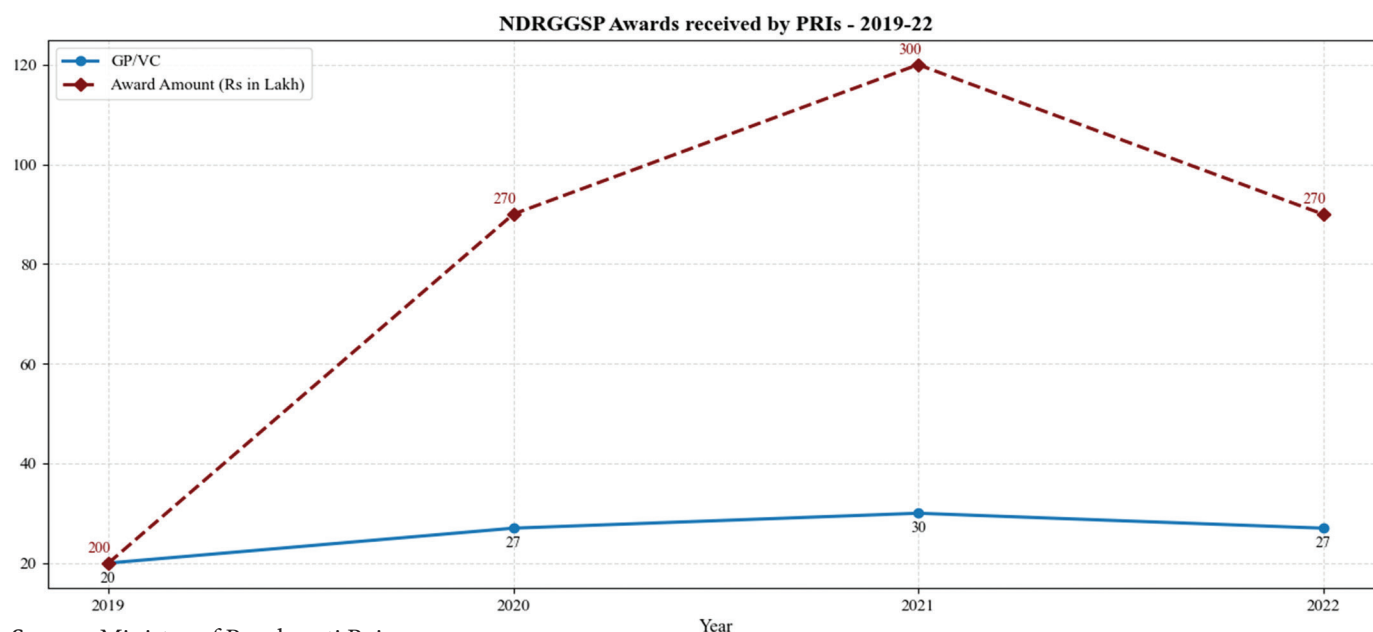

Figure 7.2: NDRGGSP Awards received by PRI's from 2019-2022

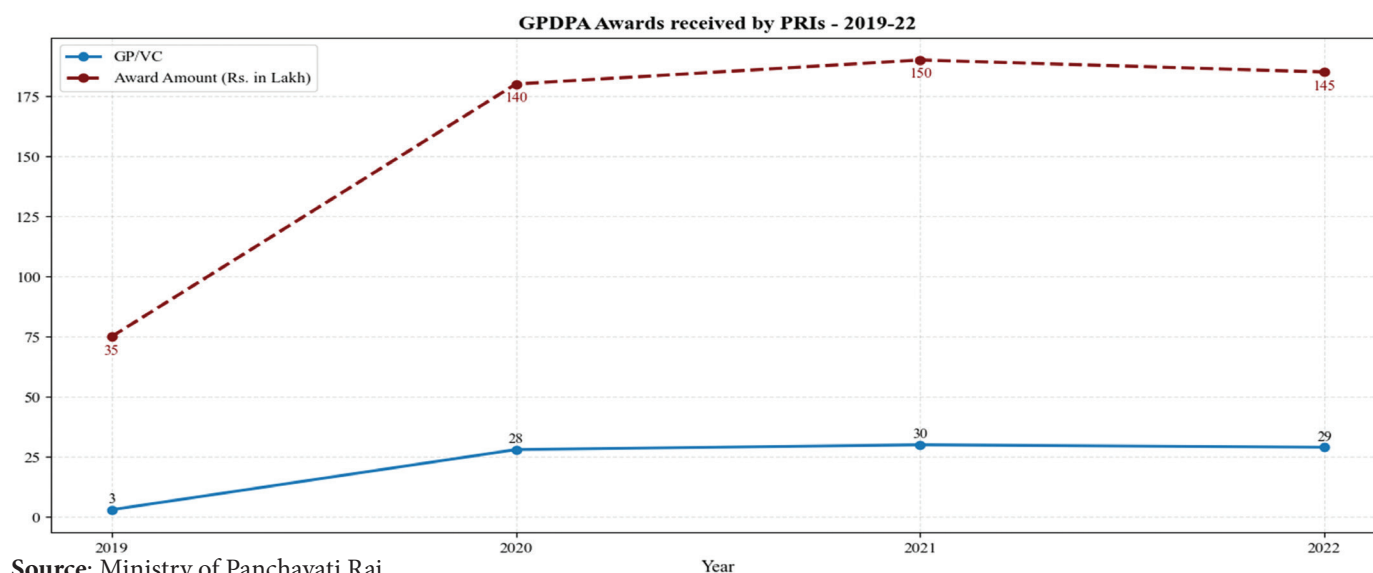

Figure 7.3: GPDPA Awards received by PRI's from 2019-2022



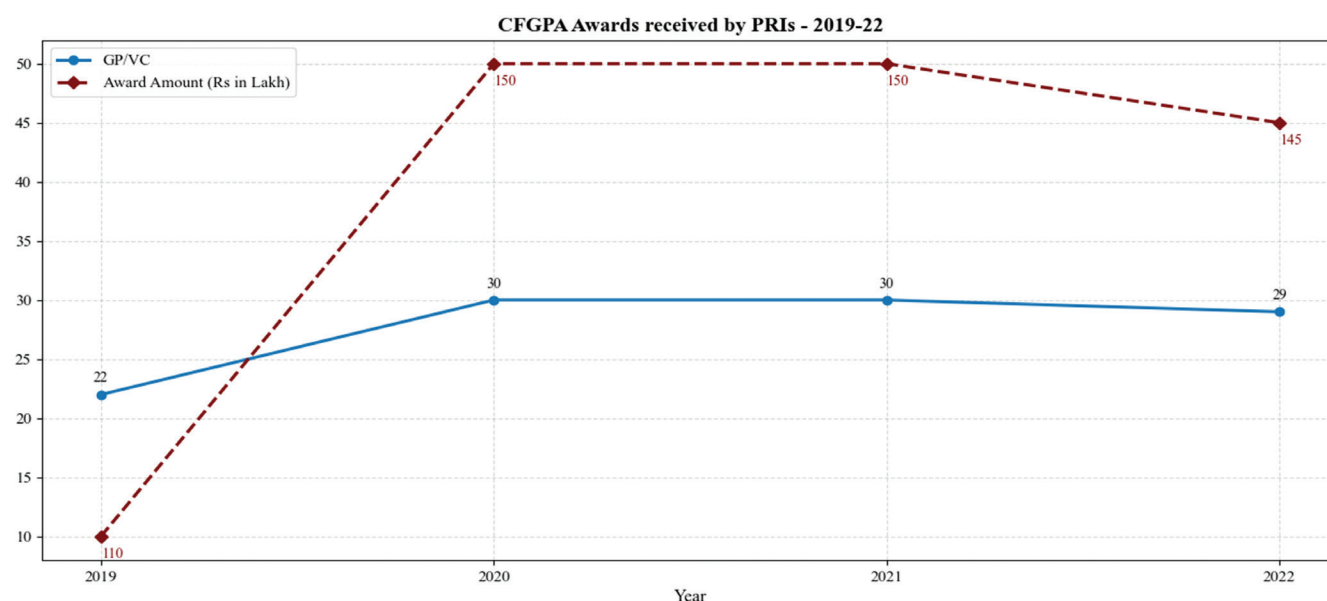

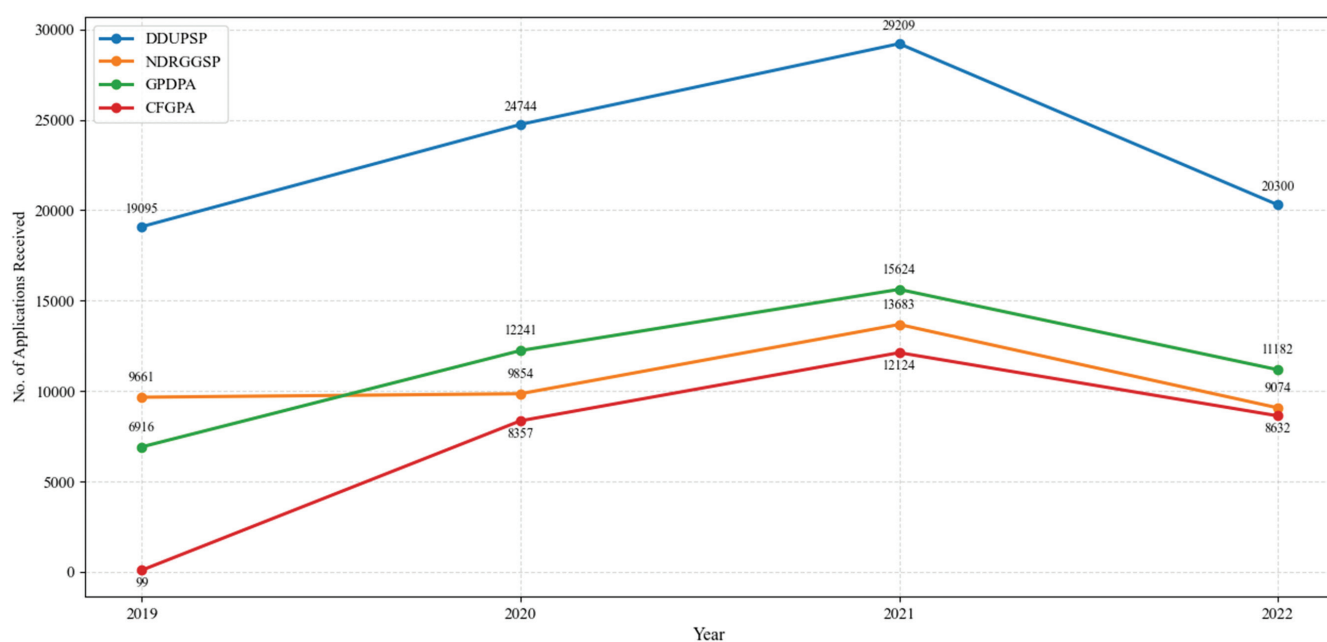

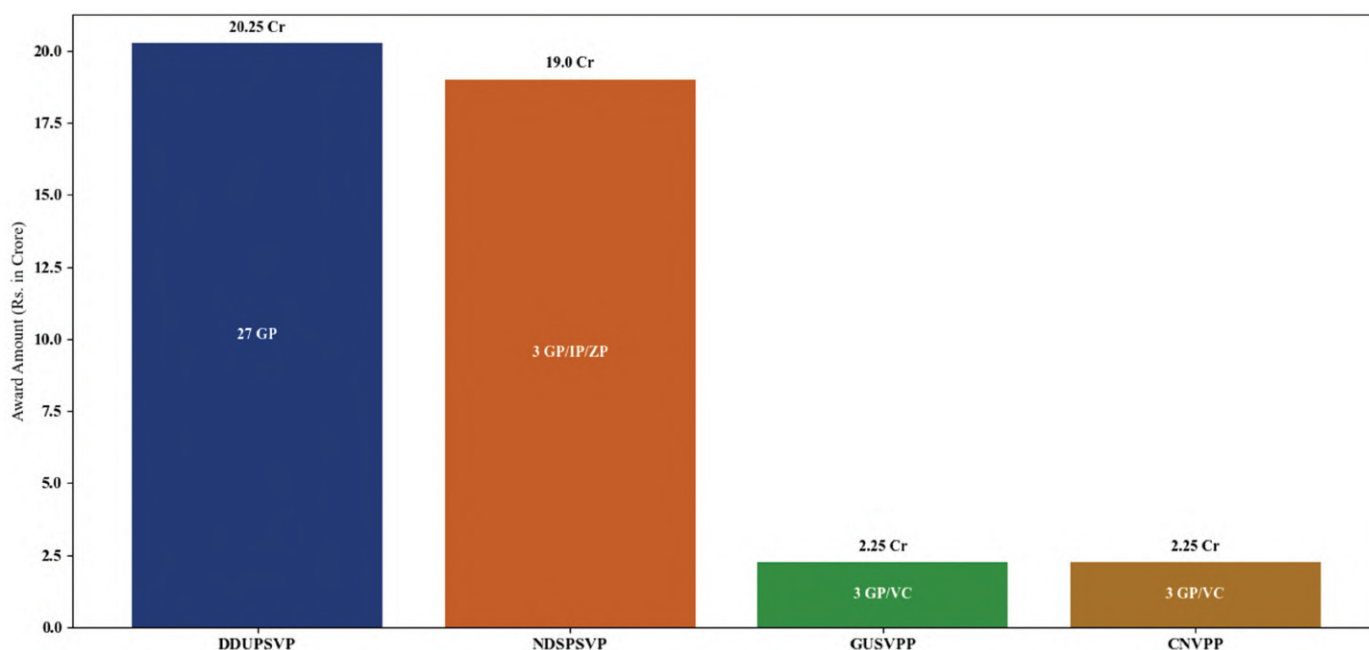

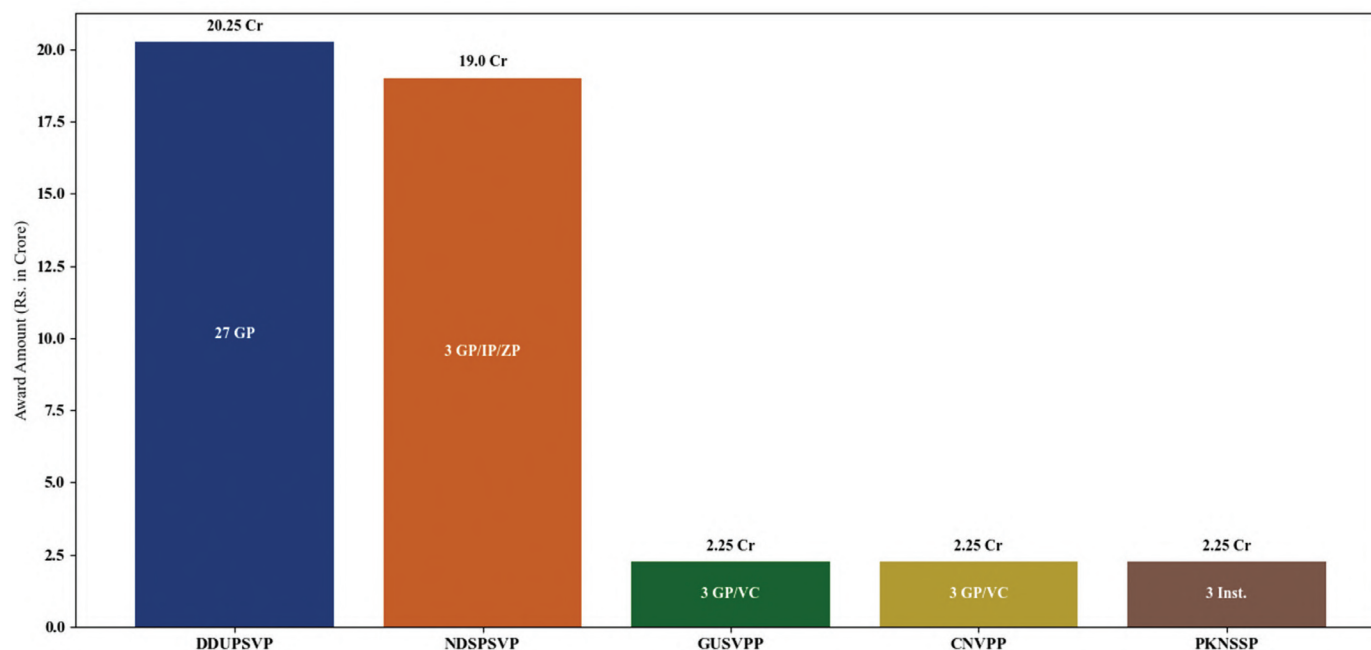

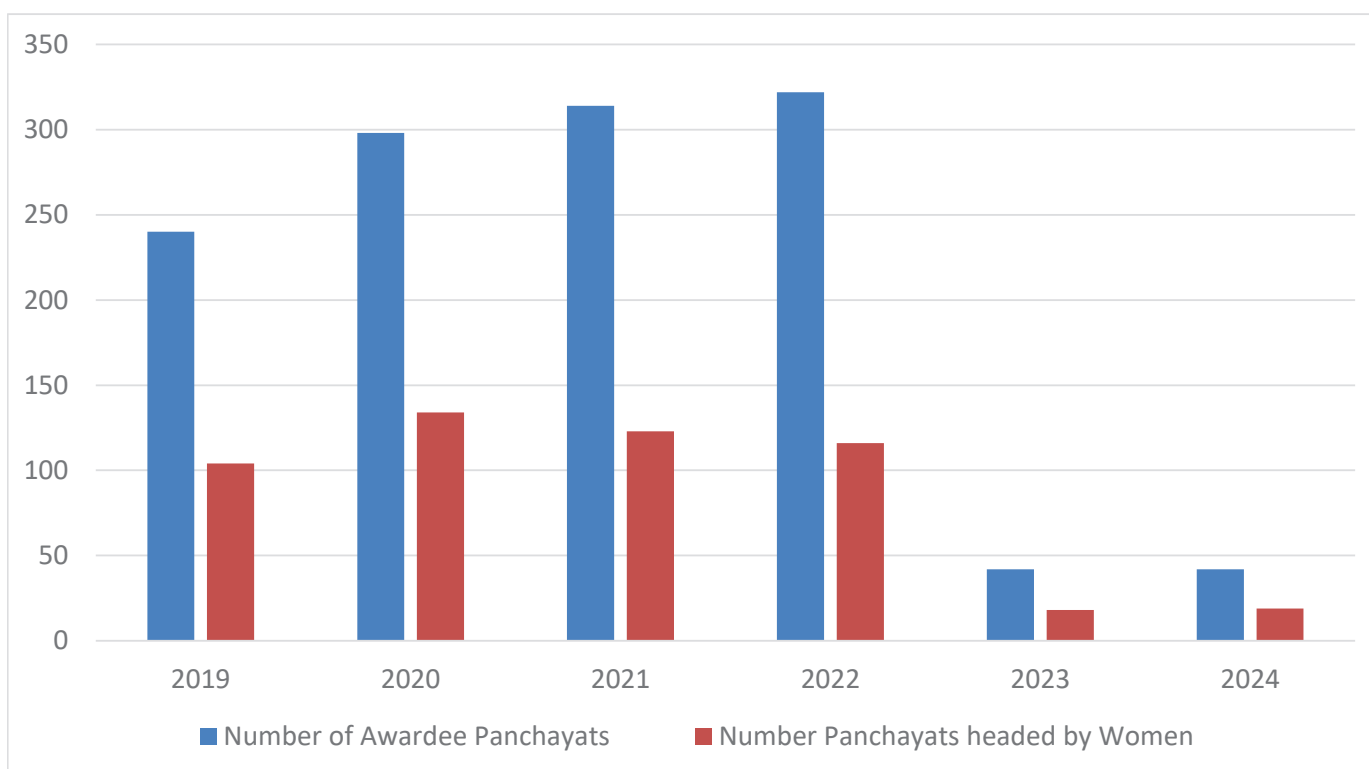

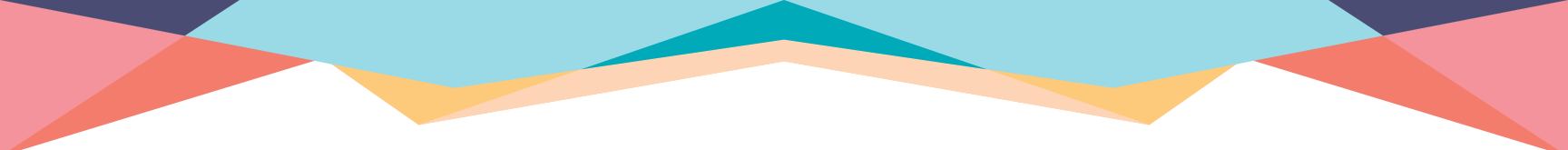

Figure 7.8: Number of National Awardee Panchayats Headed by Women



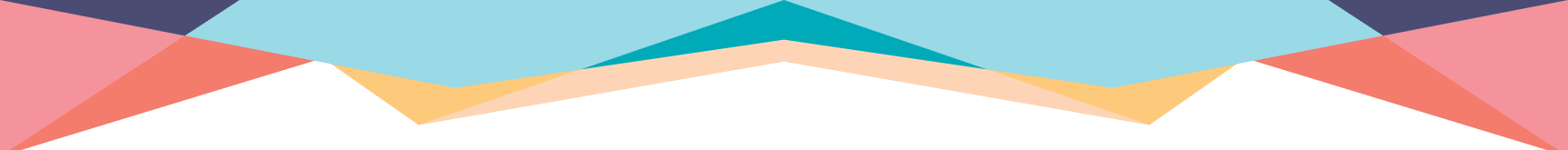

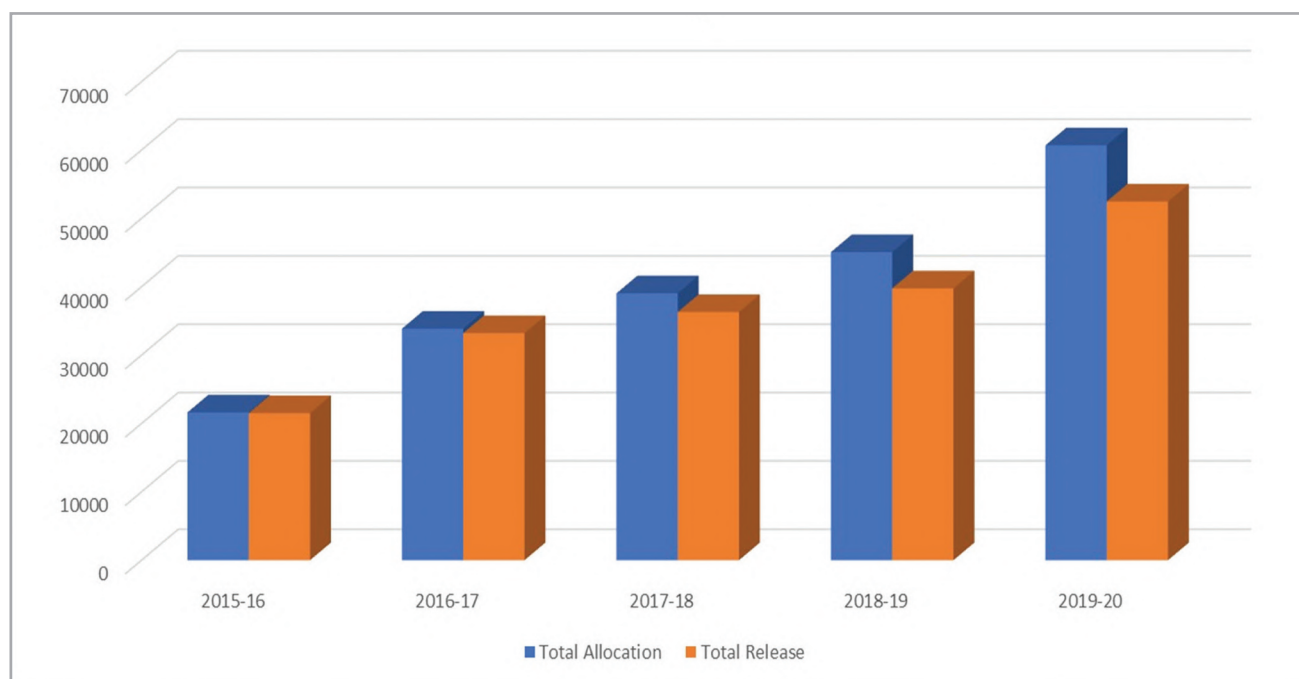

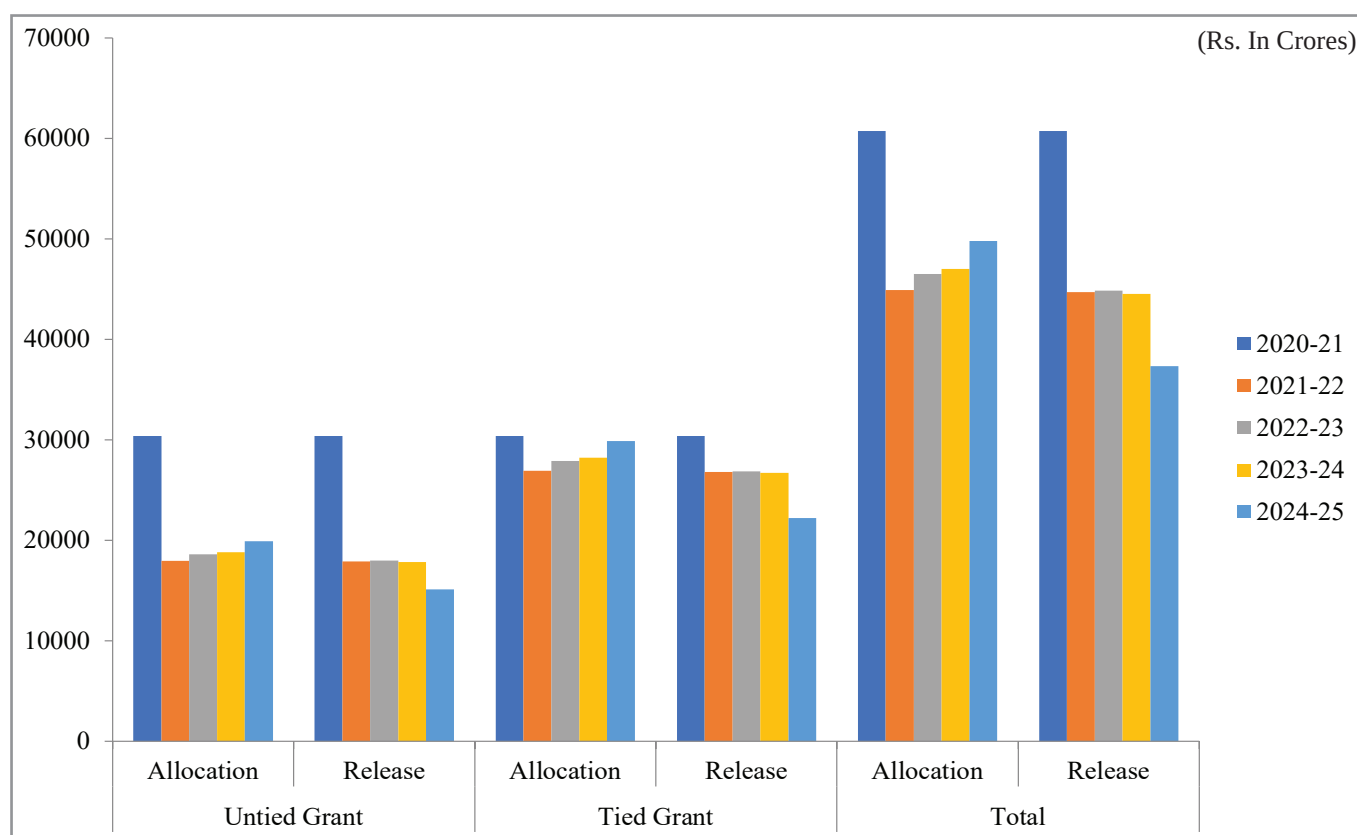

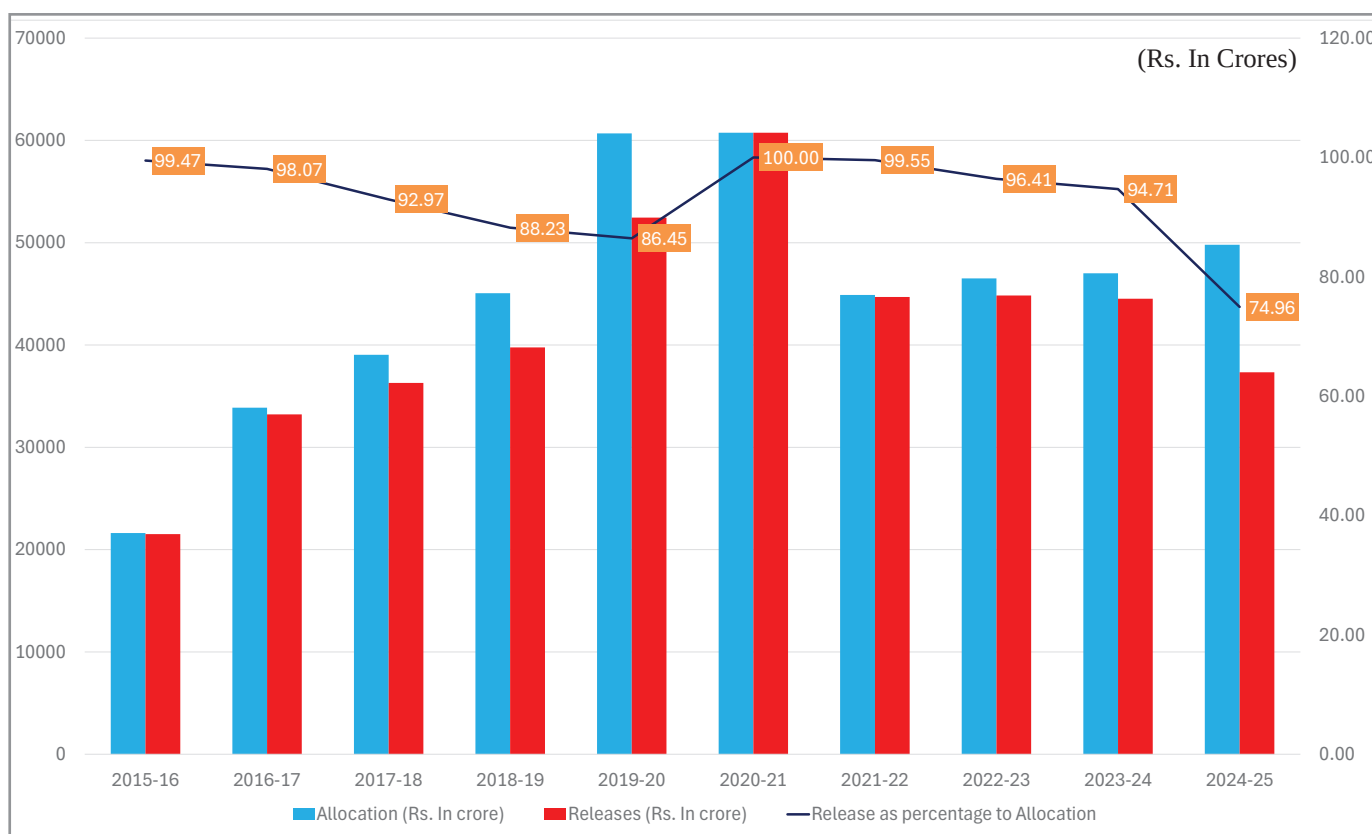
