Subject: - Regarding confirmation for e-KYC, printing and delivery of PVC Cards under CCHF scheme

With reference to the subject cited above and as per meeting held on 01.03.2024 with all 6 card creation agencies, SHA Haryana is in the process of issuing work orders for e-KYC, PVC Card Printing and Delivery of the cards till each State Government office.

Following would be the major scope of work for the card creation agencies

Scope of work	Cost as per NHA	Remarks from SHA
e-KYC of all State Government employees at their respective office	Rs. 5 + GST per successful e-KYC	- SHA will share list of all State Government offices at the HQ level as well as at the district/block level - Only State Government employees are the target in 1 st phase which are 2.63 lakh in numbers and more than 30,000 e-KYC as already done
Printing of PVC Card	- Rs. 11.19 + GST for Zypher and Colorplast - Rs 12 + GST for CSC and UTI-ITSL - Smart IT and MedSave may share their PVC card cost since cost as per NHA O.M is for different zones than North zone	-----
Delivery till each State Government office (no individual delivery)	No cost for this activity as per NHA guidelines	- Card creation agencies will share an official communication with SHA mentioning that PVC cards are delivered as per NHA guidelines of bundling & List of beneficiary - An undertaking will be sought from respective State Government Office that cards are delivered to the intended recipients.


