After considering the report received from DIU, Hisar, the competent authority is of the view that your hospital committed the gross irregularities as mentioned above and it is established that the hospital has grossly violated AB PM-JAY guidelines and applicable laws. Therefore, you are requested to provide a reply through DNO, Hisar regarding same why your hospital should not be de-empanelled from the provider network of AB PM-JAY. You are directed that you will not contact the beneficiaries in question after this showcause notice and nor you shall try to tamper the evidences.

This is without prejudice to all other legal rights and remedies available to SHA for the above stated
