Maharashtra Right To Public Services Act, 2015.

No. RTS-2018/C.R. 145/Astha-5.—Whereas by Government Notification, Rural Development and Water Conservation Department, No. RTS-2015/CR-32/PR-5, dated the 10th July 2015, issued in exercise of the powers conferred by sub-section (1) of section 3 of the Maharashtra Right to Public Services Ordinance, 2015 (Mah. ORD. No. V of 2015) (hereinafter referred to as "the said notification"), notified the public services rendered by the Rural Development and Water Conservation Department, through the Grampachayats to the eligible persons, and the suitable time limits for providing such public services, along with the Designated Officers, First Appellate Authorities and Second Appellate Authorities, as specified in the Schedule appended thereto, for the purposes of the said Ordinance;

And whereas, the Government of Maharashtra has received the representation to enhance the time limits for providing certain public services and, therefore, the Government considers it expedient to enhance the said time limits and exclude certain services from the purview of the Maharashtra Right to Public Services Act, 2015;

Now, therefore, in exercise of the powers conferred by clause by sub-section (1) of Section 3 of the Maharashtra Right to Public Services Act, 2015 (XXXI of 2015), and of all other powers enabling it in that behalf, the Government of Maharashtra hereby amends the said notification as follows, namely :—
