I am directed to invite your kind attention to the subject cited above and to say that it has been brought to notice that the official of different departments are straightaway approaching Legal Cell, at New Delhi without first getting the cases allocated to the Law Officers/ Advocates and that too only 2-3 days before the date fixed, resulting in non-filing of written statement/ counter/ additional affidavit etc. well with in time. Due to this practice, even sometimes costs are imposed by the Hon'ble Courts for non-filing of such responses etc. in time. Even the proposals for filing SLPs etc. are straightaway sent to the Legal Cell and in turn the Legal Cell at Delhi send these cases to office of Advocate General, Haryana to get cases allocated to the Law Officers, resulting in unnecessary delay in filing the cases within limitation.

Now, the Government has decided that the cases to be filed/defended before the Hon'ble Supreme Court/ Delhi High Court/ NCDRC and District Courts at Delhi etc. may be first got allocated to the Law Officers/Advocates from the office of the Advocate General, Haryana and there after the same will be referred to the Legal Cell, Haryana at New Delhi for filling/defending the same on behalf of respective Departments/Boards/Corporations/Autonomous Bodies etc.

This may please be brought to the notice of all concerned for strict compliance.




