Liberalization of delegation of powers with respect to advance and reimbursement of Medical Claims of Haryana Government employees/pensioners and their dependents.

Sir/Madam,

I have been directed to refer to Haryana Government, Health Department letter No.2/24/2013-IHB.III dated 25.08.2014 on the subject mentioned above and to state that the Government has decided to examine the matter again and after careful consideration it has been decided to further liberalize the delegation of powers with respect to Medical Advance and Reimbursement of Medical Claims of Haryana Government employees/pensioners and their dependents which is explained as under:-

a. Reimbursement of Medical Claim.

3. This decision will be affective from the date of issue of this letter.


