ORDER

Sh. Bhim Singh working as Clerk in the office of District Food & Supplies Controller, Karnal has made request for change of his cadre from Sub-Offices to Directorate Office due to his personal/domestic circumstances. In this regard he has also submitted an undertaking stating therein that he will not claim the seniority of his past service rendered in Sub Offices and he will also not claim the lien in Sub Offices. Keeping in view of his domestic & family circumstances, the matter regarding change of his carde from Sub-Office to Directorate Office has been decided by the Comptetent Authority and he is hereby allowed to join at Directorate Office by transferring his cadre from Sub-Offices to Directorate Office and posted at Chandigarh against the vacant post of Clerk.

- 2. The seniority of above official will be fixed below all the Clerks who are already working at Directorate Office. However, his pay will be protected accordingly as per Haryana Government instructions.
- 3. It is made clear that his services will henceforth be governed under the Haryana Food & Supplies Department Directorate (Group-c) Service Rules, 1982 from the date of his appointment by transfer in the above mentioned at Directorate Office and accordingly he will be treated as junior most in the cadre of Clerks working at Directorate Office.
- 4. It is further made clear that he ceased to have any right/claim in the seniority and lien and/or other benefits for the service rendered in Sub Offices.
- 5. The other terms and conditions of his promotion order dated 09.02.2012 issued under Endst. No. 32/1/2007-5E(1)/310-A/RA dated 09.02.2012.
- 6. No TA/DA & joining time will be admissible to him.
