Fixation of rents for hiring the godowns, plinths, platforms of private

parties and the state agencies.

Please refer to this office letter no. SB-3-2009/7140, dated 26-03-2009 on the subject cited above.

It is informed that Govt. has decided to revise the rents for hiring godowns, plinths, platforms, sheds etc. of private parties as well as of state agencies for the storage of foodgrains. The revised rates have been fixed as under:-

Sr. No.	Type of plinths / godowns	New rate of rent
1 100	Kucha plinths / platform with tiles / phar	30 p per qtl. per month
2	Pucca cemented plinths / platform	45 p per qtl. per month
3	Pucca cemented plinths / platform (for NCR)	50 p per qtl. per month
4	Shed	45 p per qtl. per month
5	Godowns	90 p per qtl. per month
6	Open plinth of HSAMB	45 p per qtl. per month
7	Covered godown of HSAMB	90 p per qtl. per month
8	Covered godown of agencies except HWC / CWC	90 p per qtl. per month

These rates will be applicable w.e.f. 01-04-2012.

### Rent of godowns of HWC and CWC:

The storage charges shall be paid to HWC and CWC on the pattern / rates of FCI for the storage of foodgrains stored in CWC / HWC godowns by them. These rates will be applicable w.e.f. 01-04-2012.

## Extension of time period of plinths under three years guarantee scheme and revised rates :

The guarantee period of the plinths under three years guarantee scheme is extended for another one year w.e.f. 1-4-2012 whose guarantee period has expired on 31-3-2012 and the rent shall be paid to them @ Rs. 7/- per MT per month w.e.f. 1-4-2012.
