No.13/3SB (1)/2017/2178 In pursuance of the provisions of the Provincial Reserve Manual and in supersession of instructions issued vide Memo No. SB-5-85/26179 dated 11.08.1985, SH-General-85/37290 dated 09.12.1985, SH-Gen-89/2266 dated 19.01.1989 and SH-Gen-2008/17767 dated 15.07.2008, the Governor of Haryana is pleased to notify the fixation of norms for Recovery of loss due to shortage in stock & stock articles, damage of stocks, less storage gain and shortage in Custom Milled Rice, as given below from the date of publication of this Order:-

#### 1. In case of shortage in stock & stock articles:-

- 6. In case the time of handling over/taking over of charge in the event of transfer or otherwise if any shortage is detected, immediately suitable action should be taken by DFCS&CAC to complete the shortage on the spot. If the defaulting official does not complete the shortage within 10 days after detection, FIR should be lodged with concerned Police Station against the official and copy of the FIR should be sent to Hqrs. for further necessary action. The official under transfer should not be relieved unless he did hand over the complete charge of his stocks, stock articles and official record.

In case the shortage is detected at the time of Physical Verification or at the time of special checking by senior officers, similar action should be taken as explained above in the previous para.

8. In case the custodian is on superannuation, the charge of PR Centre should be handed over to other official before six month of superannuation.

This order will come in force with effect from the date of issue.
