**Subject: - General instructions/guidelines for the Kharif Marketing Season (KMS) 2017-18.**

This is in-continuation of this office memo No. RP-02-2017(Milling Policy KMS 2017)/ 18521-18524 dated 15.9.2017 and may be treated as part of the Kharif Procurement Policy 2017. The Government extends price support to paddy and bajra through State Procuring Agencies and the Food Corporation of India (FCI). All the food-grains conforming to the prescribed specifications offered for sale at specified mandis and purchase centers are procured by the procurement agencies at the Minimum Support Price (MSP). In the last few seasons it has been observed that State Food Department and its procurement agencies has suffered few loss on account of undelivered CMR/embezzlement by the Rice Millers/arthias in connivance with the staff of procurement agencies. Therefore the following decisions have been taken to plug the loop-holes in the existing system.

1. Proceeding of District Milling Committee meeting shall be forwarded to Director Food Civil Supplies & Consumer Affairs, Haryana for information.
2. Payment of paddy shall be made after physical arrival of paddy in the rice mills.
3. Physical receipt will be ensured by the concerned inspector/purchaser and payment will be made by the concerned DFSC/DM after his certificate .
4. Weightment of 100% paddy will be ensured before its storage into the rice mills.
5. Agreement with Rice Millers will be executed before 30-09-2017 or before allotment of paddy to the rice millers. Other than the Ist and 2<sup>nd</sup> party to agreement it should be signed by the witness and guarantors.



6. The signature of the rice millers shall be got verified from his banker. The DFSC/DM will ensure that the signature put on the agreement match with the signature verified by the banker.
7. The guarantor to the agreement shall neither be his/her family member nor his/her relatives.
8. The agreement shall be enclosed partnership deed, memorandum of association if company and the registration of firms if proprietorship or partnership.
9. DFSC/MDs will allot the paddy as per milling capacity after verification from documentary evidence in this regard. If no documentary proof is submit by the rice millers about milling capacity then paddy should be allotted equal to the quantity of CMR delivered by that mill in the previous year upto 31<sup>st</sup> march 2017, after approval of District Milling Committee.
10. The District Milling Committee will allot the paddy to the rice millers after going through the previous three years record of the Rice Millers, if the rice millers is doing the work of CMR. In case of the new rice millers his financial position and capability may be examined and should be treated as mill on lease for guarantee.
11. Preference in allotment of paddy may be given in the following orders: -
  - i) Rice millers having own sortex plant and drier and who have completed the CMR before 31<sup>st</sup> March 2017
  - ii) Rice mills who have completed the CMR before 31-05-2017
  - iii) Rice mills who have completed the CMR after extension in the previous season and at the end Rice Mills on lease.
12. CCTV cameras will be installed at the Entry/Exit gate of Rice Mill.
13. Direct payment to the interested farmers should be made after approval/consent of the concerned arthias.
14. Compliant redressal centre should be opened in every mandi/purchase centre by the market committees and at least five moisture meters may kept in this centre.
