Sir/Madam,

The undersigned is directed to refer to Govt. of Haryana 's letter No.-RP-1/2020/2205, dated-29.07.2020 on the above mentioned subject regarding plan for procurement of 75,000 MT bajra during KMS 2020-21.

2. The aforesaid request of State Government has been examined in this Department and the proposal is found to be as per guidelines of GoI for procurement and disposal of coarse grains. Also, FCI vide letter No. $\pi \sigma$.II/5(4)/2016-17/Haryana, dated-21.08.2020 agreed to the proposal of State Government of Haryana and requested this Department to allow it to procure coarse grains. Accordingly, approval of the Government of India is hereby accorded to the procurement of 75,000 MT Bajra with procurement period from 01.10.2020 to 15.11.2020 during KMS 2020-21. The whole procured quantity of the coarse grains is to be disposed of through distribution under the TPDS/OWS within three months from end of procurement period. This approval is subject to the compliance of guidelines issued by this Department vide O.M. No.-7-10/2013-Py-III dated 21st March, 2014 and vide O.M. no. 7-10/2013-Py-III(pt.) dated 26th December, 2014.

3. As regards PCS of coarse grains, State Government is requested to send separate proposal on it to the Jt. Director (FC A/c), Department of Food and Public Distribution at the earliest.

4. For distribution of coarse grains, State Government is requested to send allocation/ distribution plan of the approved quantity of coarse grain to BP-Division of this Department for allocation under TPDS in lieu of rice /wheat. The whole quantity shall be distributed under TPDS (Targeted Public Distribution System)/OWS (Other welfare Schemes) in the State/UT within three months from the date of end of procurement period as per extant guidelines.
