Sub. : Regarding Implementation of Online Payments through eKharid during KMS 2020-21.

As all are aware that the procurement of Paddy during KMS 2020-21 is scheduled to be started from 01/10/2020. It is to inform that eKharid portal has been shifted to ekharid.haryana.gov.in from KMS 2020-21 onward. The procedure for online payments through eKharid portal has also been changed. Now onward, the following procedure is to be followed for online payments:

1. A Bank Account in Punjab National Bank bearing Account **No.3918002100014830** has been opened at headquarter level for transferring the funds from all the DFSCs for improving the funds management.
2. It will be the sole responsibility of concerned Purchaser/IFS/SIFS to verify I Forms after shifting of paddy to the premises of Rice Miller concerned. As & when, I forms will be received on the portal of DFSC, they will immediately initiate the process of transferring the funds in the above noted PNB bank account through treasury. Thereafter, DFSC will approve the I Forms.
3. After transferring the funds, the authorized Officer/Official at headquarter will push District wise **Pay Now** button for transferring the funds in the account of concerned Aarthias/Farmers, as the case may be.
4. MSP will be paid in the account of Farmers/Aarthias, as the case may be, within three days of the I form approval by the DFSC. If the payment of MSP is to be made through Aarthias, concerned Aarthia will transfer the funds in the account of concerned farmer through RTGS/NEFT within three days of the receipt of payment in their account under intimation to concerned DFSC office.
5. Market Fee & Rural Development Fee will be paid in the account of concerned agency within seven days of the I form approval by the DFSC.
6. Other Incidental Charges will be paid in the account of Aarthias within ten days of the I form approval by the DFSC.
7. Dami will be paid in the account of Aarthias after 15 days of the closure of procurement season.
