**Subject:- Procurement of Bajra under price support scheme during Kharif 2015-Distribution of mandis amongst procurement agencies.**

Reference on the subject cited above.

1. It has been decided by the Government to procure upto 1.00 LMT of Bajra on MSP for distribution under Targetted Public Distribution System and other welfare Schemes. The Bajra will be distributed at the scale of 10 Kg. per ration card to all the beneficiaries during the Month of November, December, 2015 and January, 2016 and if any quantity still remains balance that may be distributed during the month of February. The Bajra will be procured strictly as per specifications of Government of India. The registration of the farmers will be done after survey and village wise list of farmers will be prepared who have sown the Bajra. All necessary instructions in this regard have been issued to all the Deputy Commissioners by the Additional Chief Secretary to Government Haryana, Revenue & Disaster Management Department. It has also been decided to obtain Revenue Record (FARD) in original from farmers at the time of procurement and no photocopy shall be accepted. It was also decided that only 50% of the production will be accepted. In case of joint holding, the share & land/production of the farmer will be calculated on the basis & his share in the holding. The procurement of bajra on MSP as per parameters/specifications laid down by the Government of India will be made in the following 23 mandis:-


