Annexure 'B'

Conditions of Distance Parameters for Brick Kiln licence:-

There is a provision in Clause 4(iii) of The Haryana Control of Bricks Supplies Order regarding distance parameters of Roads, Village Abadi, Municipal Limit, School, Hospital, other Educational Institutions and Public Utility Institutions, Garden, Nursery, Forest Nursery and Electricity Transmission line etc. The proposed site should fulfill the distance parameters mentioned in the Control Order.

(f) Village abadi	800 meters	Distance is to be measured as the crow flies from the nearest portion of the outer edge of Phirni and where there is no Phirni the distance is to be measured from the outer edge of the Abadi.
(g) School/Dispensary and Hospital (h) Other Educational and Public Utility Institutions (i) Public Park	One kilometer each.	Distance is to be measured as the crow flies from the nearest portion of the boundary line/ wall.
(j) Garden/Nursery/ Forest Nursery (k) Reserve Forest	East-West and North-South One kilometer each.	Distance is to be measured as the crow flies from the nearest boundary line, wall of the institution.
(l) Electricity Transmission Lines (not less than 220 kilowatt)	600 meter (on both sides from the transmission line)	Distance is to be measured as the crow flies from the nearest transmission line

Explanation.- 1. Garden- (A garden shall be considered as such only if it has an area of atleast one acre and having 35 fruit trees of the age of minimum one year and in support of this, entries should exist in the revenue records).

2. Nursery/Forest Nursery (A Nursery/Forest Nursery shall be considered as such only, if it has an area of one kanal where fruit or other plants are reared for sale or plantation).

Note:- All distances should be reckoned with reference to nearest outer edge of the vessel of the kiln on which side the specified distances are to be determined:

Technology of Brick Kiln: Brick Kiln Owner/Applicant must have to install Zig Zag technique or any other improved emission technique approved by State Pollution Control Board Haryana.

Annexure 'C'

Documents required for brick kiln licence:

1. documents of land/proposed site alongwith with revenue documents.
2. Mines and Geology Department:- Permit
3. Forest Department:- NOC reg. the site of brick kiln situated one kilometer away from reserve forest.
4. Electricity Board/office: Certificate reg. Electricity Transmission Lines (not less than 220KW)
5. Town and Country Planning Department:-(a) NOC required in case the site of brick kiln is situated out of controlled area.
(b) Licence of DTP required if the site is in the controlled area.
6. Excise and Taxation Department:- STR No.
7. Pollution Control Board:- Consent to establish and Consent of operate
