ORDER

Smt. Priyanaka, Peon at present working in the O/o Director General, Food Civil Supplies & Consumer Affairs Department Haryana, Chandigarh is hereby transferred and posted as such in the O/o District Food, Civil Supplies & Controller Gurugram against vacant post with immediate effect.

1. This is a case of cadre change from Directorate Office to Sub-Office.
2. The Seniority of Smt. Priyanaka, Peon will be fixed below all the Peon who are already working in Sub-Office Gurugram. However her pay will be protected accordingly as per Haryana Government Instructions.
3. It is made clear that her services will hence forth be governed under the Haryana Food & Supplies Department Sub-Offices Group-D Service Rules 1999 from the date of appointment by transfer in the above mentioned in Sub-Office Gurugram and accordingly she will be treated as Junior most in the cadre of Peon working in the Sub-Office.
4. It is further made clear that she will cease to have any right/claim in the seniority and lien and/or other benefits for the service rendered at Directorate Office.
5. It is also made clear that after the change of the cadre from Directorate Office to Sub-Offices she will be liable to serve in any part of Haryana or any State Govt. Offices beyond the State Territories & she will also accept their posting anywhere in State Govt. Office.
6. The other terms and conditions of their appointment will remain the same as already mentioned in the Appointment letter issued to them vide this Offices Memo No. 2E(1)-2019/1608-1612 dated 24.01.2019.
7. No TA/DA & joining time will be admissible to her as has been transferred on her own request.
8. She is directed to join her new place of posting immediately.
