**ORDER**

Whereas the Chief Secretary to Govt. of Haryana issued instructions/directions vide letter No. 22/10/2013-1GSIII, dated 17/19.04.2017 and amended from time to time vide which 3% posts for promotion for Group A, B, C & D shall be horizontally reserved for persons with disabilities on the total number of post in cadre strength w.e.f. date of PWD Act 1995 coming into force.

2. As per PWD Act, every appropriate Government shall appoint in every establishment such percentage of vacancies not less than three percent for persons or class of persons with disability of which one percent each shall be reserved for persons suffering from :-

- a) Blind and Low Vision
- b) Deaf and hard of hearing
- c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy in the posts identified for each disability;

3. Whereas 56 posts of Auditor are meant for promotion quota in the Sub Office Cadre out of which two posts of Auditors (Group-C) for promotions in sub-office cadre of this department shall be horizontally reserved for persons with disabilities as per the above provision of PWD Act. The Chief Secretary, Haryana vide Endst. No. 22/143/2019-1GS-III dated 18.11.2019 clarified that “दिव्यांगो को श्रेणी के आधार पर प्राथमिकता नहीं दी गई है उनको seniority के आधार पर पदोन्नति दी जायेगी”

4. Whereas as per seniority list of Clerks of Sub Offices Cadre, Sh. Sajjan Kumar S/o Sh. Bilasa Ram (Seniority no.63) Clerk O/o DFSC Bhiwani and Sh. Shishpal S/o Sh. Hawa Singh (Seniority no.90), Clerk O/o DFSC Ambala belong to PHC-Ortho. Sh. Avinash Sehgal (Seniority no. 119) belongs to handicapped category of Deaf and Hard of Hearing (HH). According to the provisions of Act and instructions both the posts cannot be filled up from only one category, hence, only one candidate from PH (Ortho) category and one candidate of Deaf and Hard of Hearing can be considered on the basis of seniority and fitness for promotion to the said post of Auditor under PWD quota.

5. Whereas at present none out of both the above candidates of PHC-Ortho fulfills the requisite conditions for promotion as per the Department Service Rules amended vide notification dated 08.11.2013 and instructions issued by the Haryana State Government vide Endst. No 42/164/2008-3GS-II dated 07.11.2013, dated 17.11.2018, dated 22.12.2020 and dated 30.03.2021 regarding State Eligibility Test in Computer

Applications (SETC), as they have not passed the said SETC Test. However, Sh. Avinash Sehgal, Clerk O/o DFSC Panipat belonging to handicapped category of Deaf and Hard of Hearing (HH) has passed SETC Test and fulfills all other conditions for the promotion to the post of Auditor under the said act and departmental service rules.

6. Accordingly, Sh. Avinash Sehgal S/o Sh. Kosh Raj, Clerk O/o DFSC Panipat belonging to handicapped category of Deaf and Hard of Hearing (HH) of sub offices seniority no. 119 is hereby promoted to the post of Auditor in the pay band of Rs. 9300-34800+3600 GP (FPL-6) with immediate effect under PWD quota.

7. It is certified that had he not been promoted to the post of Auditor he would have continued to officiate as Clerk.

8. He will be on probation for a period of one year and will be governed under the Haryana Food & Supplies Department Sub Offices (Group-C) Service Rules, 1982.

9. His promotion is subject to the condition that there will be no adverse remarks regarding integrity of the official in ACR for the year 2019-20.

10. The benefit of accelerated seniority will not be given to the above official.

11. Posting orders of the official will be issued separately.
