8. By exercising the power conferred under Section 6 (8) of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules, 2020, a criteria was finalized by the Selection Committee.
