By exercising the power conferred under Section 6 (8) of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules, 2020, a criteria was finalized by the Selection Committee. On the basis of said criteria, marks of Qualification (LLB, LLM and Doctorate) by considering divisions/grade obtained by all eligible candidates and the marks for Experience were given beyond seven years, which is minimum requirement for the post applied for and thereafter, on the basis of merit list, three times candidates the number of vacancies were called for interview as well as the candidates having same marks as that of the last candidate at cut off were also called for interview.
