Appointment to the post of Steno Typist (Both languages) in the Food, Civil Supplies & Consumer Affairs Department, Haryana (in Directorate Office).

- 2. On the recommendations of the Haryana Staff Selection Commission, Panchkula vide letter No. HSSC-Confd/Recomm./2021/596, dated 26.10.2021. you are hereby appointed to the post of **Steno Typist (Both languages)** on provisional/temporary basis in the Directorate of Food, Civil Supplies & Consumer Affairs Department, Haryana, in the pay band of Rs. 5200-20200-1900+100 Special Pay Grade Pay (pre-revised) {Now FPL-2 of Pay Matrix Table in the Haryana Civil Services (Revised Pay) Rules, 2016} plus usual allowances sanctioned by Haryana, Government from time-to-time on the following terms and conditions:-
 - I. This appointment is purely provisional/temporary and you will remain on probation for a period of two years which can be extended after taking into consideration your work and conduct to a total period not exceeding three years. Your services are liable to be terminated without notice on the abolition of the post or on the termination of vacancy or leave arrangement or any other arrangement against which you happened to be working at that time.
 - If at any stage you desire to resign from your post in the Food Civil Supplies & Consumer Affairs Department, you will be required to give one month's clear notice or forfeit, in lieu thereof, on month salary including allowances or for the period by which the notice falls short of one month. Such a notice will be given to you by the department also in case it is proposed to terminate your service for the reasons other than that mentioned in Para-1 above. In case of misconduct or misbehavior, however, you will be given a reasonable opportunity to show cause as to why your services be not terminated, in that case the condition of one month's notice/salary will not apply.
 - As your character and antecedents have not been verified. Therefore, it is made clear to you that in case subsequently any adverse facts come to the notice of the State Government regarding your character and antecedents your services are liable to be terminated.
 - As the authenticity of your academic qualifications, caste and category certificates has also not been verified/checked from the issuing authority, therefore, it is made clear to you that if at any subsequent period, the same are found to be fake/false, your services are liable to be terminated and legal action will also be taken against you in this regard.
 - Your services will be governed by the provisions contained in the Haryana Civil Services(General) Rules, 2016 and the Haryana Food, Civil Supplies & Consumer Affairs Department Directorate(Group-C) Services Rules, 1982 as may be amended from time to time and also the Government instructions issued in this regard.
 - Further, it is made clear that your services will be governed under the Finance Department Notification dated 28.10.2005 & provision 2(ii) of Punjab Civil Services Rules, Vol-I, Part-I amendment Rules, 2006. Your services will be

 - You are liable to serve in any place whether within or outside the State of X. Haryana or in the office central or other State Government or a company, an Association or a body of individuals whether incorporated or not Municipal Corporation or local authority or an international organization, an autonomous body not controlled by the Government or a private body.
 - You will have to give an undertaking in writing that if and when you enter any xi. marital alliance, you shall strictly comply with any anti dowry law in letter and spirit and also furnish full details of all the articles of property and amount of money received by you from your in-laws in any name or manner, whatsoever. The undertaking shall be signed by your wife, father & father in law.
- XII. Your seniority will be fixed as per rules/instructions.
- XIII You shall have to furnish a Medical certificate of fitness from the Medical Superintendent, Government Multi Speciality Hospital, Sector-16, Chandigarh before joining to the above post within a week as required under Rule 9 of HCS (General) Rules 2016, in case you are found medically unfit then your services will be terminated without giving any notice.
- Before assuming the charge of duties, you will be required to take the XIV. prescribed oath of allegiance to the Constitution of India and to produce the following certificates to the Director General of Food, Civil Supplies & Consumer Affairs, Department, Haryana, Chandigarh:-
 - When reporting for duty, you should bring with your academic qualifications, caste and category certificates in original along with two sets of attested Photostat Copies.
 - Declaration of your having one spouse and in the event of your having more than one spouse living, the appointment will be subject to your being exempted from enforcement of the requirement of rules in this behalf.

If you are willing to accept this offer of appointment on the terms and conditions mentioned above, you should report yourself for duty to the Directoate Food, Civil Supplies & Consumer Affairs Department, Haryana, Headquarter, Chandigarh within 30 days from the receipt of this offer failing which this offer will be treated as cancelled.
