Applications are invited for filling up one post of Member in State Consumer Disputes Redressal Commission, Haryana, at Panchkula.

- Persons of ability, integrity and standing and having adequate knowledge and experience of at least ten years in dealing with problems relating to economics, law, commerce, accountancy, industry, public affairs or administration, not less than thirty five years of age as on 01.06.2019 and possessing a bachelor's degree from a recognized University who are not otherwise disqualified as per provisions contained in Consumer Protection Act, 1986, Haryana Consumer Protection Rules, 2004 are eligible to apply. Only those candidates would be eligible who have not been dismissed from service of the Government or a body corporate owned or controlled by Government, any practicing Advocate at District level or at the State level who has not been debarred to practice at the District level or at the State level by the appropriate authority or if any Judicial Officer who has not been retired compulsorily before attaining the age of superannuation by the concerned High Court. In case applications of candidates are substantially more than the number of post for the purpose of calling applicants for interview, Selection Committee may adopt any suitable criteria for the purpose of selection.
- 3. The candidate selected for appointment as Member in State Consumer Disputes Redressal Commission, Haryana, Panchkula shall hold office for a term of five years or upto the age of 67 years, whichever is earlier.
- 4. He/she shall be entitled to consolidated honorarium of Rs.60,000/-per month alongwith facilities of Government accommodation, if available or rent as per Government Rules, Rs.1000/- per month for using mobile phone or landline phone, Rs.1000/- as conveyance allowance and medical allowance as per rules. He/she shall be eligible to such travelling allowance and daily allowance on official tour as are admissible to Grade I Officers of the State Govt.
- 5. It is made clear that the candidates who would not enclose the documents alongwith their applications, their documents will not be considered later on.
- 6. Only those candidates will be called for interview whose applications are found, complete in all respect, supported by requisite attested copies of documents relating to different columns of application format including the proof of income. Any application found incomplete in this regard, would be rejected in scrutiny.

- 7. The candidates shall despatch their application in such a manner that her application, complete in all respects reaches in the office of Secretary, State Consumer Disputes Redressal Commission, Haryana, Bay No.3-6, Sector 4, Panchkula-134112 on or before the last date of receipt of applications, that is, 8th July, 2019 upto 5.00 P.M.
