Applications are invited for filling up 8 posts of Members (1 for women and 7 for male) in District Consumer Disputes Redressal Fora in the State of Haryana.

- 2. Persons of ability, integrity and standing and have adequate knowledge and experience of, at least ten years in dealing with, problems relating to economics, law, commerce, accountancy, industry, public affairs or administration, be not less than thirty five years of age as on 01.06.2019 and possess a bachelor's degree from a recognized University, who are not otherwise disqualified as per provisions contained in Consumer Protection Act,1986 and Haryana Consumer Protection Rules, 2004 are eligible to apply. Only those candidates will be eligible who have not been dismissed from service of the government or a body corporate owned or controlled by the Government, any practising advocate at District Level or the State Level who has not been debarred to practise at the District level or at the State level by the appropriate authority or if any Judicial Officer who has not been retired compulsorily before attaining the age of superannuation by the concerned High Court. In case applications of candidates are substantially more than the number of posts for the purpose of calling applicants for interview, Selection Committee may adopt any suitable criteria for the purpose of selection.
- 3. As per proviso to sub-section (2) of Section 10 of Consumer Protection Act, 1986, a person who has already availed two terms as Member of the District Fora, he/she shall not be eligible for third term as Member of District Fora as has been held in CWP No.16400 of 2012 titled as Raj Bala and another Vs. State of Haryana and others decided on 28.09.2012 by the Hon'ble Punjab and Haryana High Court, Chandigarh.
- 4. The candidates selected for appointment as members of the District Fora shall hold office for a term of five years or upto the age of 65 years, whichever is earlier.
- 5. The selected candidates shall be liable to be posted anywhere in the State of Haryana
- 6. He/she will receive a consolidated honorarium of Rs.40,000/- per month. He will be entitled to such travelling allowance and daily allowance on official tour as are admissible to Grade-II Officers of the State Govt.
- 7. It is made clear that the candidates who do not enclose the documents alongwith their applications, their documents will not be considered later on.
- 8. Only those candidates will be called for interview whose applications are found, complete in all respects, supported by requisite attested copies of documents relating to different columns of application format including the proof of income. Any application found incomplete in this regard, would be rejected in scrutiny.
- 9. The candidate shall despatch his application in such a manner that his application, complete in all respects, reaches in the office of Secretary, State Consumer Disputes Redressal Commission, Haryana, Bay No.3-6, Sector 4, Panchkula-134112 on or before the last date of receipt of applications, that is, 8th July, 2019 upto 5.00 P.M. Application received thereafter due to postal delay or for any other reason, will be rejected and disentitle the candidate for any call of interview
